This License sets forth the terms pursuant to which, in consideration of payment or other consideration provided to the undersigned by MJH Life Sciences or any of its affiliated entities (collectively, "MJH"), the undersigned agrees to submit articles, photographs, graphic material, illustrations, and/or any other material (the "Material") in any media to MJH for the purposes described below.

- 1. I hereby grant MJH: (a) the exclusive right to first publish the Material in its print and electronic publications and (b) a non-exclusive worldwide perpetual license to edit, use, reuse, republish, reproduce, translate, or otherwise distribute or disseminate the Material in any form or media (including digital electronic form and via the internet), whether now known or hereafter devised (hereinafter, "Reuse" or "Reusing"); provided, however, that with respect to that portion of the Material that consists of photographs, images, illustrations and/or other graphic material ("Graphic Material"), the foregoing license shall be limited as follows: (x) with respect to Graphic Material other than Graphic Material featured as cover art in MJH's print publications ("Cover Art"), MJH's non-exclusive license shall be limited to Reusing such Graphic Material in conjunction with the editorial content, if any, with which such Graphic Material was first published by MJH; and (y) with respect to Graphic Material used as Cover Art, MJH's non-exclusive license shall be limited to reusing such Graphic Material in a manner which features a substantial portion of the material cover element(s) (for example, the publication title) originally published by MJH in conjunction with such Graphic Material.
2. Additionally, in consideration of my continuing relation with MJH, I hereby expressly waive any rights regarding and grant to MJH a non-exclusive worldwide perpetual license to Reuse all of the Material that I have submitted to MJH or its assignors since January 1, 2010, if any, subject to the same limitations regarding the Reuse of Graphic Material that are described in Section 1 above.
3. Subject to the limitations regarding the Reuse of Graphic Material that are described in Section 1 above, the foregoing licenses include the right to create derivative or compilation works based upon the material and to combine the Material with other content selected by MJH.
4. I represent to MJH that (a) the Material will be original; (b) I will hold the copyright interest in and to the Material; (c) I retain the right to sell or license to third parties any of the original unedited material submitted; and (d) the Material will not violate or infringe any copyrights or other proprietary rights of others.
5. MJH will have the right to transfer or sublicense any of the foregoing license rights to any entity.
6. This License sets forth the complete understanding and agreement between MJH and me, supersedes all prior agreements and understandings, and may not be amended or modified except in a writing signed by both of us. The laws of the State of New Jersey shall govern the construction and interpretation of this License without reference to the conflicts of laws principles of such jurisdiction.
