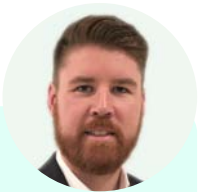

How it works

1. Partner agreement

You sign our partnership agreement and provide us with your bank details in order to receive your affiliate revenue.

2. Make a referral

You refer you clients to us informing your account manager of the referral by email. You will also receive a unique trackable link that will ensure all direct signups are tracked back to you.

3. Client contact

We will confirm receipt of your referrals and contact the clients using the details you have provided. We make our introductions, and take time to understand the clients' requirements, but there is no hard sell.

4. Status update

We keep you updated on the status of the referrals and whether they have progressed though the signup phase to open accounts with us.

5. Client trade

The clients make currency transfers with Clear Currency.

6. Statement & revenue

You receive a regular revenue statement and payment based upon the transactions undertaken by your referrals.

Your clients' experience

1. Initial contact

After your referral we will contact the client by phone or email, as to their preference. We take time to understand your clients' requirements and discuss our services with them.

2. Sign up

The clients sign up via a simple form on our website. Their details are checked and, if no further documentation is required, they are ready to make a transfer within minutes.

3. Welcome

The clients will receive a welcome email and log on instructions to our payments platform. They can choose to either trade online via the platform or over the phone with their dedicated account manager.

4. Quote & Transfer

The clients give the details of the currency they wish to transfer and receive a quote. Once the quoted rate is agreed the transfer is arranged and we supply the details for the clients to fund the transfer. Our banking counterparty is Barclays.

5. Payment

When the clients' funds are received we make a payment to their specified beneficiary. We offer same-day settlements where possible.

6. Confirmation & Review

The clients will receive confirmation and may be asked to review their experience. Should they need any further assistance their account manager will be on hand or they can use our online platform to manage their account.

Security

FCA regulated, fair and honest

We are authorised and regulated by the Financial Conduct Authority (FCA) to provide money transfer services (firm number 708529). Find out more about our regulatory permissions on the FCA website. We are also partnered with a number of trading counterparties from A-rated banks to listed prime brokers.
