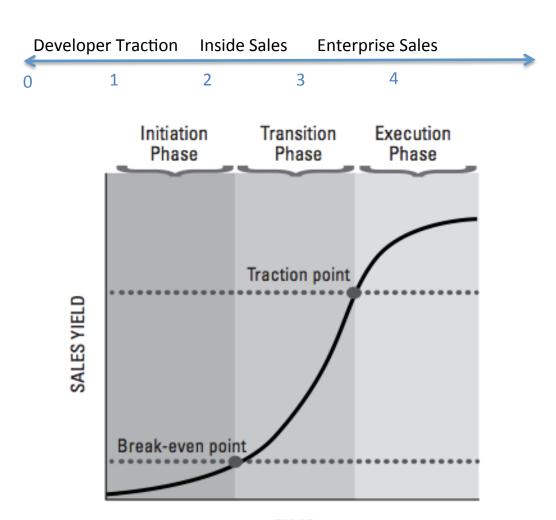

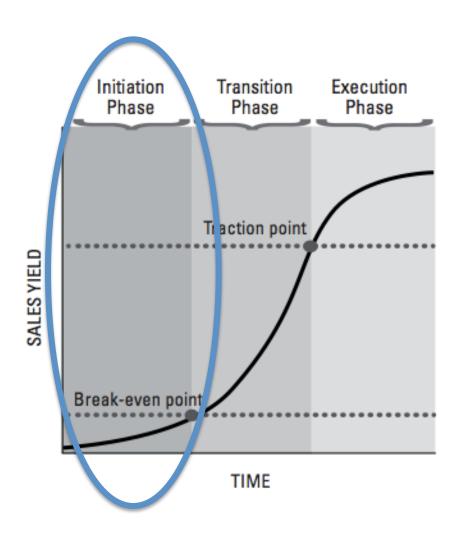

# Your Working Model



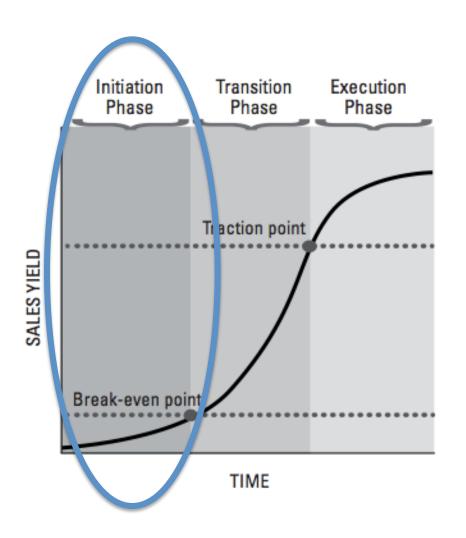




#### **Athletic Generalists:**

- Not coin-operated
- Flexible: can talk to anyone
- Broad: equally comfortable with prod/mktg/sales
- Business builders / learners
- Equity-driven
- Goal is to work themselves out of job

**Example**: generalists who may come from product, BD, marketing

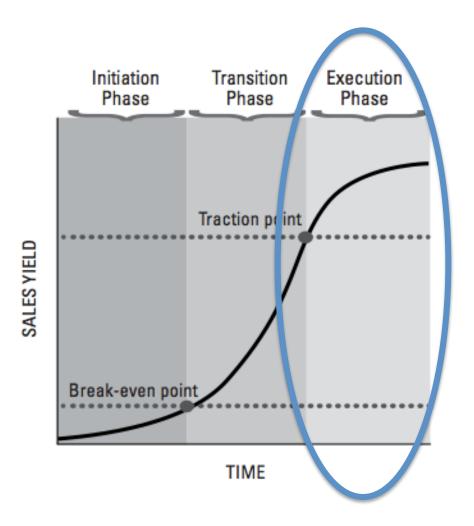


#### What Not to Do:

- Hire traditional sales managers, reps, or big company execs.
- Let the rep do everything.

#### **Success:**

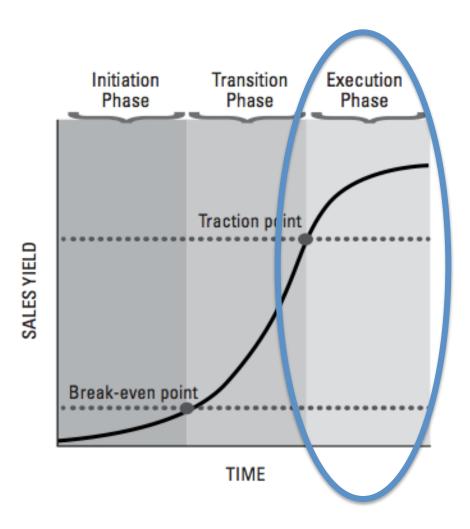
- Rep pays for themselves
- Handful of good deals
- Beginnings of a model



#### **Enterprise Sales Pros:**

- Highly coin-operated
- Lots of structure
- Strategic
- Process-driven
- Repeatability = easy scale
- Require specialists / support
- Cash-comp

**Example**: reps who worked at larger companies in similar categories.

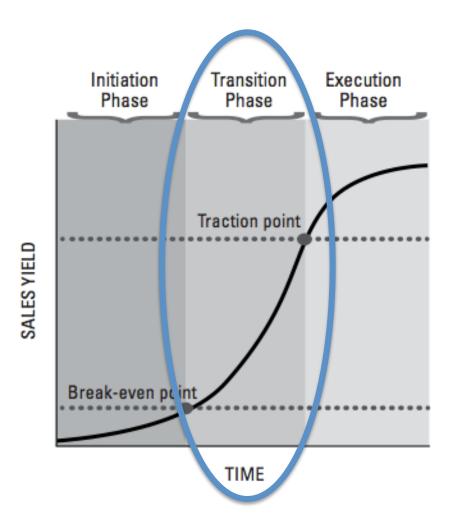


#### What Not to Do:

- Hire entrepreneurial types
- Skimp on sales enablement
- Extrapolate the success of a few to lots of new hires

#### **Success:**

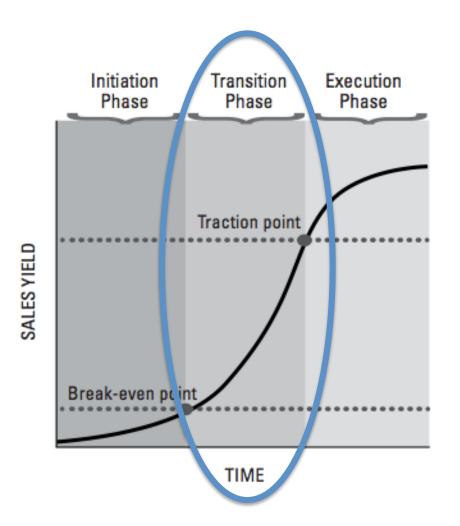
 Each new hire follows a consistent success pattern



#### **Enlightened Reps**

- Can build out infrastructure
- Strategic yet athletic
- Look for repeatability
- Don't need lots of support
- Cash and equity-driven
- Have "seen the movie" before

**Example**: Directors of sales from a company that went through a similar growth path.



#### What Not to Do:

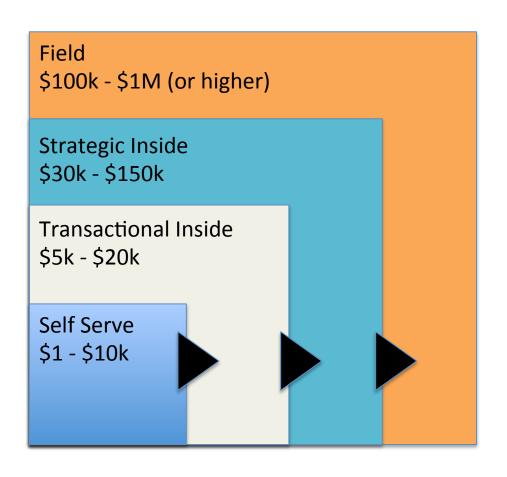
- Think it's all figured out and hire "execution phase" reps
- Put in too much structure
- Hire a sales leader who can't "find the vein"

#### **Success:**

- Twice their cost
- Repeatability

**Note**: Best rep for me was early inside rep.

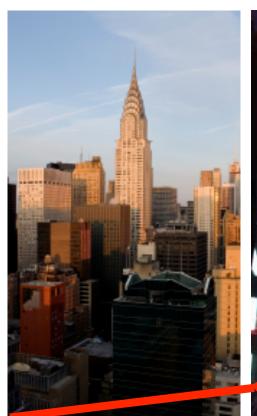

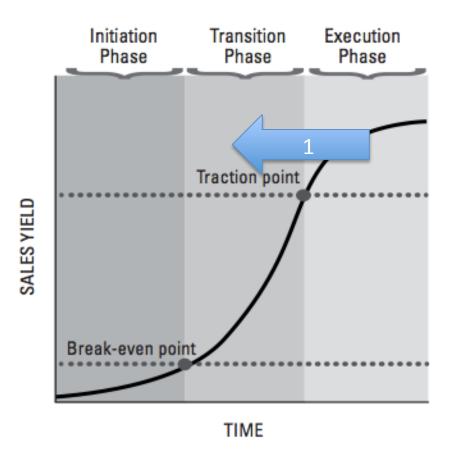

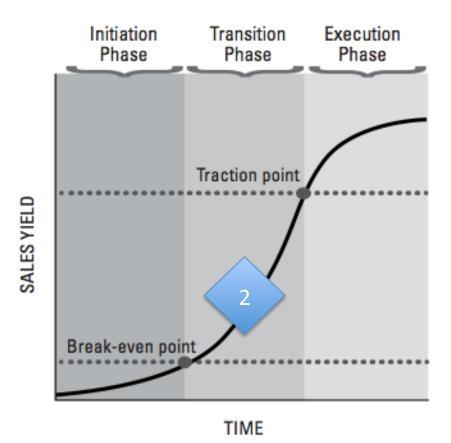

### Three Big Screw Ups



- Hired "execution stage" reps way too early
- 2. Didn't have network for hires
- 3. Hired ahead of results (2008)

#### Three Successes



- 1. Rebuilt amazing team (from similar stage co.)
- 2. Used wanna-be VP's early on
- Orchestrated transactional > inside > field model

### Recap

- Use Sales Learning Curve as model for hiring:
  - Get athletic, generalist business builders first.
  - Then reps who have a mixture of skills.
  - Then coin-operated reps when it's proven
- My tips:
  - Be patient on repeatability.
  - Tap into a solid network if possible.
  - Use career advancement to get great reps early.
