About this report

This statement of non-financial information (hereinafter, NFIS) has been prepared in keeping with the requirements of Law 11/2018 of 28 December 2018 on non-financial information and diversity reporting passed by Congress on 13 December 2018 which amended the Commerce Code, the recast text of the Capital Companies Act approved by Legislative Royal Decree 1/2010 of 2 July, and Law 22/2015 of 20 July, Audits for non-financial information and diversity reporting (from Royal Decree-Law 18/2017 of 24 November).

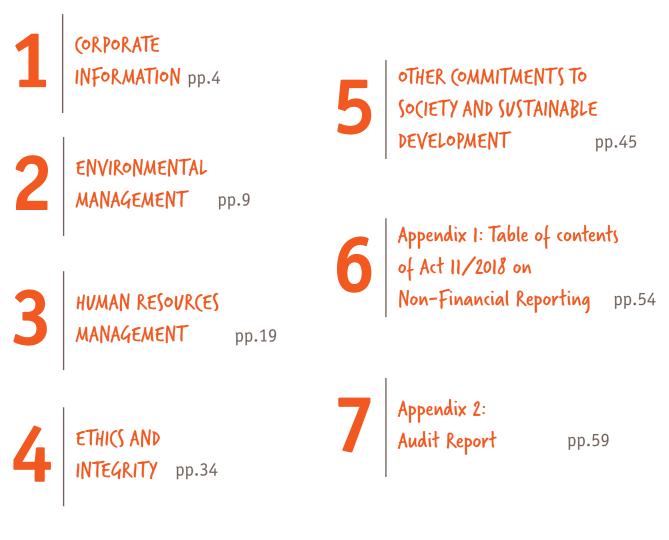
The provisions of the Global Reporting Initiative's Standards have been adhered to in drafting this report. The requirements of Law 11/2018, the GRI indicators and the corresponding section of the NFIS, are detailed in the Annex titled "Table of Contents of Law 11/2018 on Non-Financial Reporting".

Affinity Petcare's EINF focuses on environmental, social, labour, human rights, and its commitment to fight against corruption and bribery that are relevant to the company's business operations.

In order to facilitate an understanding of our business model and the markets where we operate, the first section of the NFIS on corporate information describes the pet food business of the Agrolimen Group. In addition to Affinity Petcare, the Agrolimen Group also comprises the subgroups Natures Menu and Nature's Variety.

In the sections that follow after the Corporate Information NFIS, for each issue addressed in the law we have indicated how relevant they are for the companies specifically controlled by the Affinity Petcare subgroup, the policies and risks related to each one and the key performance indicators used to monitor and evaluate them.

Corporate Information Business model

Our company is much more than an expert in animal nutrition. We are an animal-loving company fully committed to the welfare of pets and the people who care for them.

We love dogs and cats; they are our passion and the reason for everything we do. We strive to accompany pet owners and to improve the relationship with their pets, strengthening the bond between them and helping to improve the physical and emotional health of their pets. An example of our commitment and philosophy is our Foundation, a non-profit organisation which is the only corporate foundation in Spain dedicated to promoting this bond between people, dogs and cats.

The Affinity Foundation has been working for animals and people for more than 30 years in three areas: research, awareness and social action. Three areas of action with a single objective: to disseminate the philosophy that a society that respects animals is a better society.





Leaders in dog and cat food

Affinity is a company with **more than 40 years of experience** in the production of quality animal nutrition and is part of the PetFood business of the Agrolimen Group¹. The Group is a leader in the dog and cat food industry in Spain, fifth in Europe and sixth in the world.

We know how important nutrition is to pet health. Through our brands, we have developed an extensive range of products using **select ingredients of the highest quality and nutritional value** that contribute to pet development and quality of life.

A balance between research, technology, specialised professionals and a careful selection of ingredients allows our products to satisfy the nutritional needs of dogs and cats, from the most generic to the most specific. More than 40 years committed to the welfare of dogs and cats??

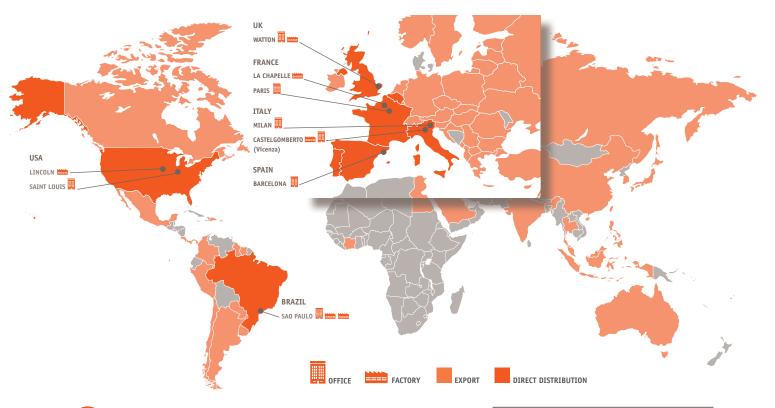
Market and customer-oriented organization

More than 1,800 professionals work in the pet food division of the Agrolimen Group at our headquarters in Barcelona (Hospitalet de Llobregat) and other locations around the world.

We also have 7 production centres to supply the more than 70 countries where we do business.

Of the seven abovementioned production centres, the ones in Spain, Italy and France belong to the Affinity Petcare subgroup; Nature's Variety has a production centre in the US; Natures Menu in the UK and the Brazil centre is a joint venture (50%) of Affinity Petcare.

With regard to the companies controlled by the Affinity Petcare subgroup, there are two business divisions, one focused on mass market and the other on specialised distribution, each one supported by corporate areas, which allow us to innovate and respond better and faster to the needs of our buyers, our customers and their pets. ⁶⁶ Present in more than 70 countries??

1.2. Market environment

It is estimated² that the turnover in the worldwide dog and cat food industry was 75.1 billion euros in 2018, with annual growth of 3.8%, Agrolimen being the sixth largest group in the world.

In Western Europe, the main geographical area where Affinity operates and which represents 24% of global turnover for the sector, with growth of 0.2%, Affinity is the fourth largest company.

Affinity produces mainly dry feed, which represents 42% of the European market. In this

technology Affinity is the third largest European manufacturer and our share is growing year after year.

Europeans are increasingly prone to pet ownership, with 23% of households owning at least one cat in 2018, and 21% owning a dog. The value of the pet food category has evolved positively thanks to both population growth and the growth of quality products adapted to the specific needs of pets.

1.4. Risk management

The Group's risk management policy is in line with best practices in the market, whose goal is to ensure that risk events that could affect it in attaining its strategic objectives are properly identified, assessed and managed. The resulting risk map is regularly reviewed and monitored by both the Management Board and the Audit Committee.

Risk management is an ongoing process and takes all business activities into consideration, including non-financial ones. To assess them, the potential impact and the likelihood of an event actually occurring is considered. The controls and mitigation plans in place are also identified.

Insofar as the risks subject to this report are concerned, it must be highlighted that the operations of the Affinity sub-group are basically conducted in Europe, where there is a regulatory framework to ensure that they are compliant, which means that the matters dealt with in this report are subject to a high level of compliance and supervision of our operations, as well as those of our suppliers and other stakeholders.

Environmental Management Management approach

Affinity is committed to environmental sustainability as embodied in our Environmental Policy, which is based on:

- Compliance with all legal and regulatory requirements applicable to our operations, as well as sector-specific codes and best practices to which we subscribe.
- Preventing and minimising the environmental impacts that we generate.
- The environmental management system we have implemented ensures correct environmental practices:
 - Diagnosing significant environmental aspects, minimising the consumption of resources and reducing or eliminating the environmental impact derived from our business and its effect on the environment in terms of emissions, discharges and waste generation.
 - Establishing environmental management objectives and goals that allow for continuous improvements that benefit our customers, consumers, shareholders, suppliers, staff and subcontracted personnel, the community and the natural environment.
 - Periodically reviewing the effectiveness of the implemented systems and the stated goals and objectives.
- Affinity is committed to proper environmental management, always taking the entire life cycle of the product into account, from the origin of raw materials to the consumption of the finished product.
- The responsibility for preserving the environment rests with all members of the organisation, regardless of position.
- The Environmental Policy is available to anyone who wishes to see it as part of Affinity's Quality, Safety and Environment policy.







The Affinity subgroup controls three production plants located in Spain, France and Italy. Each plant has an Environmental Management System in place (in Spain, it is ISO 14001 certified). It is developed, reviewed and updated as part of a systematic approach to environmental management that provides management with the information needed to generate long-term success and create options that contribute to sustainable development.

In order to determine the current and future effects of our operations on the environment, we have defined the stages in the life cycle of each product and each year we prepare an inventory of all the activities and processes that affect environmental aspects. Consideration is given to inputs (raw materials, resources, power, services), outputs (semi-finished and finished products, air emissions, discharges, spills and waste), legal requirements and working conditions (normal, abnormal, emergency).

Once the environmental aspects have been identified, they are valued according to the defined evaluation criteria, classifying them and determining which of them are significant.

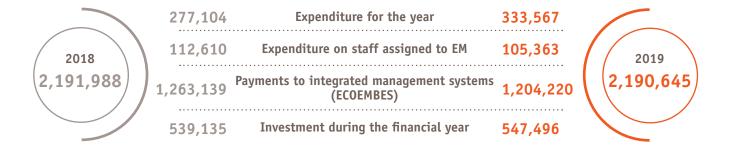

2.2. Sustainable use of resources Energy consumption

The types of energy consumed by Affinity include electricity and natural gas.

Our direct energy consumption is shown below, in which it can be observed that there was a slight increase in comparison with consumption in 2018, which can be explained by the increase in tons produced in 2019. ⁴⁴We prioritize renewable sources **?**?

Affinity is working to reduce the environmental impact of its operations. Therefore, all of the electricity consumed in 2019 in our production plants in Italy and Spain came from renewable sources, which resulted in a reduction of 2,800 tons of CO_2 emissions in comparison with the previous year.

There is an internal energy-efficiency management programme in place with a system that measures

usage, as well as continuous improvement plans and periodic energy audits. The investment in projects devoted to improving energy efficiency in 2019 was 247,187 euros. In addition, a new manufacturing line was commissioned in 2017 (full occupancy in 2019) equipped with the best available technology in terms of energy efficiency. This line has resulted in energy savings of 2,874,745 kWh per year of electricity and 3,028,933 kWh per year of natural gas.



Consumption of ingredients and materials

The quality of our ingredients is a basic pillar of our commitment to the pet welfare. We select top quality ingredients with high nutritional value that contribute to the development and quality of life of dogs and cats. Packaging materials likewise play an essential role in properly conserving the products made, as well as ensuring their preservation throughout their useful life.

The ingredients and packaging materials consumed in 2019 were as follows:

Consumption of raw materials (tons)



Affinity mainly uses both plant-based ingredients (cereals, cereal products, fruit and vegetables) and meat ingredients (fresh, frozen and dehydrated). In our factories, the ingredient transport and dosing systems are mostly automatic. The efficiency and precision of these systems minimises waste generation. In addition, the internal policies for standardising and using these ingredients are based on their environmental impact as a further factor to be taken into account whenever they are introduced to the production line. Currently, 62% of the packaging materials used for the products manufactured by Affinity, basically made of plastic and cardboard, can be recycled. Together with its main packaging suppliers in Europe, Affinity is developing recyclable plastics able to conserve our products during their useful life, with the ultimate objective that 100% of the packaging materials used by Affinity can be recycled by 2025.

Water usage and wastewater discharge

The water used by Affinity in its production processes comes mostly from wells authorised by the competent authorities in each country.

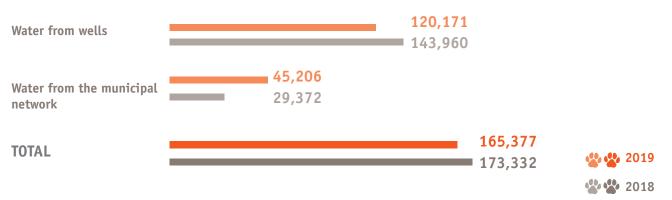
Most of the water we consume (90 to 93%) is used to cook food. During the production process it evaporates completely and is returned to the atmosphere.

The rest of the water is used to clean the facilities and is subsequently treated in treatment plants located at each factory. All water heating and cooling circuits are closed circuits which do not generate any consumption.

Affinity's three production plants have their own wastewater treatment plants. In 2019, 236,930 euros was invested in improving these facilities, of which the biggest investment was made in the plant in France, where these facilities were totally refurbished. In 2019, 236,930 Euros was invested in improving the wastewater treatment system??

Direct water consumption (m³)

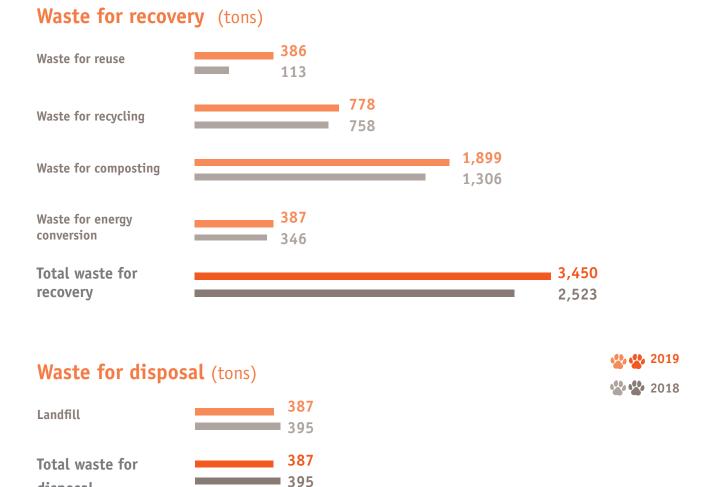






2.3. (ircular economy, and waste prevention and management

Affinity's policy is to minimise the waste generated and to use the waste for recovery rather than disposal.



Furthermore, finished products in stock that are not fresh enough for delivery to the distribution channel but are completely safe for consumption are not discarded as waste. Much of it is sent to pet shelters near the production plants (see section 5.1).

2.4. Pollution Climate change and greenhouse gas emissions

Greenhouse effect gases (GHG) are produced as a result of Affinity's operations. This includes the GHGs produced by us internally, by our suppliers and customers, and those related to the use of their products.

An annual calculation is made of scope 1 direct GHG emissions (direct emissions from the activities that the organisation controls) and scope 2 indirect GHG emissions (those generated by power stations as a result of the electricity consumed by Affinity). In the case of scope 2 GHG emissions, it should be highlighted that all of the electricity consumed in 2019 in the production plants in Spain and Italy (which together account for 77% of the electricity consumed in Affinity's production facilities) came from renewable sources that did not generate any GHGs whatsoever, which resulted in a reduction of 9% of CO2 emissions in comparison with the previous year, whilst the emissions in the plant in France were calculated based on the energy generation mix used there.

The results for Scope 1 and Scope 2 GHG emissions are shown on the table below.

In terms of greenhouse gases emissions due to Affinity's operations it is not considered that they seriously affect the environment and, therefore, none of the plants is subject to the emission rights protocol. Emission points are inspected every three years by the competent authority and comply with the established requirements.

There are also various points at the plants where particles are released into the atmosphere. All emission points have filters and are electronically monitored to prevent accidental emissions. They are also inspected every two years by the competent authority and comply with the established requirements.

With regard to GHG emissions, Affinity has undertaken to reduce emissions in the future resulting from its operations. One of the ways of doing so will be to ensure that at least 60% of the energy it uses in its factories comes from renewable energy sources. Another measure will be to make all of its packaging from materials that can be recycled. It is currently actively engaged in making this objective a reality by 2025.

Air pollution, noise pollution and light pollution

Insofar as noise pollution is concerned, Affinity's factories emit noise both at certain emission points and in the form of dispersed emissions. All sources of noise pollution have silencers or anti-noise panels to minimise the emissions. There is also a verification protocol that has been agreed with the local authorities (location of the measurement points) and inspected by the competent authorities as part of the Integrated Environmental Inspection.

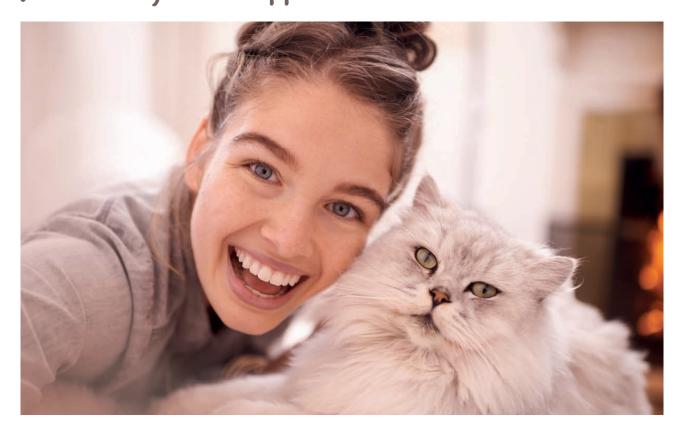
In 2019, 39,136 euros was invested in actions to control and filter the emission of dust and odours resulting from its operations.

2.5. Protection of biodiversity

Affinity's activities and products do not have significant impacts on biodiversity.



Human resources management I. Management approach



The strategic plan of the Human Resources department, approved in 2019, is intended to support teams in attaining the targets set in the Corporate Strategic Plan approved for 2018–2022.

Some of the challenges we face in the area of HR management are:

- Attracting and retaining top level members of staff able to build up solid teams committed to the growth targets set in the strategic plan.
- Strengthening an international culture common to all of the places in which we operate that enables us to better respond to

the requirements of our customers in all of our markets.

Encouraging the training of staff to bring about digital transformation in all of the company's departments.

Equal opportunities and non-discrimination are basic principles of the Affinity corporate culture. Our companies comply with national regulations on integration and access to employment. All Affinity locations comply with the applicable accessibility regulations in each one of the geographical locations where we do business.

Affinity has a total of eight employees with disabilities. In Spain we also work with socially responsible companies that guarantee the employment of functionally diverse people. Specifically, in Spain we work alongside the Àuria Group to keep our nutrition centre up and running, and with Fundació Privada Mas Albornà at our factory in Monjos on the placement of adhesive labels and filling rigid containers, while Fundació Privada Santa Teresa del Vendrell works with us on the placement of adhesive labels and packing small bags. 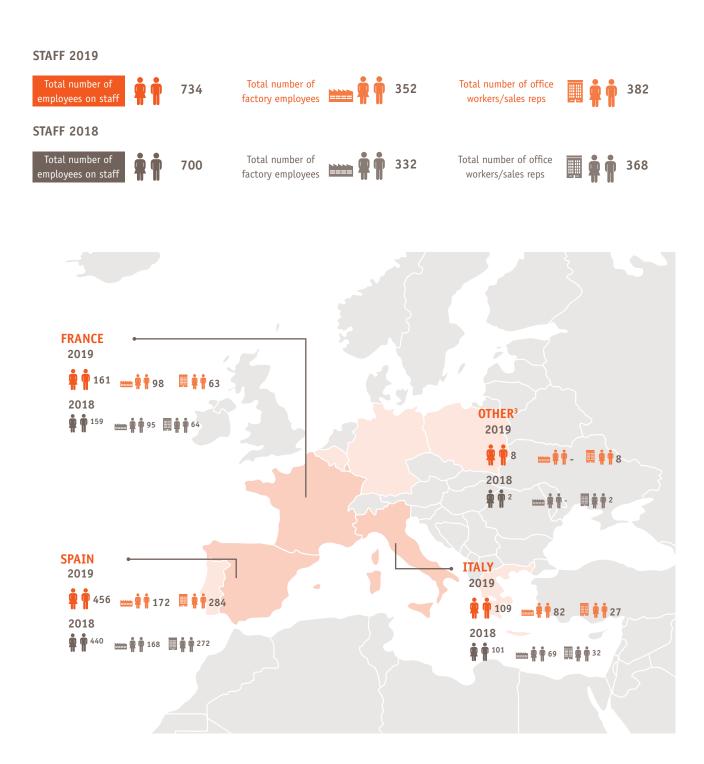
3.2. Our staff About our staff

At the 2019 year-end, Affinity had a workforce of 734, of whom 59% were men (435) and 41% were women (299). Our main offices are located in Barcelona, Paris and Milan. We also have production centres in all three countries. In addition, some of our employees are based in Belgium, Germany, Greece, Poland and Portugal.





Due to the occupational segregation affecting the industrial sector, there is still a predominance of men at our factories, while the percentage of women working in our offices is 55% of the total.

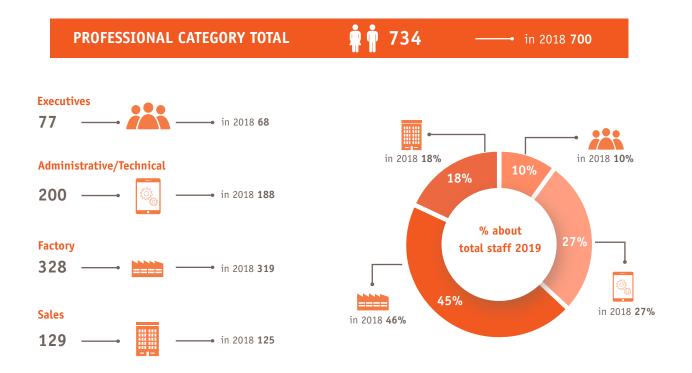

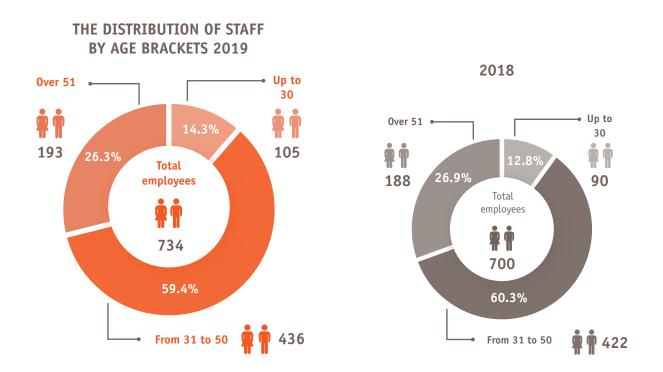

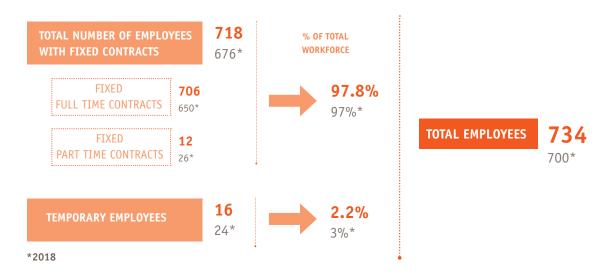
In 2019, the number of employees under the age of 30 increased by more than 19% and the total number of employees over the age of 60 years who had reached retirement decreased.





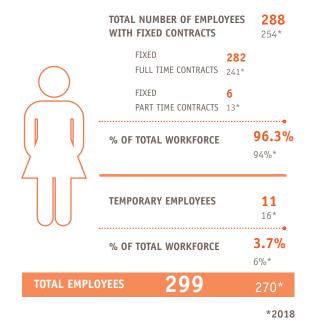

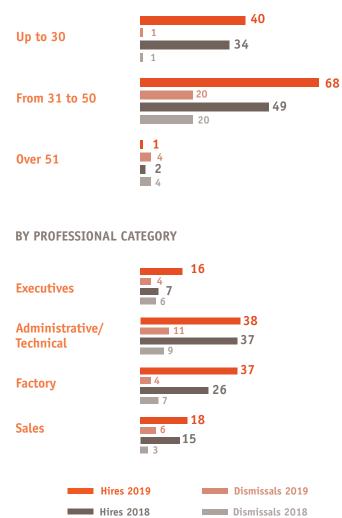

Implementation of workstation disconnection policies

In those countries where this is regulated, Affinity complies with the regulations. In places where it is not regulated, it is common practice to favour disconnection. Workstations are set up in such a way that at the end of the workday it is neither necessary nor required to remain connected to the devices provided to employees by the company. Meetings are not scheduled outside of working hours.

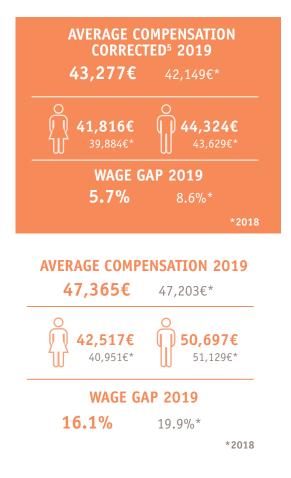
3.3. (ompensation⁴ and salary gap

As specified in our Code of Conduct, Affinity does not allow discriminatory behaviour of any kind. In keeping with this principle, Affinity employees are paid for their work according to their professional category and work performed.

Affinity's compensation model is linked to performance and the evolution of salaries on the market, in such a way that during the annual performance review process the highest increases are assigned to the employees with the best performance and/or whose compensation lags farthest behind the market reference.

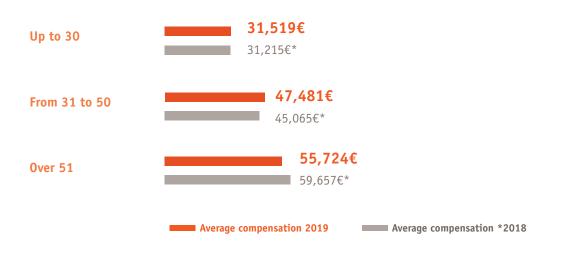
An analysis of the average compensation in 2019 in comparison with the previous year shows the results of the measurements used. Over one year, the general wage gap in the company was reduced by 3.8 points, which is an improvement of almost 20%. It should be noted that if we exclude the top level of management and the group with the most seniority, the wage gap would decrease from 16.1% to 5.7%.



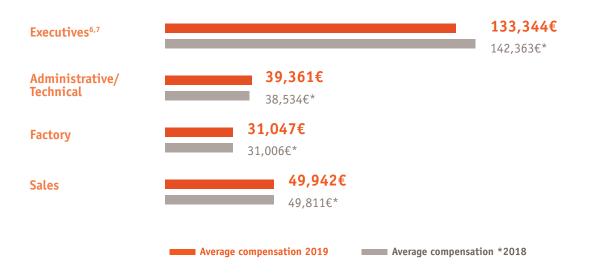

3.4. Organisation of work and flexibility policies Organisation of working hours

Working hours are organised differently at each production centre. At the industrial centres in Els Monjos (Spain) and Castelgomberto (Italy), there are three shifts (morning, afternoon and evening), with 24hour operations from Monday to Friday. In France, however, there are four shifts with the plant operating continuously from Sunday to Friday.

Office staff work a split shift, ensuring in all cases that the total working hours adhere to the labour laws in each country.

Description of measures aimed at facilitating work/life balance and fostering the jointly responsible exercise thereof by both parents

Affinity has implemented a number of measures to facilitate a work-like balance for its employees.

Office employees enjoy limited flexibility that allows them to adjust their starting and finishing times based on their personal needs and the company's needs.

For workers at the Barcelona and Milan offices, a gymnasium service is available either through an on-site gym or subsidised access to a local gym.

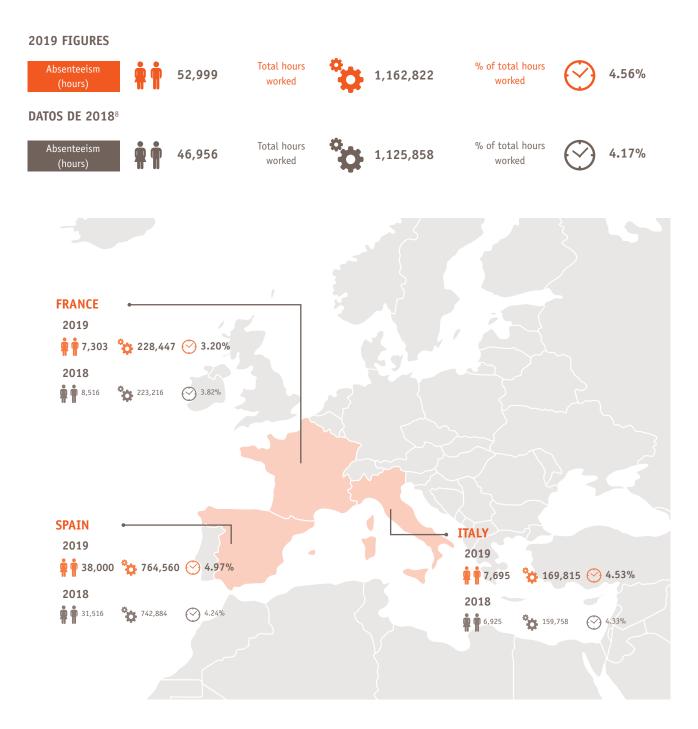
Along these same lines, a fully financed canteen and breakfast service is available at the central offices. At other locations, food is totally or partially subsidised through on-site canteens or restaurant vouchers.

Through these measures, the company reduces travel times while promoting healthy habits.



Absenteeism hours

Absenteeism is calculated as the sum of the hours not worked due to medical leave, weighted against the total hours that should have been worked in theory.



The increase in absenteeism from 2018 to 2019 was due to a number of long-term sick leaves.

3.5. Health and safety at the workplace Health and safety conditions at the workplace

The company's occupational risk prevention policy seeks to mitigate occupational risks for all employees.

At our factories, which are the workplaces with the greatest potential risk, all risks are identified by sections. For each section, we assessed the characteristics of each worksite and the different action plans implemented on them.

- At the factory in Spain, the "Risk Assessments" of the different sections are updated between two and four times per year, especially when there are significant changes at the facility. This ensures that all risk assessments are updated at least every five years. Moreover, we use the services of an external risk prevention company to help us prepare the different assessments and to detect the areas where improvements or staff training are required. An "Annual Safety Report" is drafted at the end of the year summarising the aspects of workplace health and safety addressed during the year.
- At the French factory, periodic revisions are carried out in compliance with the

regulations. Each of the five identified sections has its own indicators and measures. Every year, the Works Committee and the Health and Safety Committee hold at least three meetings for the specific purpose of addressing Occupational Health and Safety issues. All findings are recorded in a shared document that is updated at least once a year.

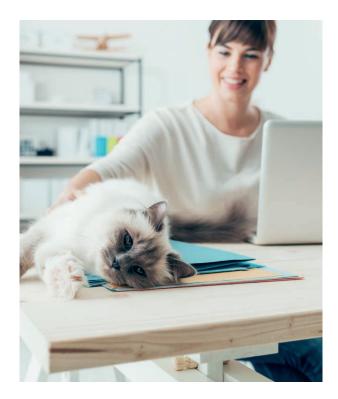
At the Italian factory, occupational risks are assessed by an external team. Risk assessments are updated whenever there are significant changes at the facilities. The external prevention service is responsible for providing worker training.



- In Barcelona, the Risk Assessment was updated in 2017 so it did not need to be reviewed in 2019. As with the factory, there is an external prevention service (EPS) that prepares risk assessments and runs staff training courses. There is also a "Prevention Activity Plan" which contains the risks and improvement actions to be carried out. As in previous years, in 2019 the employees at the Barcelona offices received special Occupational Risk Prevention training.
- In Paris, all employees took training courses on Occupational Risk Prevention in 2019, as required by law.
- At the offices in Milan, the risk assessment service is outsourced. Risk assessments are regularly updated in compliance with the laws on Health and Safety at the Workplace. Various courses were run in 2019 to update employees on new concepts in Occupational Risk Prevention.

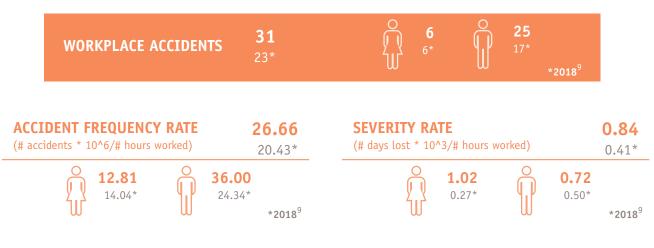

3.6. Social Relations

- In Spain, the employees of the Barcelona offices and the Els Monjos factory are covered under the "National Collective Bargaining Agreement for Manufacturers of Compound Animal Feeds".
- In France, both the Paris offices and the La Chapelle factory are covered under a similar agreement called "Convention Collective de la Meunerie".
- There are two different agreements in Italy. The Milan offices are covered under "CCNL Commercio" while the Castelgomberto factory is covered under the "CCNL Alimentare".



The four agreements make specific mention of matters on health and safety at the workplace. Dialogue between management and labour is channelled through works committees composed of democratically elected workers. There are two committees in France and Spain, one for the factories and the other for offices, whilst in Italy there is one committee for the factory.

There is also an internal, non-anonymous communication channel to facilitate structured and

confidential queries regarding the interpretation or application of the Code of Conduct and to communicate and report potential breaches.

Finally, it should be noted that it is part of Affinity's corporate culture to create spaces for dialogue with employees, places to share projects, achievements and other information of general interest. In 2019, 46 meetings of this type were held at the different worksites in Barcelona, Paris, Milan, Monjos, La Chapelle and Castelgomberto.

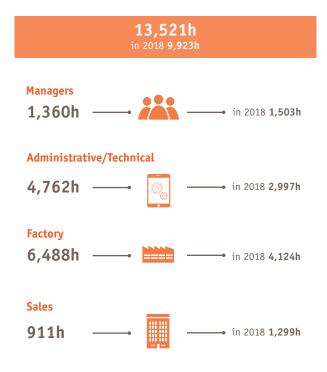
3.7. Training of workers

In 2019, a total of 13,521 hours of training were given (an average of 18.42 hours of training per employee).

At Affinity, training opportunities are offered that go beyond those established by law and are intended to enhance work skills.

Although a start was made in 2019 to count the hours spent on training courses through a platform for handling training, it has not yet been implemented in all departments and countries. Thus, the figures reported in this report do not include all of the training courses attended by Affinity's employees. The breakdown of the training hours by professional category is as follows:

3.8. Respect for diversity and equal opportunities

As reflected in our Code of Conduct, Affinity does not allow discriminatory behaviour of any kind. In particular, we promote equal treatment between men and women in terms of opportunities, access to employment, training, professional promotion and working conditions.

With regard to this, Spain and France each have their own gender equality plans. They both put forward measures in the areas of work organisation, recruitment, selection, internal promotion, training, leaves of absence and communication, among others. In Italy, there are no legal obligations related to gender equality but the same non-discrimination practices that are observed in Spain and France are also applied there.

In 2019, as in previous years, no discriminatory incidents were reported either through whistleblower hotline provided by Affinity to employees or through any other channel. If a report is made, it is automatically forwarded to the Ethics and Compliance Committee, which is responsible for adopting the corresponding decisions and measures following an internal review (see sect. 4). In certain cases, even Affinity's Board of Directors may become involved.





Ethics and integrity Ethics and the internal control model

Ethical conduct is one of the Affinity Group's core pillars, as reflected in its Code of Conduct. On an organisational level, one of the functions of the Ethics and Compliance Committee, as a permanent internal governing body, which reports to the Audit Committee of the Board of Directors, is to promote a culture of ethical conduct with zero tolerance in respect of any unlawful acts committed and situations that go against the legislation in force. To assist it in performing its functions, the Compliance Committee relies on Affinity's Internal Control System,⁽¹⁾ which is designed in accordance with international COSO standards whose aim is to provide a reasonable level of certainty that control objectives are attained in the following areas:

- Efficiency of operations
- Reliability of information
- Compliance with the laws, rules and regulations that apply

Therefore, Affinity's control model comprises a set of substantive rules procedures and specific actions designed by the group to encourage the organisation to act ethically and in compliance with current regulations, among other things. Its ultimate aim is to prevent, detect and react to irregular actions, fraud or conduct that is contrary to the Affinity Group's Code of Ethics in general, and to current regulations in particular.

The Compliance Committee has identified the regulatory frameworks to which the Group is subject, as well as the most relevant ones in line with the nature of our business, based on applying a risk assessment methodology. The departments and functions with responsibility or competencies in compliance-related areas have been established with the aim of coordinating these functions and thereby ensuring the effective operation of the compliance system as a whole. Therefore, our regulatory compliance system is not only subject to matters related to the adaptation of amendments made to Spain's Criminal Code, and the fight against activities such as corruption and bribery, but also to all levels of compliance the Group is obliged to fulfil.

The Affinity Group's Compliance System is a comprehensive, three-pronged system:





Most notable actions in the area of ethics and compliance

As pointed out above, in the framework of its Internal Control System, the Group carries out a number of actions and has monitoring systems in place for ensuring compliance with the laws and regulations in force.

These include (i) crime prevention programmes developed to comply with the provisions of the Spanish Criminal Code (without prejudice to additional actions required under the laws in other jurisdictions where the group operates); (ii) measures for compliance with the Code of Conduct, including, inter alia, specific training and communication plans for all professionals in the Group, as well as the whistle-blower hotline: (iii) specific internal rules on regulatory compliance; and (iv) controls that mitigate the risk of breaches of the laws in force.

The Compliance Committee is responsible for the Code of Conduct, the Corruption and Fraud Policy, the Purchasing Policy and the Supplier Code of Ethics, the Crime Prevention Policy, the Whistle-Blower Channel and any others assigned to it by the Audit Committee, the Board of Directors of the Group's holding company or that are included in Affinity's Corporate Governance System.

Fighting corruption and bribery

The Code of Conduct sets out Affinity's commitment against corrupt business practices (in any shape or form) and/or bribery.

Affinity's Anti-Corruption Policy, applicable to all Group companies, develops the principles contained in our Code of Conduct of staunch commitment to strict compliance with the regulations on preventing and fighting against corruption. Affinity rejects any form of corruption by taking a zero-tolerance approach to any breach of our policy. To prevent corruption, Affinity conducts its business in accordance with the laws in force in all areas and in all the countries where we operate, true to the purpose and spirit of the law, undertaking:

- Not to influence the will or objectivity of people outside the Company to obtain any benefit or advantage by means of unethical and/or illegal practices.
- Not to give, promise or offer, directly or indirectly, any item of value to any natural or legal person in order to obtain undue advantages for the Company.
- Not to allow facilitation payments (small payments in order to expedite or facilitate the completion of administrative or similar formalities).
- Not to directly or indirectly finance any political party, its representatives or its candidates.

- Not to use donations to cover up improper payments.
- Not to solicit or improperly receive, directly or indirectly, commissions, payments or benefits from third parties in connection with investments, divestments, financing or expenditures carried out by the Company.
- To faithfully and adequately reflect the Company's activities, operations and transactions in the Company's books and records.
- To foster a culture of integrity within the group, as well as with suppliers and collaborators, through the dissemination of ethical conduct.

Whenever there is any evidence, doubt or suspicion of any form of corruption whatsoever, it must be reported immediately by the Affinity employee to his or her superior, to Legal Services or to Affinity's Internal Control Body. The Company's employees, as well as third parties, may also convey their doubts or concerns through the whistle-blower hotline provided for this purpose.

Affinity will not tolerate any retaliation against anyone who in good faith reports facts that could constitute a breach of our policy.

The company's Code of Conduct, its corporate policies and access to the Whistle-Blower Channel are available on its intranet. A channel has also been enabled on the corporate website, through which the company's suppliers are able to report any conduct that goes against our Suppliers' Code of Ethics.



In 2019, the Compliance Committee did not detect any cases of corruption and/or bribery, nor of any discrimination or breach of human rights.

Finally, as Affinity is not subject to Act 10/2010, of 28 April, on the Prevention of Money Laundering, no specific policy on this matter has been drawn up. Notwithstanding the foregoing, money laundering is dealt with in the risk analysis drawn up by the Compliance Committee, whose findings were that the company's Finance department would be most likely to engage in this practice.



Respect for human rights

Respect for human rights forms part of Affinity's commitments to society and its employees. The Code of Conduct sets forth the basic principles on the dignity of individuals, equal opportunities and gender equality, and non-discrimination. In conducting our business and operations, we are bound by the ethical considerations of the UN's Universal Declaration of Human Rights, the Tripartite Declaration of the International Labour Organization (ILO) and the Guidelines for Multinational Enterprises of the Organisation for Economic Co-operation and Development (OECD). It should likewise be highlighted that the operations of the companies controlled by the Affinity Group are basically limited to the European market, where both EU and local laws offer a high level of protection in the areas of human rights, prevention of forced labour and child labour.

Knowledge of and compliance with the Code of Conduct is reinforced by the company's communication and training plan, which is delivered to new hires when they join Affinity,



an on-line course that must be completed by all employees; training based on the explanation of the principles and conflicts that may arise; and information sessions on the Code and involvement in the business.

Non-compliance with either the Code or any other aspect related to human rights, will be analysed according to internal procedures, legal regulations and the agreements in force, and may result in disciplinary action or termination as stipulated in the internal regulations and the law.

Affinity's employees have the obligation to inform the company, confidentially, of any breach of the commitments contained in this policy they may observe. People who are not employees of the company but who observe potential breaches in this area may also report them. The company has not received any complaints for human rights violations.

When considering a potential acquisition, Affinity will take into consideration its impact on the protection and promotion of human rights and will define indicators in this regard.

Similarly, the Supplier Code of Ethics to which our suppliers adhere includes among its guiding principles the commitment to respect the protection of internationally recognised fundamental human and workers' rights within their sphere of influence, and to provide a safe working environment, guaranteeing equal opportunities and complying with all established occupational risk requirements. Suppliers are also responsible for ensuring that their associates and subcontractors abide by these principles.

4.2. (onsumer protection Quality assurance and food safety

Affinity Petcare, in keeping with its quality and food safety policy:

- **# Implements** management systems based on efficient processes focused on achieving:
 - Customer and consumer satisfaction.
 - Production and distribution of products that are safe for pets.
- Sets goals and objectives that continuously challenge us to improve results for customers, consumers, shareholders and suppliers.
- Periodically reviews the effectiveness of the implemented systems and the associated goals and objectives.

For quality assurance purposes we have identified the following stakeholders:

- **Customers:** the ones who distribute and sell Affinity products to consumers.
- **Consumers:** the owners of the pets who buy Affinity brand products.
- Dogs and cats: the end consumers of Affinity products.

As far as food safety, we consider a food risk to be anything which could affect the pet's health and whose effects have either been demonstrated or fall within the realm of reasonable possibility.

All products marketed by Affinity Petcare are designed, manufactured and distributed under controlled conditions with hazard analyses.

For products manufactured by third parties, Affinity ensures that the same principles are applied.



To guarantee all this, Affinity has implemented a HACCP (Hazard Analysis and Critical Control Points) system based on:

- **FEDIAF Code of Practices** for the manufacture of safe food for dogs and cats.
- FAO/WHO Codex Alimentarius "Recommended International Code of Practices General Principles of Food Hygiene".
- Solution States Requirements Requirements".

Complaint systems, reception and resolution of complaints

Promoting satisfying relationships with our consumers is vital to our business and their continued improvement.

Affinity maintains a constant dialogue with consumers, who have different channels available to them to communicate with each of the brands and to stay informed of new commercial developments. Communication with our consumers is essential to our business model as their suggestions and opinions enable us to continually improve.

Our customer service handled 9,500 enquiries in 2019, as opposed to 11,000 in 2018. Of the enquiries made in 2019, 9% were for claims, in comparison with 8% in 2018.

In respect of the channels used, 80% were submitted online (85% in 2018) and 20% by telephone (15% in 2018). Insofar as the subject Affinity maintains a constant dialogue with consumers, who have different channels of communication available to them??



matter of enquiries is concerned, they were related to a wide range of questions, from where to find a product, its characteristics. incidents through to enquiries about new products. A total of 99% were resolved as of the date of this report (98% in 2018).

Affinity's customer service is free and the open channels allow consumers to hear opinions and clarify doubts as quickly and accurately as possible. Affinity has open channels for all of its brands in order to provide a more personalised and streamlined service.

A change was introduced in September 2019 to consumer care tools and classifications that brought about a modification to the different indicators for monitoring our business, amongst which was customer satisfaction. By applying these new indicators, the average score out of 10 for our free helpline and online service for the period from September to December 2019 was 8.03 and 6.96, respectively. Using the previous rating methods, the results of the customer satisfaction indicators in 2018 on a four-point scale were 2.69 for the customer helpline and 3.86 for the online service.

The free customer service telephone numbers and the contact forms and e-mail addresses are listed on our website. These contact details also appear on all of our packaging.



4.3. Sustainability in the supply chain

Because Affinity's supply operations are carried out on a European scale, we are able to offer suppliers a guaranteed regulatory framework that affords uniform levels of protection and security in all our commercial relations.

Affinity seeks to establish lasting relationships based on mutual trust with our suppliers wherever we do business and in the different categories of applicable products and services. The mutual success of this business relationship is based on respect for the following principles contained in the Code of Ethics of Good Practice, to which our suppliers adhere:

Ethics and Legality:

Suppliers ensure that they comply with the laws in force in the countries where they operate and make a commitment to uphold the strictest standards of ethical and moral conduct, avoiding any type of corrupt practices, conflicts of interest, providing truthful information in their communications with Affinity and ensuring the exercise of free competition.

Labour Practices, Health and Safety:

Suppliers undertake to respect the protection of internationally recognised fundamental human and workers' rights within their sphere of influence, and to provide a safe working environment, guaranteeing equal opportunities and complying with all established occupational risk requirements.



The Environment and Animal Welfare:

Suppliers comply with all legal requirements related to environmental protection and are in possession of the required operating permits, taking a preventive approach and properly managing any substance or material that represents a danger when released into the environment. The Supplier must likewise comply with any legal requirements related to animal welfare if applicable to it.

Product Quality and Safety:

Suppliers guarantee that all products supplied to Affinity comply with all food quality and food safety regulations and laws in force. The Supplier undertakes to immediately inform Affinity about any matter or suspicion related to food safety.

Confidentiality and Intellectual Property:

Suppliers undertake to respect intellectual property rights and to treat any information shared by Affinity and concerning the business relationship between them as confidential, refraining from disclosing it to third parties without Affinity's prior written consent.

Subcontracting:

Suppliers are responsible for ensuring that their collaborators and subcontractors abide by these principles.

In line with its Quality Assurance Policy and in the way it conducts its operations, Affinity uses a standard Supplier Certification Process that, based on the critical nature of the products purchased, subjects its suppliers to audits that cover aspects related both to quality and environmental considerations. Affinity also continually monitors its suppliers in order to guarantee the level of quality and safety of the products purchased.



5. Other commitments to society and sustainable development

5.1. (ommitment to society and local communities

In the countries where we have a direct presence, our commitment to Society is expressed through different initiatives focused on animal welfare and the people who interact with them.

Cross-company initiatives

Affinity supports the work of animal shelters in Spain, Italy and France through our **programme of donations to shelters.** It is our contribution to the praiseworthy work of these shelters that take in and care for cats and dogs that have been abandoned or mistreated.

As a result of this initiative, we donate a certain amount of our products to pet shelters every year (see 2.3).

Specific initiatives

As far as other more specific initiatives are concerned that we are involved in on our main markets, the **Cani Eroi Programme**, "Dogs that save and improve lives" was started in **Italy** in 2010 as a result of the social commitment of the Trainer brand. This initiative seeks to raise awareness of the importance of dogs to humans and the fundamental role they play in protecting human lives and rescuing people in situations of danger.

Dogs play a leading role in many civil protection efforts, water rescue, search and rescue of missing persons, assisting the disabled and acting as therapy animals. The (ani Eroi Programme "Dogs that save and improve lives" was started in Italy as a result of the social commitment of the Trainer brand ??



With the Cani Eroi project, Trainer seeks to showcase the work, commitment and dedication of these dogs and their educators through different volunteer and governmental associations.



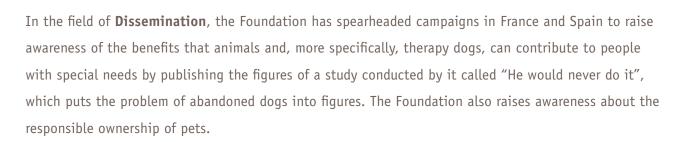


Our Foundation, present in Spain and France, investigates, acts and promotes the benefits of dogs and cats in society?? Furthermore, in **Spain** and **France** a very important part of Affinity's commitment to society and local communities is embodied in our corporate Foundation, the **Affinity Foundation**, which since its creation in 1987 researches, engages with and promotes the benefits of pets in society. Funding in 2019 amounted to 1,196 thousand euros (1,191 thousand euros in 2018).

In 2019, the Foundation continued with the mission of spreading the benefits of the relationship between pets and people from the three different areas where the Foundation's efforts are focused: research, social action and awareness raising. We continued to support the cause #AnimalesQueCuran, through which we wish to highlight the benefits of pet-assisted therapy and the role of pets in society.

Our **Social Action** concentrated on animal-assisted therapies.

- Since the early 1990s, the Affinity
 Foundation has done a great deal of work to introduce, train experts and set up

animal-assisted therapy programmes, with special emphasis placed on best practice and compiling results.

INDEX

In 2019, we ran therapy programmes in different fields in both France and Spain. In this case, we contributed through our work with local organisations to set up animal-assisted therapy programmes that were awarded funding in our 2018 Call for Grants.



We continue to be committed to **Research** through the Affinity Animals and Health Foundation Chair at the Autonomous University of Barcelona (UAB), which is gradually working to position itself as a research group at a European level, with several studies, publications and presentations at international conferences on anthrozoology.





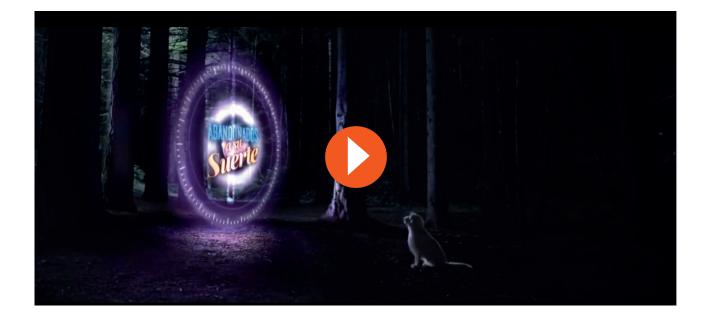
The main activities carried out by the Foundation in 2019 are detailed below:

Research

The Chair has conducted and/or supervised 6 research studies, such as a study on abandoned pets, studies to evaluate animal-assisted therapy programmes, and other studies on the link between people and animals in France and Spain.

A total of 12 papers were published in journals such as Animals and Nature Scientific Reports, and submissions at international conferences, such as the IAHAIO Conference, the VMX-NAVC (North American Vet Society) Conference and the ECAWBM (European College of Animal Welfare & Behavioural Medicine) Congress.

In addition, as we have done each year for more than 20 years, we completed a study on abandoned and adopted pets with the help of hundreds of pet shelters in Spain, which brought to light the gravity of the problem of abandoned pets. The number of pets taken into shelters was stable in comparison with other years, with a figure of around 140,000 cases reported.

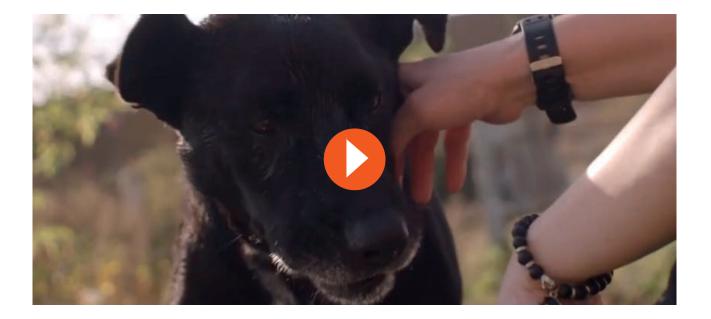


In France, following a study of the relationship between people and cats last year in the CORS study, further work was done into the relationship between people and dogs in the MDORS study.

Social action

We ran a number of programmes on animalassisted therapies in France and Spain, such as **Compludog**, in collaboration with the Complutense University of Madrid, to help mitigate students' stress levels; the **Opening** Doors programme in a prison in Nantes with the association Coeur d'Artichien; Ehpad Alzheimer, a programme intended for old people with Alzheimer's disease: Zigzag Zoo, a programme carried out in collaboration with the association Les Animaliens, for children with slight learning disabilities and behind in their schooling; and **HealingDog**, a programme to lessen posttraumatic stress with the help of rescue dogs, with the collaboration of the Institute of Victimology and the AVA Refuge.

Others continued to be run, such as **Buddies**, set up for young adolescents who live in government-run boarding schools in Catalonia; **Respect Me**, a programme for the prevention of bullying carried out at the school Leon XIII; the one at La Falguera retirement home, which seeks to contribute to the emotional, cognitive, physical and social well-being of the old people who live at the home; and the **Opening Doors** programme, which has been run in a number of prisons across Spain for several years.







Awareness

The Foundation's message was disseminated through the usual channels: media, events, public relations, web, social networks, etc.



Dissemination makes known the benefits of animal-assisted therapies through the testimonials of the people involved in them.

The Affinity Foundation also flags up abandoned pets and promotes their adoption in collaboration with the **Miwuki digital platform** that brings shelters and potential adopters together.
