FOREWORD

With the passing of the National Action Plan for the fight against illicit drugs 2009-2013, and the adoption of the Law on the Prevention and Suppression of Drug Abuse in BiH "Official Gazzete of Bosnia and Herzegovina, 2006.", the state of Bosnia and Herzegovina clearly demonstrated its commitment to this field. One course of action and commitment of the state in this direction is the opening of drop in centers in Bosnia and Herzegovina.

Drop in centers purpose is to provide it clients a comfortable place for rest, sleep and any other needs (personal hygiene, laundry, etc.). At the center, a responsible person (drop in the operator) is always present and available for the clients. Among other things, once or twice a week, nurse, social worker and lawyer come to the drop in center to advise the clients of the center.

Clents of the Center are not only people who inject drugs, but also sex workers and former prisoners. Drop in centers organize field work (outreach) which aims to reach the target groups and to establish contact with addicts who, on their own, do not have contact with any health or social institution. Outreach work acts in the immediate environment of addicts. Outreach workers are not only college-educated people, but also people with experience in drug use that have many years of stable abstinence.

Accreditation Standards for drop in centers were created as part of the "Package of harm reduction services in Bosnia and Herzegovina" related to the UN Global Fund for HIV / AIDS, TB & Malaria project implementation. These standards rely on policies and programs and good practices to reduce the social, health and economic consequences of (mis) use of legal and illegal psychoactive substances, without them irrefutably reducing injection drug use. Harm reduction as a program has been recognized by the World Health Organization, UNODC and the UNAIDS.

In addition to the national literature used in the preparation of these standards, international references, downloaded from the official site of EMCDDA* (European Monitoring Centre for Drugs and Drug Addiction), were used as well. The EMCDDA has existed since the 1993., and is one of the EU's decentralized agencies with headquarters in Lisbon. It gives EU member states a factual overview of the events associated with psychoactive substance abuse and offers topics for discussion.

The goal is to, throuh accreditation standards and accreditation of drop in centers, achieve for all centers in Bosnia and Herzegovina to operate and provide services to their customers at the same, guaranteed level of quality, which primarily refers to the safety of the clients and personnel at drop in centers.

INTRODUCTION

Accreditation Standards: Form and Content

Accreditation Standards for drop in centers in Bosnia and Herzegovina contain a total of 13 standards and 87 criteria are divided into four sections as follows:

- 1. Center;
- 2. Services and interventions in the center;
- 3. Fieldwork (outreach);
- 4. Evaluation of the drop in center work success.

Standards and criteria have a specific form. Each standard has four columns, each criteria has five columns (see Figure 1):

- <u>The Number</u> of standard (contains two numbers: the chapter number and then the ordinal number of the standard) or the number of criteria (which has three labels: chapter number, ordinal number of standard and ordinal number of criteria);
- <u>The Statement</u> of standard (which defines it) or statement of criteria (which in more detail analyzes that standard);
- <u>Instructions</u> of standard or criteria (further emphasizes or explains the statement);
- <u>Evidence for evaluation</u> (present only in criteria, and state what must be provided or met during the assessment for the criteria to be fulfilled) and
- <u>References</u> of standard/criteria (column which lists the literature and/or national legislation to which it directly or indirectly refers and which directly or indirectly supports the statement of the standard/criteria in question).

Within the standards are listed policies and procedures relating to the work within the center. Standards provide 16 policies and procedures, although it is assumed that, over time, centers will create more procedures than prescribed by the accreditation standards, since procedures are the ones that are enabling all service users to receive equal treatment, both in volume and by quality of service, and making the work easier for the personnel, by standardization of work processes. Of course, it is possible for procedures to be named and/or grouped differently, in case of similar themes, or if several procedures are overlapping in a work process of one center. Procedure, in addition to its name, has its own form, which must be fulfilled in order to be valid. This form contains:

- The date of creation or last revision,
- The date of the next planned revision (up to three years furthest),
- The seal of the center or the organization which established it,
- The signature of the responsible person (person who has written procedure) and

- A list of signatures of personnel confirming that thay are familiar with the procedure and are implementing it.

Rating of standard/criteria fulfillment level

The fulfillment of the individual standard is conditioned by fulfillment of all the the criteria contained in this standard, while the fulfillment of the criteria is conditioned by presenting evidence listed in "Evidence for assessment" column, which are necessary for the given criteria. The unconditional (full) Accreditation will be given to centers that have met 80% or more of the standards requirements, while the conditional (suspended) Accreditation will be given to those that have met more than 70% but less than 80% of the standards requirements.

As evidence of the fulfillment of the criteria, within these accreditation standards, interviews with both the staff and the clients are used, and the criteria is met if 80% (or 4 out of 5 respondents) confirms assertion stated by criteria. For other cases, the rating is done througe the presentation of evidence (insight into existing documentation, policies, procedures, etc.) and inspection of the facility and/or it's equipment. Grading of the criteria fulfillment is carried out according to the scheme:

- Fully fulfilled criteria **F** 2 boda;
- Partially fulfilled criteria **P** 1 bod;
- Unfulfilled criteria U 0 bodova i
- Non-applicable criteria
- NA shall be exempt.

Rating of fulfillment is first time performed by the staff of the center in a process known as self-assessment, which is a way for center to determine its shortcomings in terms of fulfilling the requirements arising from the standards. Self-assessment can be repeated any number of times. When the self-assessment is satisfactory, the center is ready for external review and submits a request to AKAZ about the term of the external review. During the process of appointing members of the evaluation team, AKAZ takes into account that there is no conflict of interest between the appointed team and the center to which the team is going.

Accreditation review conducts a team of appointed external evaluators at the external inspection of the center. The team consists of chief evaluator and a team member. These are trained professionals who have undergone AKAZ's training for external assessors. They are guided by the same evidence for fulfillment of the criteria/standard that are listed alongside the very standard/criteria. Based on the final report, the drop in center is granted full (unconditional) accreditation or conditional accreditation. If conditional accreditation is granted, the center is given a certain period of time during which it is required to fix the deficiencies in terms of meeting the standards and thus fulfill the requirements for full accreditation. If this is not done within the given deadline, the accreditation is being withheld. Also, when the fulfillment of the criteria is below 70%, accreditation is denied until the conditions are met for the issuance of the same.

Duration and monitoring of the accreditation

Accreditation is obtained for a period of three years. Within those three years, AKAZ will supervise the accredited centers through at least one unannounced external review. This review is done in the same way as the review during the external assessment, whith the purpose of determining to what extent the staff of the center abides to the requirements arising from the accreditation standards. Upon expiry of the accreditation period, the center applies for the renewal of the accreditation and the whole process starts over again. Accredited centre has the right to: inform their clients and public about the status of accreditation, put to public scrutiny the decision on accreditation and the accreditation mark, and request official interpretation from AKAZ in case of any questions.
