On the occasion of the project "Strengthening NGO capacity and promoting public health and promoting human right oriented drug policy in South East Europe" DPNSEE held a press conference in the EU info centre in Belgrade, Serbia on 1. September

The speakers on the press conference were:

- Mr. Thanasis Apostolou, chairman of the board of the Network for policy towards drugs South-Eastern Europe. He welcomed the guests and presented the project "Strengthening NGO capacity and promoting public health and promoting human right oriented drug policy in South East Europe ", but also the objectives of the project and the network itself.
- Mr. Nebojša Đurasović, president of NGO Prevent from Novi Sad who spoke about the participation of this organizations in the project, but also did a small review of the International Overdose Awareness Day (IOAD), that is a global event which takes place on 31 August of each year and aims to raise awareness about overdose, as well as to influence the reduction of stigma related to death due to an overdose of psychoactive substances.
- Mr. Milutin Milosevic, Executive Director of the Network for policy towards drugs Southeast Europe, Talked about the strategic plans for the future of networks, as one of the important actors in the region when it comes to drugs policy and its reform in the direction of respect for human rights and public health.

Visit to Kosovo



Pepresentatives of the Drug policy network South East Europe visited Kosovo from 29 to 30 August 2016. The delegation included Thanasis Apostolou, Chairman of the Board, Milutin Milošević, Executive Director and Julijana Daskalov, Financial officer.

The overall objective of these public meetings is to involve civil society in the decision making process about drug policy. 


Potential for cooperation on justice and home affairs

Meeting with the Mayor of Aghios Dimitrios (Athens)



Diogenis" has started a round of meetings with local authorities in Athens, aiming to raise awareness in drug policy issues.

First stop was at the Municipality of Aghios Dimitrios, meeting the Mayor, Ms. Maria Androutsou and the Vice-Mayor Ms. Eleni Katzeli (Dept. of Social Services).

The discussion was in a friendly and sincere level, both sides expressed their will to start a dialogue with the local community on drugs, aiming to the maximum participation of the citizens. They also highlighted the problems that both Municipalities and NGOs face in their struggle to give better responses to the needs of the users and of society, as i.e. the lack of National Strategy on Drugs.

The meeting ended with the will of both sides of a closer cooperation on drug policy issues, giving a new aspect on the relation between the Municipality of Aghios Dimitrios and "Diogenis".





The NGO "Diogenis – Drug Policy Dialogue" organized the presentation of the book "Sentencing of Drug Offenders: Legislators' Policy and the Practice of the Courts in South Eastern Europe". The book is edited by Mr. Thanasis Apostolou (Director of 'Diogenis') and published by "Sakkoulas Publications". The event was held on September 27th, 2016 in the Europe Direct hall of the Municipality of Athens.

In the panel discussion chaired by Mrs M. Malliori, Professor of Psychiatry, University of Athens, participated:

 (Author of the research for Greece, published in the book)
- Evangelos Zacharias, Appeals Prosecutor, Chief Prosecutor of Piraeus
- Evangelos Kafetzopoulos, neurologist psychiatrist, President OKANA
- Chris Vettas, director of KETHEA "PROMETHEUS", Northern Greece

The publication contains the findings of the investigation which was carried out by "Diogenis", in collaboration with researchers linked to research institutes and legal university faculties in the countries surveyed: Bosnia and Herzegovina, Bulgaria, Croatia, FYROM, Greece, Montenegro, Romania, Serbia and Slovenia.

DIOGENIS AT THE 4th NATIONAL MEETING ON "AIDS & HEPATITIS"

The National Meeting on "AIDS & Hepatitis" was held with great success for the 4th consecutive year. The scientific meeting took place from September 29th to October 1st in Athens, Greece. The aim was to provide a comprehensive approach to HIV/AIDS and viral hepatitis regarding our country, by putting special emphasis on the real challenges that health professionals, patients, public health authorities and the general public are facing. During the conference, distinguished scientists and professionals working in this field presented the most important developments in epidemiology, diagnosis, holistic prevention and treatment of those diseases.

'DIOGENIS' Drug Policy Dialogue, for 2nd consecutive year, was represented by the director of the organization, Mr. Apostolou Thanasis, who participated at a round table entitled "Addicts in Greece, 2016" and spoke about the "UNGASS 2016" (UN Special Session of the General Assembly on Drugs) that took place on April 2016 in New York. Aim, expectations, successes and setbacks of this Special Session, as well as the importance of this Session's outcome and the future implications on national, European and international level were presented in detail.

Draft proposal to decriminalise drug possession for personal use in Albania



The Minister of Interior of Albania presented a draft proposal to consider the consumption and possession of small quantities of drugs for personal use an administrative offense and not a criminal act. The proposal argues that the state police seizes for 70% of the cases small quantities of narcotic drugs. This practice requires from the police a lot of human resources and expertise in order to determine what consists a "daily dose" for a consumer and generates numerous court hearings with employment of a high number of experts resulting into unnecessary court expenditures without tangible results. It is expected that the proposal will cause a vivid discussion in the Albanian parliament. The outcome of the deliberations in the parliament are uncertain. It is however good that this debate takes place.

etters to the Prime Minister, the Minister of Health and the Minister of Justice was sent in July, by the _six NGOs – members of the "NGO Platform on psychoactive substances", calling for the necessary and immediate initiatives to be taken, aimed at implementing a coordinated policy geared to public health and human rights.

The Greek "Platform of NGOs for psychoactive substances" consists of the following organizations: "DIOGENIS – Drug Policy Dialogue", "POSITIVE VOICE", "CENTRE FOR LIFE" in support of people living with HIV / AIDS, «PROMITHEAS – Liver Patient Association of Greece", "GREEK DRUG USERS UNION" and "PRAKSIS".

Among other, they request the establishment of (a National Strategy on Drugs) the Inter-Ministerial Commission on Drugs chaired by the Prime Minister, as required by the law 4931/2013. The Commission has to approve the Drug Strategy which has been submitted by the national coordinator in 2014. The letters refer also to anchor Harm reduction in the law and decriminalize possession of drugs for personal use. You can see the press release at the following link:
