

International Drug Policy Consortium A global network promoting objective and open debate on drug policy

Structure and work plan - 2009/2010

The International Drug Policy Consortium (IDPC) is a global network of NGOs and professional networks that specialise in issues related to the production and use of controlled drugs. The Consortium aims to promote objective and open debate on the effectiveness, direction and content of drug policies at national and international level, and supports evidence-based policies that are effective in reducing drug-related harm. It produces occasional briefing papers, disseminates the reports of its member organizations about particular drug-related matters, and offers expert consultancy services to policymakers and officials around the world. IDPC members have a wide range of experience and expertise in the analysis of drug problems and policies, and have contributed to policy debates at national and international level. The following paragraphs describe our main planned areas of activity in 2009/10.

IDPC has a global membership of NGOs and professional networks with an interest and expertise in drug policy issues (see below for a full list). Partner members work together to implement the annual IDPC work plan, while network members contribute to the dissemination of our ideas and materials. We have come together to facilitate open debate on drug policy issues, and to promote more humane and effective policy at a national and international level. The network is managed through a steering group of representatives from the 10 regions, and a secretariat based at Release, the UK drugs and legal advice charity.

Our work plan for the period April 2009 to March 2010 aims to build on the analysis and advocacy relationships we have developed over the previous two years and to articulate a progressive alternative to repressive drug policies. We will provide NGOs and policy makers with mechanisms to discuss and implement more humane and effective policies and programmes. Our activities can be grouped under three broad headings:

Networking and communications

The core of our communication system is our website (www.idpc.net). This site contains all the latest information on our work, regular updates on drug policy debates and structures from around the world, and a publications library of relevant reports and briefing papers produced by IDPC, our members and other relevant bodies. We produce and distribute a monthly email alert to thousands of subscribers, that provides latest news and publications on drug policy issues. We have a regional structure for planning our advocacy work with national governments. In each region, a lead member facilitates discussion on advocacy priorities and opportunities, and organises our resources to maximize the influence of our network. International advocacy

The United Nations, and other multilateral institutions, need to consider drug policy in the context of many other global challenges – for example the fight against HIV/AIDS, the obligation to protect human rights, the need to maximize social and economic development, and the battle against organized crime. The issue therefore comes up in many different multilateral forums, but is mainly dealt with through the structures established to oversee the global system of drug prohibition – the United Nations Office on Drugs and Crime (UNODC), the International Narcotics Control Board (INCB), and the Commission on Narcotic Drugs (CND). We will co-ordinate the involvement of our network in seeking to promote our policy principles and perspectives to these bodies. This involves producing reports and briefing papers that analyse and critique the work of these bodies, providing information on their structures and meetings, and organising NGO activity and advocacy. A key target in this regard is the annual meeting of the Commission on Narcotic Drugs, held every March in Vienna, and at which the IDPC has a significant presence.

National advocacy

As most national governments around the world attempt to reconcile their commitment to the international drug control system, with evidence on the ground that shows the problems related to drug markets and use as being much more complex and intractable, IDPC members are seeking to offer constructive advice on how to develop and implement more humane and effective policies. We are collating a national policy 'toolkit' of best practice and evidence from around the world that our regional groups can use to promote our policy principles, and specific programmes and activities that have been shown to be effective in reducing drug related harm. Regional groups can call upon the expertise and contacts in our global network to arrange seminars and workshops in target countries, offer advice and consultancy to policy makers, and arrange study tours to showcase effective practice.

Membership

The IDPC membership is constantly growing. Members can be NGOs, academic institutions, think tanks, or professional networks, but they must have a national or international outlook, and a credible track record in the drug policy field.
