# **PREAMBLE**

he National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) has since 2012 held Annual National Conferences with a view to providing a platform for stakeholders to share their experiences in addressing the enormous challenge of alcohol and drug abuse. This year, NACADA is partnering with the Ministry of Interior & Coordination of National Government, International Society of Substance Use Professionals (ISSUP), African Union and US Department of State Bureau of International Narcotics and Law Enforcement Affairs (INL) in undertaking the first ever International Conference on drug demand reduction in Kenya. The International Society of Substance Use Professionals is an international platform of addiction professionals that provides opportunity for information sharing on evidence-based treatment and prevention interventions as well as emerging issues in the management of persons with Substance Use Disorders.

The Conference will take place on 10<sup>th</sup> – 14<sup>th</sup> December 2018 at the **Kenyatta International Convention Centre** (KICC), Nairobi – Kenya.
