1.Introduction and Background

1.1. Executive Summary

The Indian Harm Reduction Network organized the third regional consultation with the regional partner organisations for strengthening the regional harm reduction network. 27 participants from the member states attended this consulation held in New Delhi.

In this consultation Microsoft PowerPoint Presentations and flips-charts were used to support deliberation and discussion. IHRN Secretariat shared all consultation materials with the participants through Google-eGroup.

1.2. Background

Under the GFATM Round 9: HIFAJAT Project, 5 Regional Harm Reduction Networks were initiated and established through various regional specific workshops held in major metropolitan cities in India. These workshop included key players such as TI implementers along with specific SACS, TSU & NACO representation.



This was facilitated by Sharan: Society for the Service to Urban Poverty as a Technical Partner in the 1^{st} phase and then it was taken over and continued by IHRN in the 2^{nd} phase with the purpose of scaling up the quality & capacity through facilitation of networking and exchange of implementation experiences within the regions and also drawing from them in the programming of the NACP IV.

IHRN facilitated the final regional harm reduction network meeting for the North region on 24th and 25th of Nov 2014 in New Delhi, which is considered as a convenient place for participants and also many SACS are stationed there. Involvement of SACS will provide leverage in the strengthening of NIHRN and also its activities roll out.

1.3. Objectives

The final consultation is aimed at the following objectives for strengthening the synergy among IDU service providers:

1. To explore the current situation of IDU related HIV services in the Northern states;

- 2. To identify strengths, weaknesses and opportunities of NIHRN as a functional network & strengthen its role in the region;
- 3. To develop a short term and long term working strategy for NIHRN as a network to address capacity gaps that needs collective action including SWOT exercise, advocacy needs assessment & advocacy strategy with action plan with defined roles and timeline;
- 4. To orient service providers & stakeholders about the GFATM 9 HIFAJAT Project and on areas where it can supplement and compliment IDU services through its existing mechanisms of working through STRCs and Learning Sites and networking through IHRN.

1.4. Progress

Outcomes of previous North Regional Harm Reduction meetings/workshop:

1st Regional Workshop [Facilitated by Sharan in 2011]

- NIHRN initiated with constituents & the Executive Committee elected;
- Constitution developed/MOA drafted with defined Roles and responsibility for the Executive Committee or office bearers;
- Service gaps identified;
- Region wise action plan developed;
- Web based presence planned.

2nd Regional Workshop [Facilitated by IHRN, December 2013]

This workshop was held in Delhi and attended by 30 delegates from 9 North Indian States with following tasks accomplished:

- Previous action plan reviewed;
- State specific & Region wise issues identified;
- Networking among members initiated by IHRN & in process of formalizing.

3rd Regional Workshop [Facilitated by IHRN, November 2014]

Total 21 delegates from 9 North Indian States participated and finished the following tasks:

- HIV services for IDUs including OST assessed through member & changes in trends & patterns identified;
- Registration process of NIHRN initiated and Secretariat placement discussed;
- Membership expanded through IHRN activities;
- Need for a strategic plan for NIHRN identified.

1.5. Challenges and Gaps

- NIHRN not yet registered as a legal entity;
- Secretariat to be established with network activities;
- Need for a strategic plan with defined roles, responsibilities & timelines;
- PMU & IHRN need to put more supporting role for NIHRN in its strengthening;
- Need to mobilize support from SACS, NACO, TSUs, State Social Welfare Departments, MoSJE for the functioning of NIHRN.

2. Proceedings of Day 1

2.1. Pre-lunch Sessions

Meeting was started with an opening address from Mr. Raju Raj Kumar, Central Coordinator and Mr. Siddharth Singh, IHRN Consultant/Facilitator.

Introduction

In the first session, an overview of 2 days consultation program details were shared with the participants. At the end of the session, participants were asked to introduced them with four key information including:

- Name?
- Where s/he works?
- How long s/he work?
- Why s/he is in this field?

Some of the participants were senior most in their organization and they been in the field for more than 15 years. Majority of them were in the middle management, nevertheless with great interest in this field to understand drug use and walk with PWIDs, they reported to be in field for less than 10 years. Few of them were found recently joined this field however their active participation helped this consultation to achieve its aims and objectives.

In the post coffee break, a session was facilitated to capture the overall progress made and key areas where NIHRN needs improvisations. In order to sum up the progress following points were discussed.

- Take home dosages are given only to the people who have court cases;

Why Harm Reduction?

• We will never have a drug-free society



- Abstinence has its limitations for many
- Enforcement has its limitations
- Primary prevention has its limitations
- People will continue to use drugs and get sick & die.
- We can reduce illness, suffering, deaths and other harms that people experience.

Definition of harm reduction

• Harm reduction aims to reduce the adverse health, social, and economic consequences of drug use while the person is still using drugs.

Aims of harm reduction

- Reduce the spread of infections such as HIV & HCV;
- Reduce risky drug use;
- Prevent drug overdose deaths;
- Provide honest drug education;
- Increase users' contact with services and treatment;

Drug related Harms

- The term harm reduction implies that drugs can cause real harms;
- Harms are psychological, physical, social, legal and economic;
- Harms are to individual, family, community and society;
- Harms are not an inevitable consequence of drug use, they can be prevented or reduced through a range of strategies;

Harm reduction principles include:

- Pragmatism
- Focus on Harms
- Hierarchy of goals
- Support not punishment
- Humanistic & Human Rights Based
- Non-judgmental
- Reduce Stigma
- Autonomy
- Flexibility
- Evidence based

Furthermore, Mr. Raju Raj Kumar and Siddharth Singh facilitated a session on explaining the importance and scope of establishing regional network. An emphasis was given about history of Indian Harm Reduction Network and its demonstrative work to be a national player and support national response towards drug use and HIV.

3.2. Post-lunch Sessions

Regional Strategic Plan


Nest session was a consultation-based work to collect relevant information and compile a Regional Strategic Plan for NIHRN. The major points from the SWOT analysis were utilized to draft the Regional Strategic Plan that follows the following structure:

Regional Strategic Plan Model: to determine where NIHRN as an organization is going over the next

year or more.

- Vision: Developing a clear understanding of what is your preferred future
- Mission: Developing a sound statement about why you exist
- Core Values and Beliefs: Describes behaviors and ideas that are important to your organization
- Strategic Issues: The issues that create a gap between the ideal and reality
- Operational Plans: How are you going to achieve

In the next session advocacy strategies were explained and discuss on how stakeholders analysis should be done and assess them using four essential steps in Johari Window. The diagram given below helped participants to understand known, unknown and completely unknown stakeholders for an effective advocacy plan.

4.1. NIHRN: Regional Strategic Plan


NIHRN is one of the regional networks constituted under the GFATM Round-9 HIFAJAT Project aims to bring organizations/networks and professionals working on drug treatment, HIV prevention, treatment and care to People who use drugs in 8 North Indian States. NIHRN establishment process was started in 2012.

Section – I: Aims and Objectives

The Purpose of the Strategic Plan

The purpose of the NIHRN is to guide and support regional to drug use and HIV among injecting drug users and their partners through collective harm reduction based policy and programs. The NIHRN work will involve many kinds of stakeholders and Regional Strategic Plan will guide decisions on priority interventions in their respective areas of competency and interest.

Regional Strategic Plan and its accompanying Work Plan will also serve as key tools for coordination and partnership to achieve optimal utilisation of community, regional and state specific programs. The Regional Strategic Plan is a dynamic and living document that will be subject to regular critical review, update and change.



Geographical Region

The North Indian Harm Reduction Network is consisted of the following 9 states and the union territories including

Chandigarh [Union Territory] Rajasthran Punjab Delhi NCR Himachal Pradesh Uttar Pradesh Haryana Jammu & Kashmir Uttrakhand

Vision

To secure health, dignity, social participation and economic opportunities for persons using and/or affected by drug use and HIV & HCV in the North India through a conscious and collective response of human rights and harm reduction.

Mission

- As an alliance of persons using drugs and/or affected by drug use and HIV & HCV, harm reduction practitioners and service providers, the North Indian Harm Reduction Network (IHRN) will secure access to quality health services including drug and HIV related services for drug users within a rights framework; and
- Promote the involvement and participation of drug users including those living with or at risk of HIV & HCV in program and policy development through networking, information sharing, research, policy advocacy and collective action. NIHRN will function at the state, regional, and national level in the North India.

Strategic Internal and External Goals

• NIHRN will work on both external and internal goals to make its vision and mission meaningful through active involvement of its network members.

Stretagic External Goals

- To build and strengthen its base as a regional network.
- To build a strong visibility among main stakeholders to become a recognized voice of the drug user community.
- To strengthen its advocacy role for the rights of drug users.
- To establish and strengthen partnership with the National AIDS Control Organization IDU program to help expand and scale up harm reduction services in India.

Stretagic Internal Goals

- To establish a strong and transparent governance mechanism with clearly defined roles & responsibilities of the Executive Board and members.
- To establish and maintain an effective communication system and channel for both internal and external communication and enhance its efficiency as a regional network.
- To place a fundraising outlet with systematic approach for fundraising and ensure long-term sustainability of regional network.
- To prepare a well defined action plan with a clear timeline on an annual basis for the next 1 year.
- To explore and establish membership campaign and strengthen its base as a regional network.

Strategic Aims & Objectives

A. Policy and Programs Support

- To protect and promote the health and human rights of persons using drugs and / or affected by drug use and HIV & HCV;
- To support and strengthen programmes that prevent and mitigate drug related harms and enhance wellbeing of persons using drugs and/or affected drug use and HIV & HCV across the region;
- To promote the meaningful involvement and participation of people using drugs and / or affected by drug use and HIV in policy and program development.

B. Advocacy

• To promote and advocate for access to range of prevention, care and treatment services for persons using drugs and/or affected by drug use and HIV & HCV including OST,

condoms, sterile needles, treatment for drug dependence, medical care, prophylaxis and treatment for HIV and opportunistic infections, nutrition and support services for recovery.

- To advocate for prevention, care and treatment services for hidden populations like female drug users, children using drugs and incarcerated users.
- To advocate non-discrimination and equal opportunities for persons using drugs and / or affected by drug use and HIV & HCV
- To advocate for a policy and legal environment conducive to harm reduction services and supportive of rights of persons using drugs and or affected by drug use and HIV & HCV

C. Coordination

- To create a coordinated and cogent response to drug and HIV & HCV epidemics in North India by facilitating dialogue and discussion among different stakeholders in the drug and HIV sector
- To coordinate and align prevention, care and treatment programs and services for persons using drugs and / or affected by drug use and HIV

D. Regional Networking

• To set up and strengthen networks of individual and agencies working on drug use and HIV & HCV at city, state and regional levels.

E. Capacity Building and Technical Assistance

- To build capacity of current and ex drug users to support and sustain drug and HIV & HCV related programs
- To train individuals and agencies on reduction of drug related harm including prevention, care and treatment for persons using drugs and /or affected by drug use and HIV & HCV
- To set-up standards and evolve a code of practice for drug and HIV related services across the country
- \circ $\,$ To act as a resource centre and clearing house for information, updates and policy briefs on drug use and HIV & HCV
- To promote any object of general public utility aimed at benefiting using drugs and / or affected by drug use and HIV & HCV

F. Research and Documentation

- To conduct research including rapid situation assessment, surveys, operations research, policy review on drug and HIV epidemics in the country
- To document and publish resource material including information sheets, posters, handbooks and manuals on prevention and mitigation of drug related harm

Guiding Principles

The Regional Strategic Plan identifies following guiding principles to ensuring a more effective regional response to HIV and HCV among PWIDs. Universally, the harm reduction approach is underpinned by respect for and acceptance of the user and her/his decision to use or give up drugs. In keeping with this core principle, the IHRN professes and agrees to adhere to the following values:

- 1. Access and Scaling Up: Achieving Universal access and the Millennium Development Goals on HIV/AIDS as regional commitment.
- 2. **Partnership:** The strategy will rely on collaboration between government and other public, private, non-government, community and regional entities.
- 3. **Coordination:** Mechanisms for effective and inclusive coordination will be strengthened, especially at national and township levels.

- 4. Policy and legal context: The Regional Strategic Plan will foster towards a compassion and understanding of existing legal contexts of policies and enable environments conducive to an effective response to drug use and HIV.
- 5. Evidence and results oriented programs: Building on evidence, strategic information will guide decision and action with PWIDs at higher risk and vulnerability and with the greatest needs, with an emphasis on program outcomes.
- 6. Meaningful involvement of PWHIV [MINA]: People living with HIV and affected populations; vulnerable people and local communities should participate in every aspect and at every stage of the program.
- 7. The GIPA Principle: greater involvement of people living with HIV and AIDS in all aspects of the HIV response.
- 8. Human Rights: The protection of human rights of PWIDs, those vulnerable to infection and those already infected, which also produces positive public health results against HIV



Section – II: Strategy Framework

To achieve the above objectives, the NIHRN identifies the following Strategic Priorities focused on human rights and harm reduction.

Strategic Priority # 1: Network Structure

Purpose: The first Strategic Priority is to create a foundation structure of NIHRN in consultation with the IHRN and the regional members. An Executive Board has already been elected in the regional consultation meeting held in 2013.



Strategic Priority # 2: Operationalization [Management and Implementation]

Purpose: For operationalization and implementation of Network related activities, the Regional Strategic Framework identifies the following steps:

- Setting up centrally located NIHRN Secretariat;
- Establishing a clearly defined communication channel; •

- Delegation of roles and responsibilities among state members [organizations and individuals];
- Setting up documentations;
- Identification of various ways of enhancing its visibility;
- Identification of relevant authorities and organizations for networking and partnership;

Strategic Priority # 3: Promote Harm Reduction Policy and Programs

Purpose: In order to promote harm reduction policy and programs in the region, NIHRN will undertake the followings.

Core Activities:

- Advocacy with national, regional, state and district level authorizes;
- Undertake Advocacy initiatives to enhance support from/among medical, social, legal, and social justice system.
- Sharing information related to ongoing harm reduction interventions, debates and dialogue at national, regional and international levels.
- Co-ordinate and align programmes and services for people using drugs and/or affected by drug use.
- Facilitate Policy debates and dialogue on drug use and HIV.
- Capacity building for the individuals and organizations working as partner of Targeted Interventions for IDUs in the region;
- Conduct relevant 'action research' to support harm reduction programs;
- Act as a regional resource centre and clearinghouse for updated information on drug use and HIV & HCV in the region;

Strategic Priority # 4: Resource Mobilization

Purpose: The Regional Strategy Framework identifies need of collective resource mobilization efforts and system to strengthen NIHRN and its visibility in the northern states of India, these include.

Core Activities:

- Revenue collected through Membership fee;
- Setting up fundraising campaigns and outlets;
- Exploring available national and state specific schemes relevant to NIHRN's presence and objectives;

Strategic Priority # 5: Community Mobilization

Purpose: The Regional Strategy Framework emphasizes on community engagement participation and mobilization through the followings endeavors.

Core Activities:

- Sensitization of relevant audience on core issues of drug use and HIV & HCV;
- Thematic awareness about NIHRN work in the region;
- Dissemination of newsletters, brochure and key information through NIRHN eGroup, NIRHN Facebook Community Page and using mailing lists;
