Scottish Drugs Forum is delighted to invite you to attend our Cannabinoid Masterclass by Dr Adam Winstock.

Cannabis, and particularly synthetic cannabinoids, have become a focus of concern in a range of settings, including prisons, young people's services, drug treatment and mental health services. At the same time, there has been a contrary move emphasising reported benefits of use and steps towards more tolerant law enforcement.

Dr Winstock is well-placed to describe the extent and nature of cannabinoid use, issues that arise for users, and the support and treatment of users in both clinical and non-clinical settings.

This masterclass will cover a range of issues including:

- Prevalence of cannabis and synthetic cannabinoid use
- Issues users face as a consequence of cannabis / synthetic cannabinoid use
- Self-reported harms of cannabis and synthetic cannabinoid users
- Harm reduction and advice for users
- Harms encountered in clinical work with cannabis / synthetic cannabinoid users
- Links and relationships with mental health issues
- Patient-perceived self-medication with cannabis / synthetic cannabinoids
- Treatment modalities with a cannabis /synthetic cannabinoid-using patient

Dr Adam R Winstock Bsc MSc MRCP MRCPsych FACHAM MD is a Consultant Addiction Psychiatrist and also Honorary Senior Lecturer at the Institute of Psychiatry, Kings College London.

Adam founded and is Director of the Global Drug Survey, which has run the world's biggest annual survey of drug use trends since 2011. He is the architect of online and smart phone apps - the Drugs Meter and Drinks Meter, and creator of the free online harm reduction guide, the Global Drug Survey Highway Code.

Adam has authored over 100 research papers, book chapters and monographs and worked extensively across public health services. A user-focused clinician promoting transparency in clinical decision making he is also a highly accomplished teacher and trainer

Having studied medicine at Middlesex Hospital, Adam qualified in 1991 after taking a year out to complete a Psychology degree. His general physician training was completed in London and Bath, and he gained Membership of the Royal College of Physicians (MRCP) in 1994.

He then trained as a psychiatrist at the Maudsley becoming a Member of the Royal College of Psychiatrists in 1997. He spent four years as a Clinical Lecturer at the Institute of Psychiatry, obtaining his Masters in 1999 and his Certificate of Completion of Specialist Training (CSST) in general adult psychiatry and addiction psychiatry in 2001

In 2002, Adam took up the roles of Clinical Director for the South West Sydney Area Health Service Drug and Alcohol Service and Senior Lecturer at the National Drug and Alcohol Research Centre, University of New South Wales. He completed his Doctor of Medicine (MD) qualification in 2008. During his years in Australia, Dr Winstock was an active researcher and teacher, and was involved with state and national advisory committees.

He returned to the UK in 2009.
