#### **Terms of Reference**

#### 1. Introduction

**Support. Don't Punish** is a global advocacy campaign to raise awareness of the harms caused by the criminalisation of people who use drugs. <sup>1</sup> The campaign was created in 2013, in acknowledgement of the need to change laws and policies which impede access to harm reduction interventions, and to promote respect for the human rights of people who use drugs.

The campaign aims to:

- Change laws and policies which impede access to harm reduction interventions for people who use drugs.
- Raise awareness about the need to stop criminalising ('punishing') people for using drugs.
- Raise awareness about the need for greater funding and attention for essential health services and other 'support' for people who use drugs.
- Promote respect for the human rights of people who use drugs.
- Engender public support for drug reform.

The campaign attempts to mobilise public action for policy change. It was originally conceived by the International Drug Policy Consortium (IDPC),<sup>2</sup> the International HIV/AIDS Alliance,<sup>3</sup> Harm Reduction International (HRI),<sup>4</sup> and the International Network of People who Use Drugs (INPUD)<sup>5</sup> – as part of the Dutch Government-funded 'Community Action on Harm Reduction' (CAHR) project.<sup>6</sup>

#### 2. Evaluation Purpose

IDPC is looking for an experienced consultant to conduct a 360-degree evaluation of the first two years of the **Support. Don't Punish** campaign – from January 2013 until December 2014. The purpose of the evaluation will be to:

- 1. Document the outcomes and impacts of the campaign activities such as the website, social media accounts, the Global Day of Action, and the Interactive Photo Project in order to identify lessons that can improve future plans.
- Recommend communication and campaigning strategies that can increase the impact of future campaign efforts between now and the UN General Assembly Special Session (UNGASS) on drugs in 2016<sup>7</sup> – with a particular focus on better media engagement and how to reach new partners and stakeholders, including in new countries.
- 3. Propose measurable indicators and low-threshold means of verification for future evaluations of the campaign.

#### 3. Data Collection and Methodology

The evaluation methodology could, as an example, include: desk reviews of documents; a thorough mapping of stakeholders and potential partners; in-depth analysis of media and social media reach and coverage; key informant interviews; online interviews with participants and stakeholders; focus group discussions; internet-based surveys; and participative case studies.

A draft methodological outline should be submitted by Monday 19th January.

A multi-lingual methodology would be preferred, to make the evaluation as inclusive as possible. However, all information and material should be submitted to IDPC in English, with arrangements made for translations if needed. Any original material (such as transcripts of interviews) should also be provided in their original language, if not English.

#### 4. Expected Outcomes of the Evaluation

The final evaluation report should be presented as a Microsoft Word document, in English, and with a maximum of 20 pages (including any graphs and figures). Additional Annexes (including original study materials and translations, as appropriate) may also be added in addition to the 20 page limit.

While there is no fixed structure for the final evaluation report, it should cover (among other things):

• A comprehensive mapping of campaign actors, participants and stakeholders, and of the main results achieved to date.

- Feedback on the perceptions of campaign actors, participants and stakeholders in terms of the campaign aims, activities, approach and communications channels – with recommendations for future changes.
- An assessment of the effectiveness of the available campaign tools such as the website, social media accounts, template media releases, guidelines, videos and other resources.
- An assessment of the overall impact and relevance of the campaign messaging and brand coherence.
- An evaluation of the impact of the main campaign activities particularly the Global Day of Action and the Interactive Photo Project at the local, regional and international levels.
- Recommendations for future campaign activities and fundraising opportunities, with a
  particular focus on the UN General Assembly Special Session (UNGASS) on drugs in 2016.
  Recommendations should ideally be tailored to different scenarios with respect to the available
  staff and financial resources available.

#### 5. Terms and Timeframe

The consultancy will be for a two month period, from Monday 12th January with a final report submitted before Monday 16th March.

The total fee for the consultancy is US\$ 10,000. The full amount will be paid upon delivery of the final report and submission of an invoice.

#### 6. Person Specification

- Demonstrable experience and expertise in conducting evaluations of campaigns focusing on institutional and/or change.
- Demonstrable knowledge in international relations, public health, sociology and/or media analyse.
- Awareness of, and interest in, global and regional drug policy debates.
- Excellent written and verbal communication skills with oral and written fluency in English. Additional languages highly desirable.
- Excellent interpersonal skills and an ability to communicate effectively with a wide range of audiences in terms of status, geography and cultural background.
- Committed team player with excellent organisational skills and the ability to plan, prioritise and manage time and varied workloads.
- Strong organisation skills and IT skills.

# ANNEX 2: Support. Don't Punish global campaign evaluation methodology

## IDPC Support. Don't Punish Global Campaign Evaluation Methodology

The proposed methodological approach, and components, to conduct the 360-degree evaluation of the first two years of the 'Support. Don't Punish' campaign – from January 2013 until December 2014 - includes the following:

#### 1. Desk Review

This will include, but is not limited to, planning and implementation materials, meeting notes, progress reports, and materials available on the IDPC and related websites. The desk review will also seek to demonstrate how the campaign supported the broader objectives of the Community Action on Harm Reduction (CAHR) project from which the campaign was funded.

#### 2. Case Studies

It is proposed that case studies will be developed to explain why certain locations did, and did not, undertake campaign activities on the Day of Action, 26 June, in 2013 and/or 2014, respectively. The countries to be included as case studies include one or more of the following:

- Colombia
- France
- India
- Indonesia (Jakarta)
- Lebanon
- Ukraine (Kiev, related to Russia's annexation of Crimea)
- Zimbabwe

The case studies will include participation by stakeholders with French and Spanish languages and, therefore, will not be solely reliant on people/organisations with only English language skills.

#### 3. Questionnaire

A short questionnaire will be developed and emailed to a random selection of people/organisations that have been involved in the campaign. The objective of the questionnaire is to ascertain:

- a) The reason why the person/organisation decided to become involved in the campaign;
- b) The extent to which the support provided by IDPC was of use;

- c) What materials provided by IDPC were used or customised, or were of most use; and what materials did you/your organisation or partners develop for the event, and why?
- d) What results have emanated from the Global Day of Action, if any, at the local, sub-national and/or national level?
- e) What plans does the person/organisation have for future campaigning in light of the forthcoming UNGASS 2016?

#### 4. Key Informant Interviews

Key informant interviews (KII) will be help through the use of skype with participants from a range of countries selected at random. It is likely that the KII's will be those people who respond to the questionnaire and are involved in the development of the case studies outlined above. Interviews will also be conducted with staff of UNODC HQ, from the Alliance Secretariat and from Alliance Ukraine, as well as from INPUD and HRI

#### 5. Media review and analysis

A review of global media coverage of the Day of Action in 2013 and again in 2014 will be undertaken to ascertain the key messages delivered by media organisations as a result of the activities in various countries.

All information and materials will be submitted to IDPC in English, with arrangements made for translations as needed. All original material (such as transcripts of interviews) will also be provided in their original language, if not English.

We felt it was necessary as the UNGASS will be taking place in New York, so this was an opportunity to mobilize people beforehand. In 2013, the timing was bad. We had an intern who could help organize it in 2014. It's not lack of interest but lack of person power.
18.	Zimbabwe	Our organisation decided to be involved in this programme because of the high prevalence on illicit drugs in Zimbabwe. We wanted to raise the conscientiousness of the community and the government on the drug problem and also the inadequacies of the drug policy in Zimbabwe. This programme started in March of 2014 when we became aware of the programme.
