COURSE SUMMARY

In this course, learners will understand how to describe the data analytics lifecycle and set out details, activities and roles at each stage through real-world examples. They will learn how to design effective project briefs which communicate expectations to stakeholders, as well as gather and elicit requirements. They will then identify business specific rules related to datasets and data characteristics that will influence project design and analysis. Learners will also be able to describe the key characteristics of different data formats and how to work with them, including file extensions, data types and data structures.

COURSE AIMS

- Train learners to apply the data analytics lifecycle, based on the Cross-Industry Standard Process for Data Mining (CRISP-DM) to support the planning and evaluation of data related projects.
- Train learners to gather and elicit requirements to build a project brief and develop a stakeholder management plan.
- Enable learner to identify common data sources and understand how they are used in data analysis.

During seminars, applied learning seminars and one to one coaching, questioning and quizzing are used as formative assessment. These reviews are an opportunity to discuss progress to date both in their role and on the degree programme.
