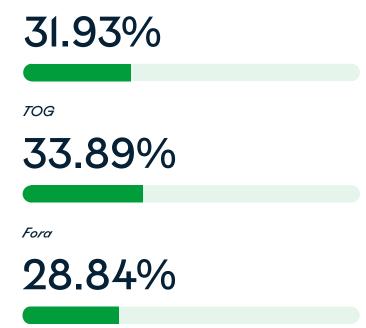

Mean hourly pay gap

The mean hourly pay gap is the difference between the average hourly pay paid to male employees and female employees. Hourly pay includes salary and commission paid in April 2023.







All companies with 250 or more employees in the UK must now publish their own gender pay gap figures annually, by comparing the average pay for all men to the average pay for all women, without accounting for job type, tenure, location, or performance ratings. It's important to understand that the gender pay gap is not a like-for-like comparison of what women and men are paid when working in the same role or at the same level. This is known as pay equality and is a matter of law. At The Office Group, we pay women and men equally for equal work.

Promotions

Through change we made great progress between April 2022 and April 2023 and promoted 98 employees, of which 64 were women.

Reward

We continued to focus on our reward philosophy and framework, drawing focus to our Member Host population, who are majority female, and ensuring our salary bandings were competitive and fair. We are currently working with an external reward consultant to review our entire package in order to help bring transparency to our bandings and have invested in a Reward Manager to provide accurate data for key decision making.

DE&I Committee Relaunch:

We have relaunched our committee to help ensure there is a platform for two-way feedback on diversity and inclusion to support consistent growth and improvement. We want to help challenge, create change, and champion what is important to employees so that this is represented and celebrated both internally and externally.



Apprenticeships

Since we launched apprenticeship opportunities in 2023, we have 16 employees enrolled, 12 of which are women and we have invested \pounds 69,000 from our levy fund.

Identifying opportunities

We have created a new partnership with an independent third party to provide honest feedback on our current initiatives and to challenge our ways of working to ensure decision making is fair, void of biases and our working environment is inclusive.
