What is the purpose of this update?

This document tells you how the Kernel S&P 500 (Unhedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The Kernel S&P 500 (Unhedged) Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P 500 (NZD) Index.

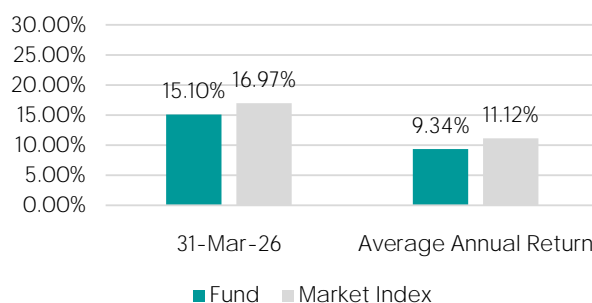

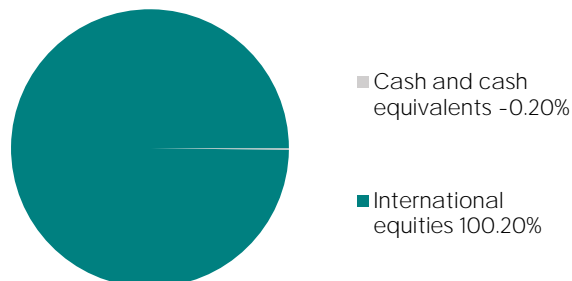

Notes

¹ Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 129 year(s) 11 month(s) of market index returns.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 April 2025 and did not make any further contributions. On 31 March 2026, Emma received a return after fund charges were deducted of \$1,661 (that is 16.61% of her initial \$10,000). This gives Emma a total return after tax of \$1,510 for the period.
