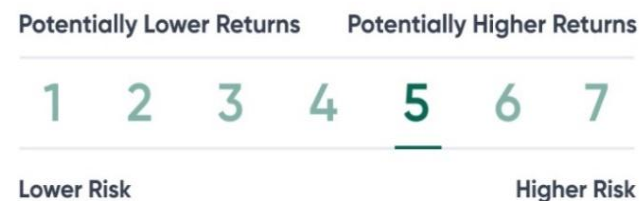
Description of this fund

The Kernel Emerging Markets Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P Emerging BMI (NZD) index.

What are the risks of investing?

Risk indicator for the Kernel Emerging Markets Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way. What fees are investors charged?

Investors in the Kernel Emerging Markets Fund are charged fund charges. In the year to 31 March 2025 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

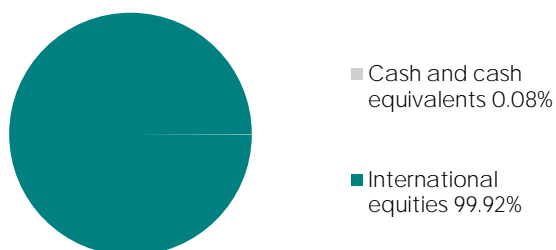
Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$2,175 (that is 21.75% of her initial \$10,000). This gives Emma a total return after tax of \$2,022 for the period.
