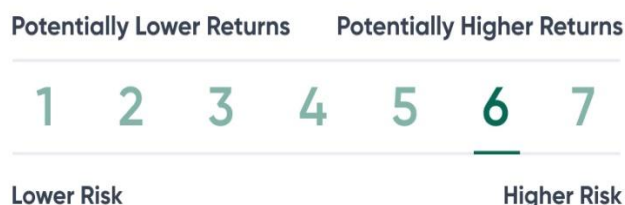
#### Description of this fund

The Kernel S&P 500 (Unhedged) Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P 500 NZD Index.

#### What are the risks of investing?

Risk indicator for the Kernel S&P 500 (Unhedged) Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. #### What fees are investors charged?

Investors in the Kernel S&P 500 (Unhedged) Fund are charged fund charges. In the year to 31 March 2025 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

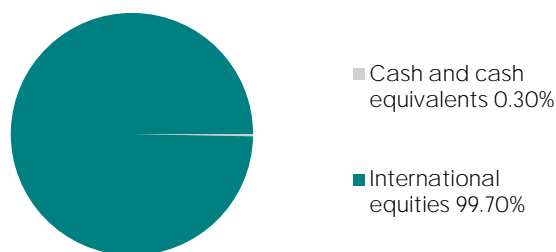
#### Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$1,447 (that is 14.47% of her initial \$10,000). This gives Emma a total return after tax of \$1,298 for the period.
