What is the purpose of this update?

This document tells you how the Kernel Cash Plus Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel Cash Plus Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the Bloomberg NZ Bond Bank Bill Index.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

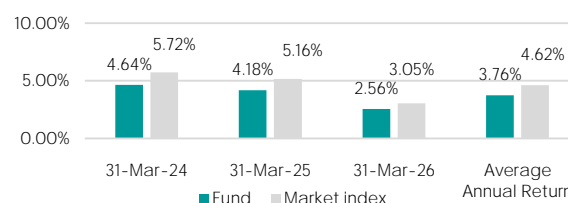

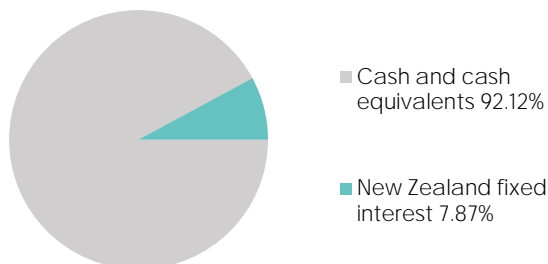
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Notes

¹ Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year(s) 8 month(s) of market index returns.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 April 2025 and did not make any further contributions. On 31 March 2026, Emma received a return after fund charges were deducted of \$358 (that is 3.58% of her initial \$10,000). This gives Emma a total return after tax of \$256 for the period.
