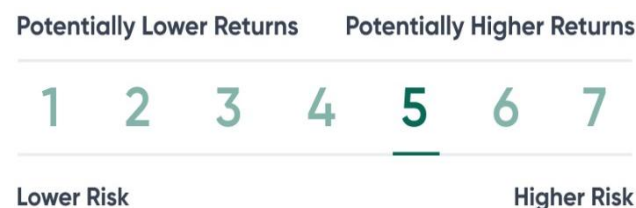
Description of this fund

The Kernel Global ESG Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P World Net Zero 2050 Paris-Aligned ESG ex non-pharma Animal Testing (PAB Ex AT) (NZD) Index.

What are the risks of investing?

Risk indicator for the Kernel Global ESG Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

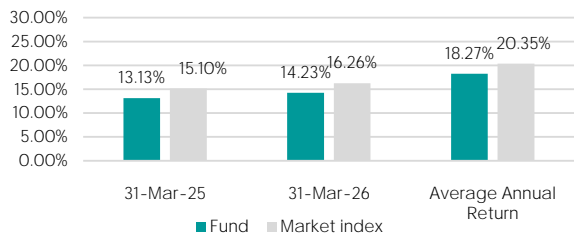

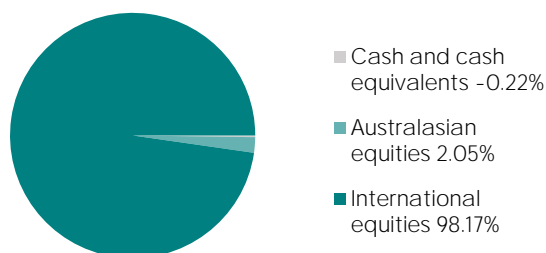
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 April 2025 and did not make any further contributions. On 31 March 2026, Emma received a return after fund charges were deducted of \$1,573 (that is 15.73% of her initial \$10,000). This gives Emma a total return after tax of \$1,423 for the period.
