#### Fund update for the quarter ended 31 March 2026

This fund update was first made publicly available on 1 May 2026.

#### What is the purpose of this update?

This document tells you how the Kernel NZ Small & Mid Cap Opportunities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Kernel NZ Small & Mid Cap Opportunities Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Emerging Opportunities Index.

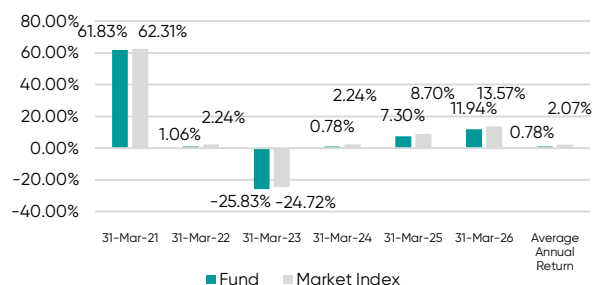
#### How has the fund performed?

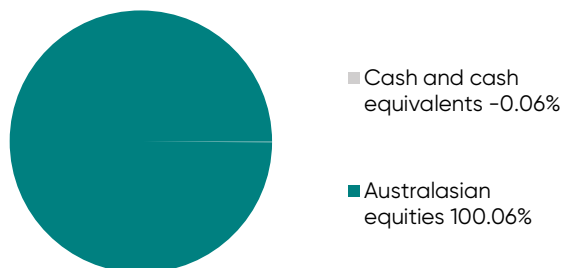
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

## Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 April 2025 and did not make any further contributions. On 31 March 2026, Emma received a return after fund charges were deducted of \$1,323 (that is 13.23% of her initial \$10,000). This gives Emma a total return after tax of \$1,194 for the period.
