What is the purpose of this update?

This document tells you how the Kernel World ex-US (NZD Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P World Ex-U.S., Controversial Weapons and Tobacco (NZD Hedged) Index.

What are the risks of investing?

Risk indicator for the Kernel World ex-US (NZD Hedged) Fund :



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. Small differences in fees and charges can have a big impact on your investment over the long term.

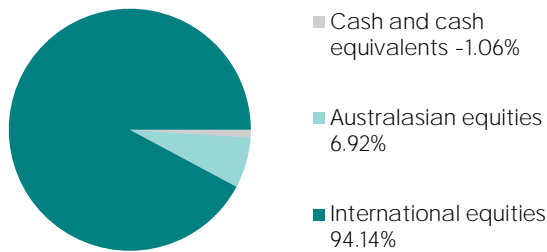
Example of how this applies to an investor

Emma had \$10,000 in the fund on 13 August 2025 and did not make any further contributions. On 31 March 2026, Emma received a return after fund charges were deducted of \$960 (that is 9.6% of her initial \$10,000). This gives Emma a total return after tax of \$881 for the period.
