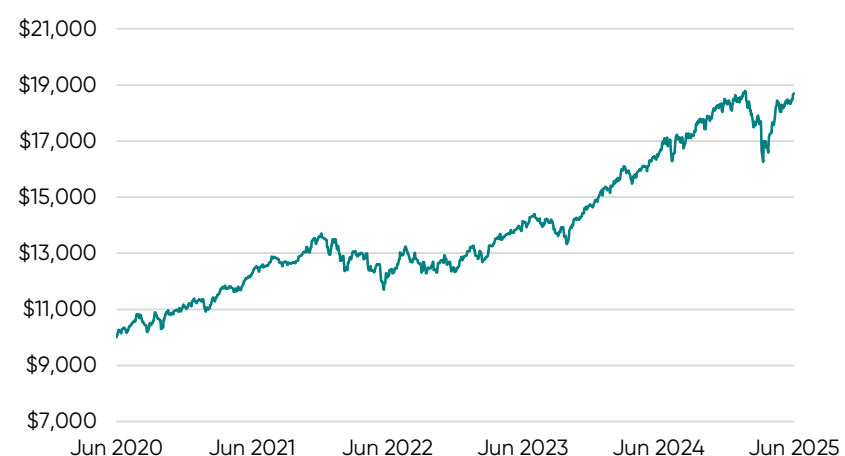

## Index value chart

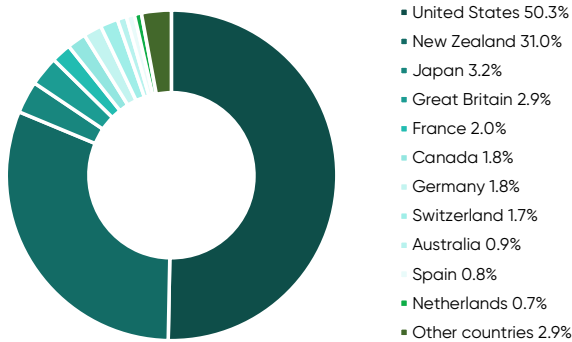
**\$10,000 invested 5 years ago<sup>6</sup>:** \$18,700



— High Growth composite index

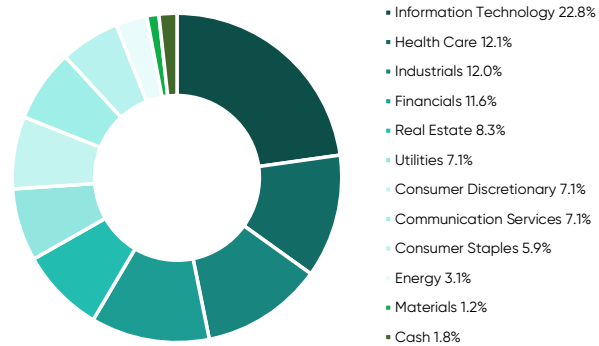
## Where does the fund invest?
