Fund update for the quarter ended 31 December 2025

This fund update was first made publicly available on 4 February 2026.

What is the purpose of this update?

This document tells you how the Kernel Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel Conservative Fund is designed for lower-risk investors, with a majority of its assets allocated to fixed income assets, such as bonds and cash equivalents. The fund provides broad diversification and suits those seeking capital preservation and income, such as retirees or short-to-medium-term investors. Designed as a 30% growth / 70% income option by investing mainly in several of the other Kernel funds.

What are the risks of investing?

Risk indicator for the Kernel Conservative Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Investors in the Kernel Conservative Fund are charged fund charges. In the year to 31 March 2026 these are expected to be:

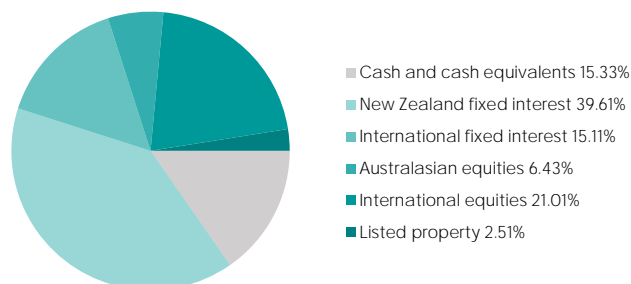
Example of how this applies to an investor

Emma had \$10,000 in the fund on 13 August 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$330 (that is 3.3% of her initial \$10,000). This gives Emma a total return after tax of \$269 for the period.

Currency hedging

The fund had a 7.49% allocation to the Kernel Global Infrastructure (NZD Hedged) Fund which was 100.23% hedged back to New Zealand dollars, a 14.97% allocation to the Kernel US Bond Fund which was 100.76% hedged back to New Zealand dollars, a 3.03% allocation to the Kernel World ex-US (NZD Hedged) Fund which was 100.49% hedged back to New Zealand dollars, a 2.53% allocation to the Kernel Global Property (NZD Hedged) Fund which was 101.15% hedged back to New Zealand dollars, and a 3.99% allocation to the Kernel S&P Global 100 (NZD Hedged) Fund which was 100.72% hedged back to New Zealand dollars.
