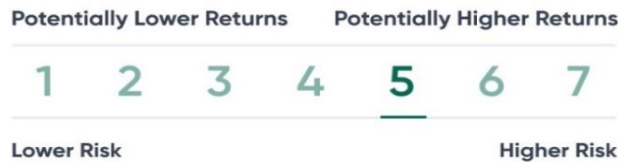
### Description of this fund

The Kernel Emerging Markets Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P Emerging BMI (NZD) Index.

### What are the risks of investing?

Risk indicator for the Kernel Emerging Markets Fund:

### What fees are investors charged?

Investors in the Kernel Emerging Markets Fund are charged fund charges. In the year to 31 March 2025 these were:

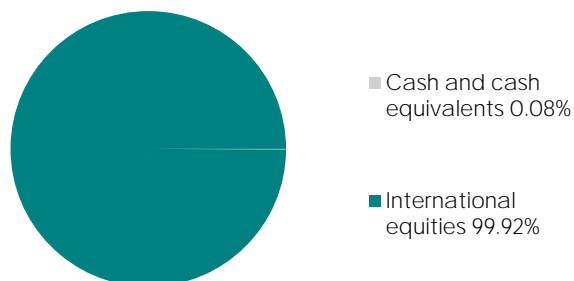
### Example of how this applies to an investor

Emma had \$10,000 in the fund on 11 November 2024 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$2,510 (that is 25.1% of her initial \$10,000). This gives Emma a total return after tax of \$2,337 for the period.
