Kernel Global Property (NZD Hedged) Fund

Fund update for the quarter ended 31 December 2025

What is the purpose of this update?

This document tells you how the Kernel Global Property (NZD Hedged) Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 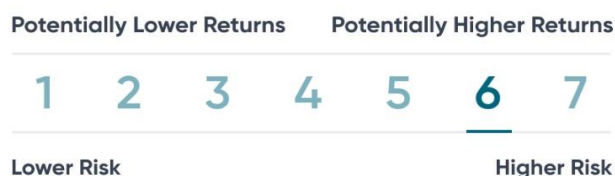
Description of this fund

The Kernel Global Property (NZD Hedged) Fund invests in globally listed real estate investment trusts (REITs) and real estate operating companies (REOCs) traded globally. Company weights are modified to tilt a higher investment to companies with stronger ESG characteristics as calculated by GRESB. The Fund targets a position of being fully hedged back to New Zealand dollars. It is designed to track the Dow Jones Global Select ESG Tilted RESI NZD Hedged Index.

What are the risks of investing?

Risk indicator for the Kernel Global Property (NZD Hedged) Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

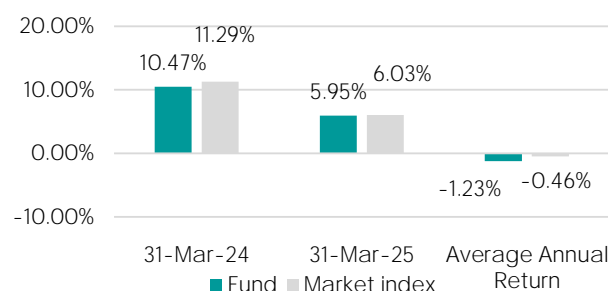
How has the fund performed?

Investors in the Kernel Global Property (NZD Hedged) Fund are charged fund charges. In the year to 31 March 2025 these were:

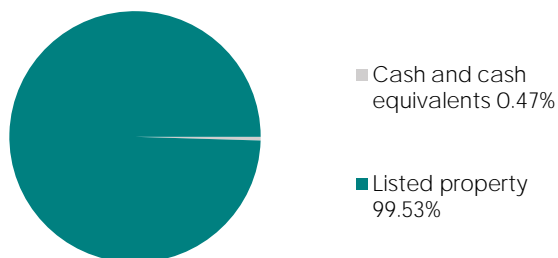

Notes

¹ Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year(s) 4 month(s) of market index returns.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$724 (that is 7.24% of her initial \$10,000). This gives Emma a total return after tax of \$477 for the period.
