What is the purpose of this update?

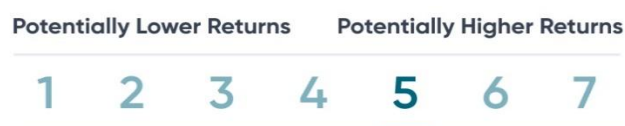
Description of this fund

The Kernel Global Infrastructure (NZD Hedged) Fund is designed to provide diversified exposure to pure-play infrastructure companies domiciled globally. The index covers all sectors of the infrastructure market. To be included in the index, a company must derive at least 70% of cash flows from infrastructure lines of business. The Kernel's Hedged Global Infrastructure Fund is also hedged to New Zealand Dollar. It is suitable for an investor with an investment time horizon of at least 5 years.

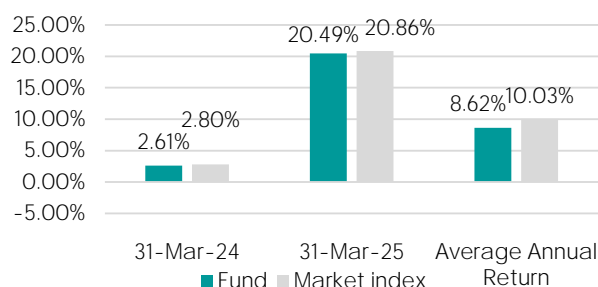

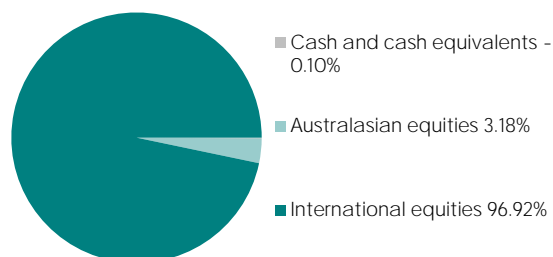
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Notes

¹ Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year(s) 11 month(s) of market index returns.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$1,005 (that is 10.05% of her initial \$10,000). This gives Emma a total return after tax of \$795 for the period.
