What is the purpose of this update?

This document tells you how the Kernel NZ 50 ESG Tilted Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel NZ 50 ESG Tilted Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX 50 Portfolio ESG Tilted Index.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

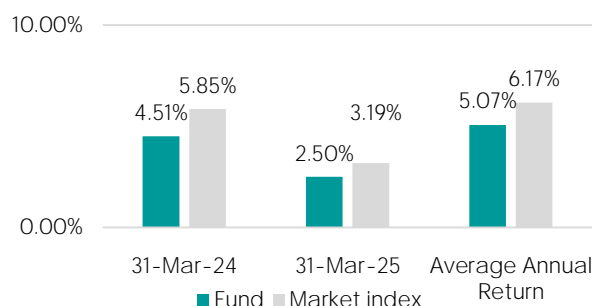

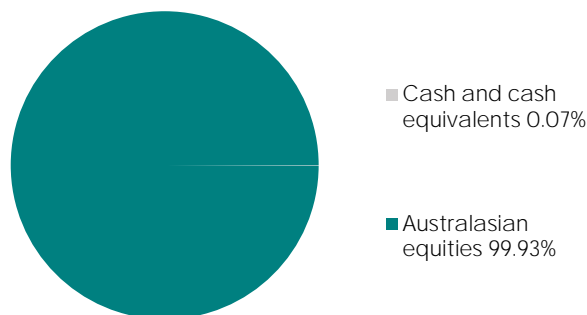
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Actual investment mix

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$1,011 (that is 10.11% of her initial \$10,000). This gives Emma a total return after tax of \$915 for the period.
