#### What is the purpose of this update?

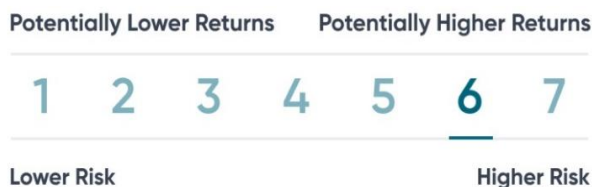
#### Description of this fund

The Kernel S&P 500 (NZD Hedged) Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P 500 Dynamic Hedged Index (NZD).

#### What are the risks of investing?

Risk indicator for the Kernel S&P 500 (NZD Hedged) Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

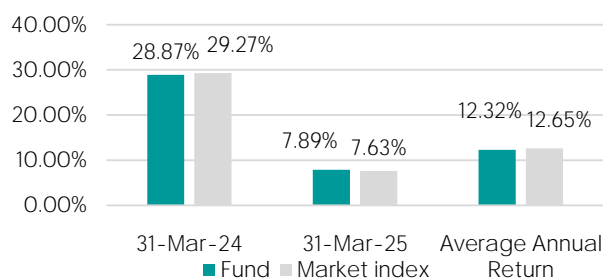

Investors in the Kernel S&P 500 (NZD Hedged) Fund are charged fund charges. In the year to 31 March 2025 these were:

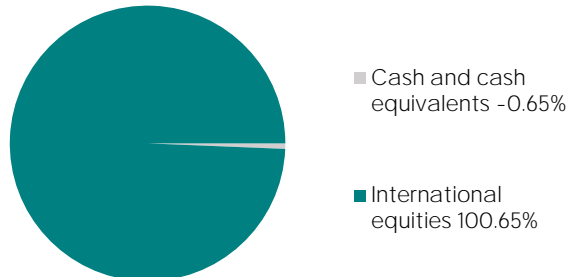

## Notes

<sup>1</sup> Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year(s) 4 month(s) of market index returns.

## Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$1,575 (that is 15.75% of her initial \$10,000). This gives Emma a total return after tax of \$1,306 for the period.
