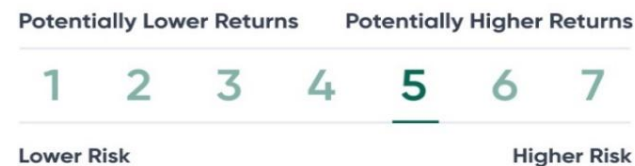
Description of this fund

The Kernel NZ Small & Mid Cap Opportunities Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX Emerging Opportunities Index.

What are the risks of investing?

Risk indicator for the Kernel NZ Small & Mid Cap Opportunities Fund:

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

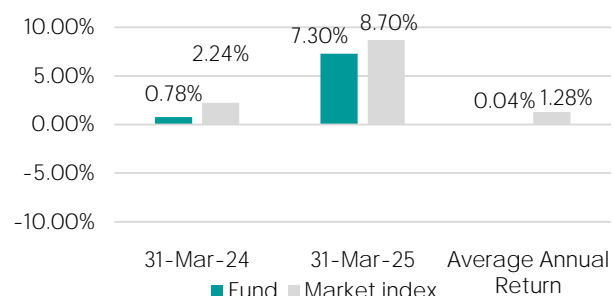

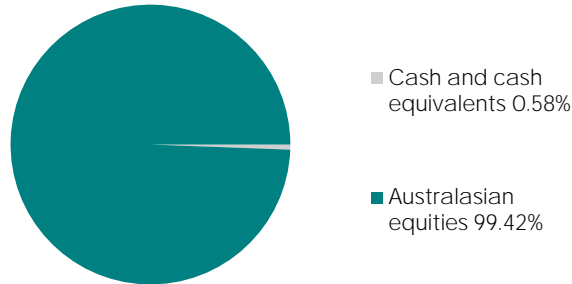
Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$2,065 (that is 20.65% of her initial \$10,000). This gives Emma a total return after tax of \$1,943 for the period.
