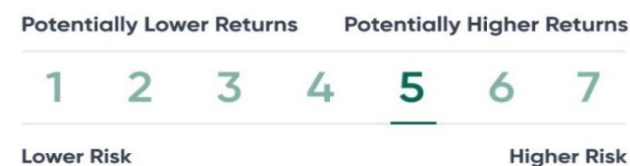
Description of this fund

The Kernel World ex-US (NZD Hedged) Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P World Ex-U.S., Controversial Weapons and Tobacco (NZD Hedged) Index.

What are the risks of investing?

Risk indicator for the Kernel World ex-US (NZD Hedged) Fund :



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in the Kernel World ex-US (NZD Hedged) Fund are charged fund charges. In the year to 31 March 2026 these are expected to be:

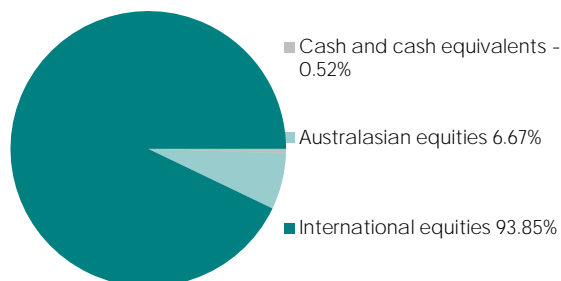
Example of how this applies to an investor

Emma had \$10,000 in the fund on 13 August 2025 and did not make any further contributions. On 31 December 2025, Emma received a return after fund charges were deducted of \$900 (that is 9% of her initial \$10,000). This gives Emma a total return after tax of \$855 for the period.
