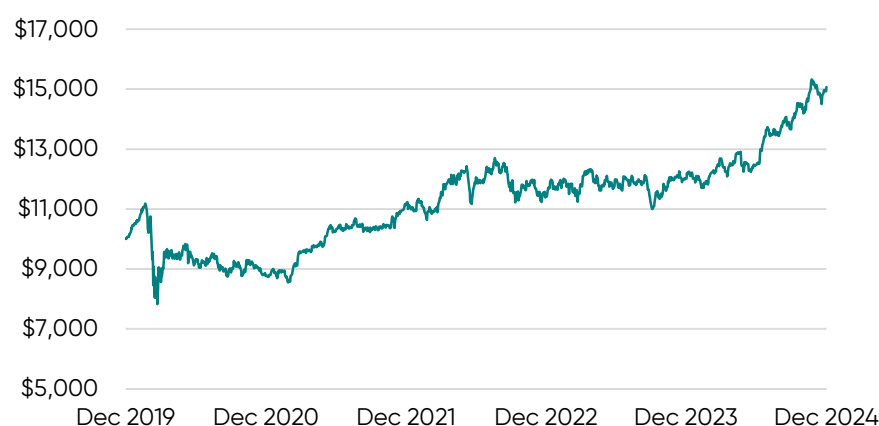

Index value chart

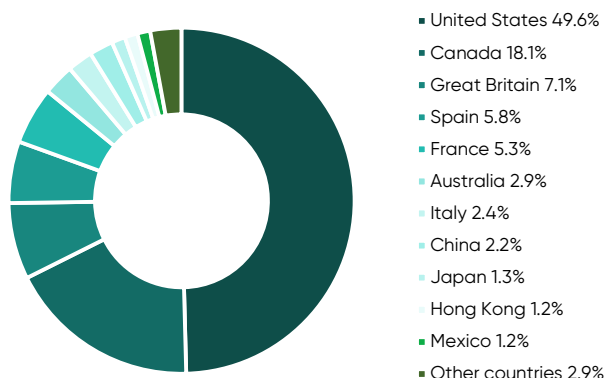
\$10,000 invested 5 years ago⁶: \$15,070



— Dow Jones Brookfield Global Infrastructure Gross Total Return Index (NZD)

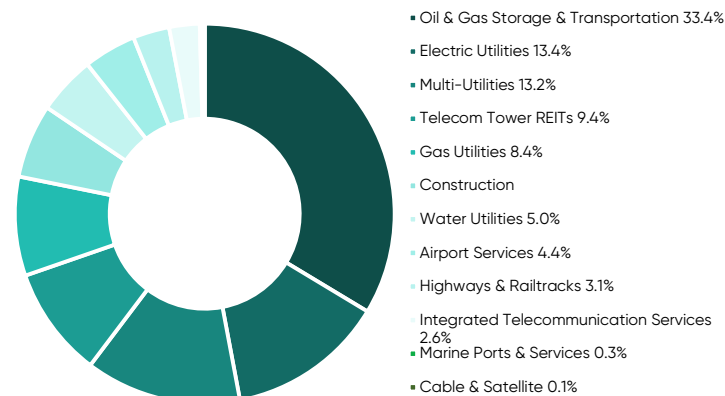
