

PROJECT CONNECT EVENT SCHEDULED

Project Connect, originally scheduled for March 7, has been rescheduled to March 21. It will take place from 9 a.m. to 2 p.m. at Family Event Center, First Presbyterian Church, 702 E. Cottonwood Lane, Casa Grande.

About 40 agencies will set up tables to discuss their services. The public is invited to learn about these agencies and their offerings. The goal is to simplify the process for individuals and families with limited income or those experiencing, or at risk of experiencing, homelessness to connect with essential services.

Free mammograms will also be available. Appointments for the mammograms can be made with Nallely Chavez at CAHRA 520-466-1112.

For many facing limited income, navigating various organizations can be challenging. Visits may need to fit around work shifts or involve finding transportation. Gathering all these resources in one place saves time and reduces stress, making the process significantly easier.

The participating agencies aim to provide information on meeting their needs and offer long-term solutions. They will meet with guests one-on-one, giving them direct attention and actively listening to their needs. Additionally, guests may receive important documents such as driver's licenses and contact info where to apply for birth certificates or social security cards.

Vendors or agencies wishing to participate are encouraged to sign up by contacting Nallely by phone or email nchavez@cahra.org. Arizona Complete Health is a major sponsor of the event and is also sponsoring the mammograms. Credit also goes to the agencies whose staff work on the event. They are CAHRA, United Way of Pinal County, City of Casa Grande Community Development Department and St. Anthony's Catholic Church.

SOCIAL SECURITY AND SCAM AWARENESS

Social Security imposter scams continue to be widespread across the United States. Scam-

mers use tactics to deceive you into providing sensitive information or money. If you receive a suspicious letter, text, email, or call, do not respond.

We will NEVER:

- Text or email images of an employee's official government identification.
- Suspend your Social Security number.
- Threaten you with arrest or other legal action unless you immediately pay a fine or fee.
- Require payment by retail gift card, wire transfer, internet currency, or cash by mail.
- Promise a benefit increase or other assistance in exchange for payment.
- Mail or email "official" letters or reports containing your personal information.

We only send text messages in limited situations, including:

- When you have subscribed to receive updates and notifications by text.
- As part of our enhanced security when accessing your personal my Social Security account.

If you owe money to us, we will mail you a letter with payment options and appeal rights. Social Security employees do contact the public by telephone for business purposes. Ordinarily, the agency calls people who have recently applied for a Social Security benefit, are already receiving payments and require an update to their record or have requested a phone call from the agency. If there is a problem with a person's Social Security number or record, Social Security will typically mail a letter.

We encourage you to report suspected Social Security imposter scams — and other Social Security fraud — to the OIG's website at oig.ssa.gov/report. You can find more information about scams at www.ssa.gov/scam. Please share this information with your friends, family, and colleagues to help spread awareness about Social Security imposter scams.

SOCIAL SECURITY'S SCHOOL EMPLOYEES AND SURVIVORS BENEFITS TOOLKITS

We've released new resources to help you better understand Social Security benefits. We've designed easy-to-use toolkits to provide education about our programs for chil-



dren and our benefits for families after the death of a loved one. Our toolkits (**School Professional** and **Survivor Benefits**) are downloadable PDFs that include ready-to-go communications, such as sample email blasts, newsletter articles, handouts, and social media posts.

The School Professional Toolkit at

www.ssa.gov/marketing/assets/materials/toolkit-ss-benefits-and-ssi-payments-for-children.pdf is for teachers, school counselors, and other educators. The purpose of this toolkit is to educate parents and guardians about the financial help we provide. We make payments to students with disabilities and to those who have experienced the loss of a parent or have a parent who is receiving retirement or disability benefits.

The toolkit discusses:

- Eligibility requirements.
- How to apply.
- How to respond to requests for school records and forms.
- Evidence we need from school professionals to determine whether a child with a disability may be eligible for SSI.

The Survivors Benefits Toolkit at

www.ssa.gov/marketing/assets/materials/toolkit-ss-survivors-benefit.pdf is for funeral homes, care facilities, and other organizations working with people who have lost a loved one. This toolkit increases awareness about survivors benefits for eligible family members. We make monthly payments to surviving spouses, minor children, adult children with disabilities, and dependent parents of workers who paid Social Security taxes before they died. The toolkit discusses:

- Eligibility requirements.
- · How to apply.
- Evidence we need to process applications.

SOCIAL SECURITY ANNOUNCES NEW RESOURCES FOR SICKLE CELL WARRIORS



Are you a sickle cell warrior or do you know someone with sickle cell disease? At Social

Security, we're committed to supporting sickle cell warriors and the people who care for them. An adult or child with sickle cell disease may be eligible for benefits through Social Security Disability Insurance (SSDI) or Supplemental Security Income (SSI).

SSDI benefits are based on earnings and are not subject to income and resource limits. SSI is a needs-based program that provides payments to people who are age 65 or older, blind, or have a disability and have limited income and resources.

STATEMENT FROM LEE DUDEK, ACTING COMMISSIONER, ABOUT COMMITMENT TO AGENCY TRANSPARENCY AND PROTECTING BENEFITS AND INFORMATION

"I am honored and humbled to be appointed Social Security's Acting Commissioner pending Senate confirmation of Frank Bisignano to be SSA's next Commissioner. I accepted the position because I strongly believe in the agency's mission and the hardworking and dedicated employees who serve America.

Openness, transparency, and accountability are tenets of good government and demonstrating them begins with me. To that end, I want to share several points to reassure the public and our employees that I will continue SSA's history of transparency and protecting benefits and information.

I have experienced firsthand the impact that Social Security benefits have on family's lives. Since joining SSA in 2009, I have had the opportunity to work across multiple parts of SSA, and especially appreciated my experiences working alongside frontline employees in the Cambridge, MA field office.

Transparency begins with me: My first call as Acting Commissioner was to our Office of the Inspector General (OIG) to provide them an opportunity to oversee and review any and all agency activities, including my actions past, present, and future. I trust in the People to be informed, and I am making available my agency personnel and performance files to the OIG.

The law matters and we will follow it: I have invited the Government Accountability Office, the non-partisan and independent agency that works for Congress, to observe how we conduct agency business.

Good government means finding ways to do better: The Department of Government Efficiency, known as DOGE, is a critical part of President Trump's commitment to identifying fraud, waste, and abuse, and better ways for the government to function to support its people. I want to be very clear about the DOGE personnel who are now working at Social Security.

- Our continuing priority is paying beneficiaries the right amount at the right time, and providing other critical services people rely on from us.
- DOGE personnel CANNOT make changes to agency systems, benefit payments, or other information. They only have READ access.
- DOGE personnel do not have access to data related to a court ordered temporary restraining order, current or future.
- DOGE personnel must follow the law and if they violate the law they will be referred to the Department of Justice for possible prosecution

I also want to acknowledge recent reporting about the number of people older than age 100 who may be receiving benefits from Social Security. The reported data are people in our records with a Social Security number who do not have a date of death associated with their record. These individuals are not necessarily receiving benefits.

I am confident that with DOGE's help and the commitment of our executive team and workforce, that Social Security will continue to deliver for the American people."
