

HEATING AND HOUSING HUB UDPPATE 11th MARCH 2021

Purpose of Report:

To update the Sustainable Glasgow Board.

Recommendations:

• That the Board notes the paper.

1. New Build Theme: Presentation

- 1.1 Calum Murray gave a presentation on the work of CCG in developing a near zero carbon new build standard house design.
- 1.2 CCG are currently delivering a product for West of Scotland Housing Association (WOSHA), and they are confident they can deliver a product to PASSIV standard. <u>http://c-c-g.co.uk/passivhausdevelopment-recevies-planning-consent/</u>
- 1.3 CCG save almost 20% against traditional construction costs as a lot of it is done off site. There is a high standard of saving on the manufacturing process and the cost element is factored in. There is an ambition to take even more of the manufacturing and construction process into the factory if there is a notable benefit.
- 1.4 Processes are zero waste. All waste is recycled and taken back to manufacturing.
- 1.5 This type of standardised low carbon design also has private sector potential. There is a Passivhaus project underway on land in the east end of the city funded by LCITP.
- 1.6 The Hub asked for further information on the city's programme for energy efficient affordable housing. There will be a presentation on this at the next meeting. The City was asked to consider conditioning land sales to promote low carbon building.

2. Actions

- 2.1 As part of the HUB retrofit theme work plan Paul Kilby will be invited to the next Hub meeting to update on the city region retrofit bid and how the HUB might contribute
- 2.2 The HUB will be briefed at its May meeting on the city development plan district heating strategy as part of the heat theme.
- 2.3 Members discussed the Charter Pledge being developed by the Green Economy and Private Sector Hub. The HUB members noted their support and the ties into project development.

2.4 It was noted that Salix funding could potentially be utilised. GS responded that there is a paper currently at GCC leadership to see if
