Total heavy metals in packaging	Toxics in Packaging Clearinghouse (TPCH)	Packaging shall not contain the sum of mercury, cadmium, lead and chromium (VI) in concentration above 0.01% by weight.
Plastic Bag Warnings	Various state laws	Plastic bags with a thickness of less than 1 mil (0.001 inch) having an opened end larger than 5 inches in diameter shall contain the following warning statement or equivalent: <b>WARNING: To avoid danger of suffocation, keep this plastic bag away from babies and children.
