Country of Origin Marking	19 CFR 134.11	Shall indicate country of origin legibly, permanently, and incomparable size and close proximity to any mention of country other than country in which the article was manufactured or produced. Must be visible at point of purchase.																																						
Age Grading	ASTM F963-current version	<ul style="list-style-type: none"> <li>The toy shall be labelled to indicate the minimum age for intended use, or have such labelling on any retail packaging.</li> <li>For certain toys, such as costumes and riding toys, it may also be appropriate to label in terms of height or weight limitations.</li> </ul>

Plastic Bag Warnings	Various state laws	<p>Plastic bags with a thickness of less than 1 mil (0.001 inch) having an opened end larger than 5 inches in diameter shall contain the following warning statement or equivalent:</p> <p><b>WARNING: To avoid danger of suffocation, keep this plastic bag away from babies and children. Do not use this bag in cribs, beds, carriages or playpens. This bag is not a toy.</b></p>
Lithium metal batteries and Lithium-ion batteries	UN Manual of Tests and Criteria, Sixth Revised Edition, Amend 1, Part III, sub-section 38.3	Comply with the regulation. Battery test report should be available on request.
