Best Efforts Offering of Membership Interests

This Supplement No.11 (the "Supplement"), which amends and supplements certain information originally set forth in the Private Placement Offering Memorandum dated June 21, 2023 (the "Original Offering Memorandum"), previously distributed to prospective investors, is incorporated by reference into, and constitutes part of, the Original Memorandum. Prospective investors should read the Original Offering Memorandum, this Supplement, and the Subscription Agreement before making a decision to invest in the Interests offered thereby. Unless provided otherwise herein, section references are to the particular section in the Original Memorandum.

The purpose of this supplement is to disclose the commencement of and to make active the following October 2024 Rewards Program (the "Rewards Program" or the "Program") and are offering reward membership interests ("Reward Interest", "Reward Interests", "Reward", or "Rewards"). The Program is available to all new and existing investors and is being offered through the Cityfunds by Nada App and the Company Website.

Rewards Program

Cityfunds Portfolio Fund, LLC (the "Fund", or "Cityfunds Select", or "Select Fund", or "Select") establishes the following terms and conditions governing the investor Rewards Program. This Program offers bonus membership interests to investors who make investments in the Fund during the Qualifying Period (as defined below), subject to the terms and conditions set forth herein.

Commencing on October 10th, 2024, investors can make a Qualifying Investment or Qualifying Investments during the Qualifying Period to qualify for the Reward under the October 2024 Rewards Program.

1. Program Overview:

The Program provides bonus membership interests based on the amount invested by an investor during the Qualifying Period. The bonus structure is tiered as follows:

- **7% Bonus:** For investments of \$100,000 or more.
- **5% Bonus:** For investments between \$50,000 and \$99,999.99.
- **3% Bonus:** For investments between \$25,000 and \$49,999.99.

Investments below \$25,000 do not qualify for a bonus under this Program.

In addition, investors who make a qualifying investment by 11:59 pm CST on October 17, 2024, will receive an additional 1% bonus (the "Early Bird Bonus"). This early bird tier applies to all qualifying investments, regardless of the amount, and is awarded in addition to the standard bonus for the corresponding investment tier.

Investors may qualify for a single tier only under the Rewards Program. Investors cannot qualify for or combine rewards from multiple tiers in the same investment cycle, nor may they participate in any concurrent rewards programs offered by the same entity if another program is active.

2. Bonus Calculation:

The bonus awarded under the Program is calculated as a percentage of the total investment made during the Qualifying Period, based on the applicable tier, as follows:

- Example 1: An investor who invests \$150,000 by October 17, 2024, is entitled to a 7% bonus plus the Early Bird Bonus of 1%, resulting in \$12,000 in additional membership interests.
- Example 2: An investment of \$75,000 qualifies for a 5% bonus, and if invested by October 17, 2024, also qualifies for the Early Bird Bonus of 1%, totaling \$4,500 in additional membership interests.
- Example 3: An investment of \$30,000 qualifies for a 3% bonus, and if invested by October 17, 2024, will receive the Early Bird Bonus of 1%, resulting in \$1,200 in additional membership interests.

All bonus rewards are earned as additional membership interests in the Fund and will be credited to the investor's account.

3. Qualifying Period:

The "Qualifying Period" refers to the specific timeframe during which investments must be made in order to qualify for the Program. The Qualifying Period for this Program begins at 12:00 am CST on Thursday, October 10, 2024 and continues until 11:59 pm CST on Thursday, October 31, 2024. The Early Bird Bonus is available only to investments made by 11:59 pm CST on October 17, 2024.

4. Form of Reward:

All rewards under the Program are awarded in the form of membership interests in Cityfunds Portfolio Fund, LLC. No cash or other forms of compensation will be provided. The membership interests awarded through the Program will carry the same rights, restrictions, and obligations as any other membership interests in the Fund.

5. Platform Eligibility:

In order to qualify for the Program, all investments must be made through the Cityfunds by Nada App or the Company Website. Investments made through other platforms or mediums are not eligible for bonuses under this Program.

6. Additional Terms:

The Fund reserves the right to amend, modify, or terminate this Program at any time at its sole discretion. Any such changes will be communicated promptly to investors. Participation in the Program constitutes the investor's acceptance of these terms and conditions.

The Reward will not be processed until sixty (60) days after the Qualifying Investments are marked as "settled" and the funds successfully placed in escrow. The Reward is not contingent on your investment settling during the Qualifying Period as long as the investment is placed through the Cityfunds by Nada App or Website during the Qualifying Period. We reserve the right to reverse any Rewards distributed to investors if their investment payment fails for any reason.

The Rewards Program is non-dilutive to the current offering. All Reward Interests are purchased by Nada Holdings, Inc, of which the Manager of Cityfunds Portfolio Fund is a subsidiary to. These purchased Reward Interests are issued directly to the investor's portfolio accounts that qualified for the Reward.
