In the event that our acoustic panel systems attain their end of life due to building demolition or refurbishment, Decor Systems commits to donating usable panels to educational facilities (schools, training centres, childcare, etc.) in regions that are identified as having a high proportion of students with learning challenges. Special consideration is given to centres that focus on literacy programs for Indigenous students. The following conditions apply: Liaise with Decor Systems to determine suitability before panels are returned. Photos will be required both before and after dismantling to ascertain suitability. Panels to be dismantled and returned to Decor Systems at the client's cost. Panels must be in reasonable condition in their original manufactured sizes. The final decision will rest with Decor Systems as to the suitability of the panels for re-deployment to alternative projects.

Decor Systems are committed to operating responsibly and maintaining ethical standards across our operations, with a particular

focus on risk areas within our supply chain. **STRUCTURE** Decor Systems is a family owned Australian owned and operated vertically integrated manufacturer, supplier and retailer of architectural acoustic panel systems. Our headquarters, manufacturing and supply facility located in Glendenning, NSW. Decor Systems maintains offices in Brisbane and Melbourne. **OPERATIONS AND SUPPLY CHAINS** Decor Systems is committed to the superior design, production and supply of quality products and services. We have been in the business for over 50 years and offer an extensive range of innovative products, professional services, experience, and industry knowledge. With a growing team of Sales and Project Consultants located throughout Australia, , a modern manufacturing and supply facility and an international sourcing team, Decor Systems has a valued reputation for reliably delivering state-of-the-art architectural solutions. Decor Systems’ supply chain includes both local and overseas suppliers with whom the business has established, long-standing supply agreements in place. Our manufacturing facility produces custom and made-to-order products, sourcing raw materials and componentry from tier one suppliers mostly located in Australia. Our importing division sources and assembles materials that requires little or no customisation, with raw materials sourced largely from suppliers located in Germany, USA and Latvia, as well as some local Australian suppliers. **ADDRESSING THE RISK OF MODERN SLAVERY PRACTICES** The Decor Systems executive team are committed to ethical procurement and oppose slavery in all its forms. Policies and risk management processes have been implemented to identify and address the risk of modern slavery in our supply chain. This includes routine supplier evaluation and supply chain mapping that encompasses a range of environmental and ethical risks, including modern slavery. Within this supply chain analysis, BFX has identified two areas of risk. First, a generally low risk of modern slavery in the construction supplies sector. Second, some second-tier suppliers where materials are imported from overseas have a medium geographic and entity risk. **DUE DILIGENCE AND REMEDIATION PROCESSES** To date, Decor Systems has had no reported incidents of modern slavery or breaches by its overseas suppliers. Nevertheless, Decor Systems recognises the inherent risk of slavery and human trafficking within the supply chain and has established internal processes to guide supplier selection and tendering, including: Consideration of certain factors before a supplier is awarded a supply contract. For example, the potential supplier’s reputation, ability to supply, integrity, financial strength and compliance with legislation and best practice. Ensuring that Decor Systems do not purchase materials from suppliers that breach the UN Guiding Principles. If any existing suppliers are found to have breached the UN Guiding Principles, Decor Systems will take immediate steps to reassess those supply arrangements. Staff training within Decor Systems direct supply chain,in which supplier evaluation is conducted prior to engagement of suppliers. Existing suppliers are audited in line with Decor Systems GECA, FSC and Illegal Logging Audit requirements. **FUTURE COMMITMENTS** Over the next year, Decor Systems focus areas will be: Further refining our procurement processes and training our procurement team with best practice initiatives.
