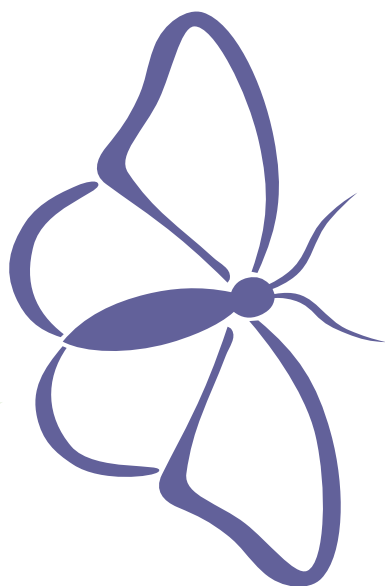

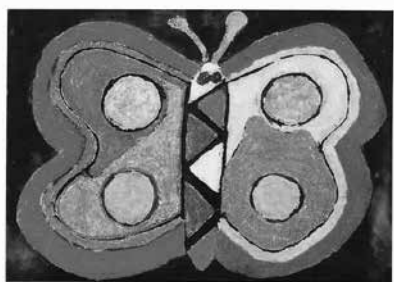

We have been making great progress on our goals and have had lots of success.

In my role I have been to lots of meetings with different organisations and many events and conferences. It's great to keeping letting people know about People First and what we do.

Highlights for me have been:

- People First turning 10 and having the 10 year celebrations at Parliament
- giving Josie Khoury (Whanganui People First) the 2013 Leona Gitmans Te Aranga self-advocacy award
- attending and presenting at the Australian ASID conference in Sydney
- giving out new life memberships to Rosemary Scully and JP Edwards

I am very pleased that People First NZ continues to have new, younger members joining up. Through our courses such as Speaking up and the UN Convention, young people are learning about their rights and joining their local People First group.

A lot of people are involved with People First NZ – members, advisors, volunteers and staff – and everyone does their bit to make the organisation work well.

I would like to thank the National Committee for their great work and also People First's Advisors Gordon Boxall and Brigit Mirfin-Veitch for their commitment to the organisation.

The national office is a busy place and staff look after the people who work and volunteer for People First. They deliver and report on the contracts that People First has. They make meeting arrangements and organise projects and money.

I look forward to the year ahead with People First growing even stronger and more members becoming leaders and having their say.



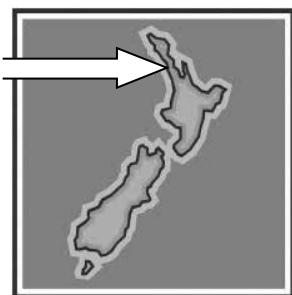

We have had some false starts with Paparanga and Franklin, so they are a little bit behind.

We have been to the following conferences:

- Know How conference – this can sometimes be someone’s first experience on their journey of having a child with a disability.

We had a great leadership team in 2013 – Manu Talatiu, Craig Henderson, Tyron Aphia and Linda Harwood. What great presentations they did. They have been adding to their kete of skills and knowledge this year. We are very proud of them.

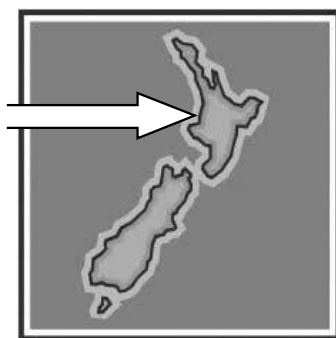
Manu has been trained as a monitor and has been interviewing people with disabilities about the UN Convention. David Hughes, ex-Northern Region Chairperson, sits on the Auckland Council. Manu and I take turns going to the Auckland Transport Advisory meetings. Manu is also on the Pasifika PHAB Group. I have recently finished my term on the New Model Group. Members have also been involved in: a Domestic Violence and Disability group; the Health and Wellbeing Action Group; and a disabled women’s forum.

We have secured funding for our Keeping Safe Feeling Safe project this year. This project will work with providers, community groups and government departments to change the landscape around bullying, abuse, neglect and violence towards people with learning disabilities.

Northern region has run 3 speaking up courses which were well attended and enjoyed.

Thank you to the Auckland community, disability, social and government sectors – who have supported, walked alongside, listened to and taught us heaps. People First definitely feels like part of Auckland and its diverse community.

Lastly, I would like to say thank you to Kaeti, who never stops working for us. For all of the hard work she does with and for our members, helping us to lead a good life and being there for me when I need it.



Midland Region

We have told lots of people about People First by having stalls at the Waikato Show and the Waipa 150th Anniversary Celebration.

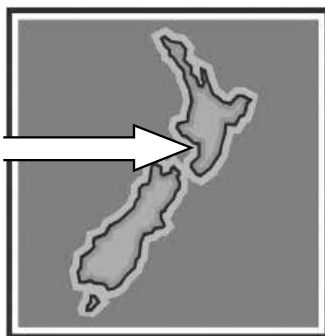

In the last year Central Region members have been to many events and meetings.

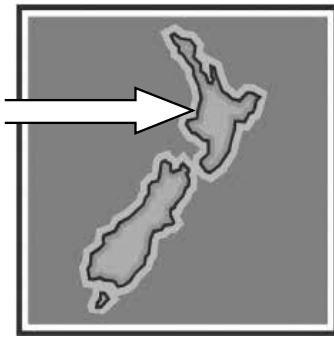
We have spoken up about disability issues and People First New Zealand at these places:

We held our regional meetings in November 2013 and March 2014. Members from Christchurch, Ashburton, North Canterbury and the West Coast attended on both occasions.

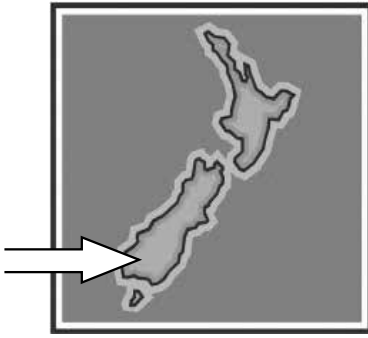

A number of us have been involved with the Dunedin 'Empowering People Otago' group that is watching closely the work of the Enabling Good Lives projects. Also, a number of members have roles in the local Disabled Persons Assembly (DPA) and we have talked to the local Needs Assessment and Service Coordination (NASC) provider Accessibility, sharing experiences from our perspective.



Our Te Pou Leadership Project on behaviour support has been very well received and we are continuing to look at the role medication plays in behaviour management. Discussions with Explore and the Ministry of Health will continue on this topic.

The event, held at parliament, was attended by many people from a range of organisations and government ministries. The fact that so many felt that it was important to share in the celebrations showed just how valued People First now is. The hard work and commitment of People First members was clear for everyone to see with members hosting events and showing leadership throughout the celebrations.



This year has seen People First continue to grow and develop as an organisation. It continues to be a great privilege and pleasure to serve the members of People First NZ. This year has been another exciting and busy year.

We have made great progress on the 6 strategic goals the National Committee has chosen. More people know about People First NZ nationally and internationally through a range of activities such as presenting at national conference and talking about People First NZ in local communities. This year has seen strong growth in requests for easy read translations and members for local, regional and national advisory groups.

People First NZ continues to speak up on important issues and we are guided by the UN Convention on the Rights of Persons with Disabilities – the Disability Convention. This year's issues have ranged from words that are used in the disability sector, having jobs and money, to the sterilisation of children and adults.

People First NZ is a member of the UN Convention Coalition – which finds out if disabled people in New Zealand are getting their rights – and we are proud to have been part of producing the Article 33 reports. The latest reports have been about young people, and how disabled people are talked about in the media.

We are working with the other Disabled People's Organisations and the Government to put Article 4.3 of the Convention into reality in New Zealand. This is very exciting work and is setting up a new ways of doing things for the future.

People First NZ has many members speaking up on local and national advisory committee, boards and conferences. What the members say makes a difference. This year we are pleased to have been involved in a range of Committees including: Choices in Community Living and Enabling Good Lives – Waikato. Members have also spoken up at conferences run by Imagine Better, New Zealand Disability Support Network, the Health and Disability Commission and both of the ASID conferences in Australia and New Zealand.

People First NZ remains focused on leadership development and this year we have continued the regional and national leadership work. The leadership work gives future leaders opportunities to learn new skills and have new experiences which will assist them to lead People First in the years ahead.

Our **Learn With Us** educational courses are going well with courses for people with learning disability happening around the country. Members have lots of ideas for new courses for the future. **Learn With Us** also educates professionals so they can work better for people with learning disability.

People First NZ is kept strong by having a great team of staff and volunteers who understand self-advocacy and work hard for the members.

Speaking up in New Zealand



Members from around New Zealand represent People First at many national, regional and local advisory groups. Their role is to bring the voice of people with a learning disability to the group and make sure all ideas for changes will make a difference to all people with a learning disability. This year members were on the following national advisory groups:

Disabled People's Organisations' Coalition for Monitoring the United Nations Convention on the Rights of Persons with Disabilities

Graeme Parish – The Coalition is made up from representatives from the Disabled People's Organisations and looks at whether disabled people living in New Zealand think they are getting their human rights. Each year they write a report called Article 33.

Social Skills Governance Group

Craig Bellis – This advisory group has been set up to discuss the mandatory review of the social skills qualification available through the New Zealand Qualifications Authority.

Enabling Good Lives Waikato Leadership Group

Glen Terry – This advisory group is involved in designing the demonstration of Enabling Good Lives in the Waikato region.

Ministry of Health, Disability Services Directorate Consumer Consortium

Phyllis McPherson and **Robert Martin** - The aim of the Consumer Consortium is to increase the involvement of disabled people and family/ whānau into the Directorate's activities.

New Zealand Bankers Association

Melissa Blackmore – This group looks at banking issues for disabled and elder people. The group has developed guidelines for banks to help them accommodate the needs of their disabled and elder customers. At the meetings the banks report to the group about their progress.

Workbridge Council

Don Neal – The Council, which is made up of disabled people, gives advice to the Board of Workbridge NZ.

Choices in Community Living

Christina Crawford – This group is about providing another network for people with disabilities to go into the community to live.

ATAC (Accessible Transport Action Coalition)

Simon Atkinson – This group was set up to implement the recommendations from the “Accessible Journey” report from the Human Rights Commission. It writes submissions and comments to the Ministry of Transport about transport issues for disabled people.

Being a Disabled People’s Organisation



People First NZ is a Disabled People’s Organisation (DPO) and has a role in monitoring the UN Convention. The UN Convention also says that Governments must work with and support DPOs.

Hamish and Cindy have been meeting with staff and people in governance roles from the other DPOs about what this means and also thinking about ways that DPOs can lead the disability sector.



The DPOS have also been working with government officials and together we have been writing the cross-government department **Disability Action Plan for 2014 -2018**. This is very exciting and the first time this has ever happened in New Zealand.



The four priority areas are:



More jobs and opportunities



Make sure Disabled people are safe and feel safe



Changing the disability support system for the better



Making the community easy for everyone to access

Members will be involved in the action plan working groups and many of the project groups that will be set up around the actions.

People First is very proud of the actions on the plan especially: improving the health outcomes for people with learning disability, replacing the minimum wage exemption permit, looking at issues of violence and abuse and supported decision making.

Speaking up regionally and locally



There are a lot of People First members actively involved in speaking up in their communities: in city and regional council advisory committees, university research advisory committees, hospital committees and also at conference and forum organising committees. Thank you for the opportunity for people to speak up and have their say.

The Leona Gitmans Te Aranga Trust



Leona was a person who was passionate about people with learning disability knowing about self advocacy. When Leona passed away her parents asked her family and friends to make donations to People First rather than bring flowers to her service.

The Leona Gitmans Trust was set up by People First in 2004. In 2008 our Kaumātua, Arapeta Amai added the words Te Aranga to the name of the Trust, so it became the Leona Gitmans Te Aranga Trust.

Te Aranga self advocacy award

The National Committee decided to create an annual award for a person with learning disability who has been a strong leader in self advocacy for people with learning disability in New Zealand. Normally the award is presented at the Imagine Better conference every year, however in 2013 the award was presented at People First NZ's 10 year anniversary celebration at Parliament.



People First was thrilled to be able to present the award for 2013 to Josie Khoury from Whanganui – one of the founding members of People First in New Zealand.

Josie has had many roles in her local group over the years, including President; Josie was on the People First Independence Steering Committee that was set up to move People First from within IHC to its own organisation.

Josie was a leader in the People First march and petition to get the Government to close Kimberley, the last large institution. She went on to be on the government working group to close it and stayed on the group throughout the many years that it took.

Josie also was Involved in 'To Have An Ordinary Life' Photo Board Exhibition, telling her story to help others. Her story then went into the book and DVD 'Seeking Community'.

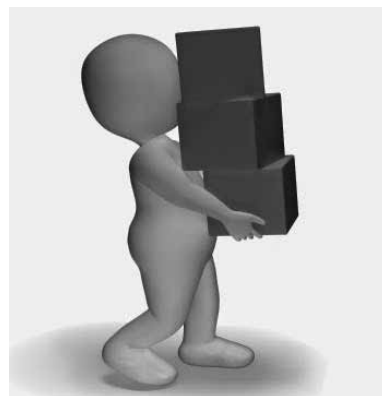

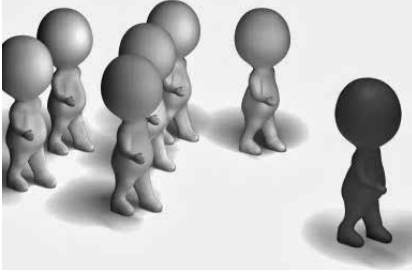
The National Committee had a hard time choosing a winner from the wonderful entries that were sent in and decided instead to give out awards for 1st, 2nd and 3rd.

Consumer Leadership Development



Once again People First has received funding from Te Pou for leadership development. Over the last few years People First has created a very successful 2-stage model with ongoing leadership development in the regions and a national forum at the end of the year to cement the learning. This has meant that many more members have had opportunities to learn, develop and represent People First at meetings and events around the country.



The 2013 national forum was held in Wellington and the focus was on '**Looking Forward**'. At the forum 30 members from across the six regions met to learn and discuss topics such as 'being a leader' and sharing what leadership development has been happening in the regions.



The next Leadership Forum will be held in Christchurch in November 2014 and the theme will be: '**Future Leaders**'.

Keeping Safe Feeling Safe project



People First NZ National Manager Cindy Johns met with Trish Green and Dr Jan Scown from the Making a Difference Fund in June 2014 to sign a 1 year funding contract for our 'Keeping Safe, Feeling Safe' Project in Auckland.

Keeping Safe Feeling Safe is based on a project developed in the UK by people with learning disability. It aims to change the way people with learning disability are seen and treated across the police and social services when they report bullying, harassment and abuse.

The project is being managed by 2 Project Managers – Kaeti Rigarsford and Sue Hobbs, and they work closely with 4 People First members as Advisors. The Advisors to the project are Raymond Thoumine, Sam Welsh, Manu Talatiu and Kylie Wookey. Each will receive training to facilitate KSFS workshops to people with learning disabilities, social services, the police and people who work with people with learning disabilities.

The first stage of the project will be based in Auckland and it is hoped that it will be available nationwide in the future.

Disability Information and Advisory Service

People First is funded by the Ministry of Health to provide good information and advice about learning disability for New Zealanders.

The number of enquires we have increases every year and the requests for information come from a wide range of people and services.



Information to people with learning disability is provided in a number of ways including through meetings, presentations, events, courses and newsletters.

Learn With Us



People First has developed an education arm called **Learn With Us** where courses are made and delivered by members to others with a learning disability.

Current courses available are:

- **Speaking Up**
- **The UN Convention**
- **Work and your rights at work.**

People who have attended these courses have said they have found them really great and that they have learnt about their rights and how to speak up. Many have gone on to join People First as a member of their local group.

1. STATEMENT OF ACCOUNTING POLICIES

REPORTING ENTITY

People First New Zealand Inc. is a charitable organisation incorporated under the Incorporated Societies Act 1908, and is registered as a charity with the Charities Commission (CC11244)

These financial statements are for the National operations of People First Inc. and include the following regional and group results for the first time: 5 regions are Central, Midsouth, Northern, Midland, Top of South. 29 groups are Ashburton, Blenheim, Central/City Auckland, Christchurch, Dunedin, East Auckland, Hamilton East/Cambridge, Hamilton, Horowhenua, Hutt Valley, Kaikorua, Kapiti, Mana, Manawatu, Motueka Nelson, North Canterbury, North Shore, North Taranaki, Oamaru, Rotorua, South Auckland, Papakura Tauranga, Wanganui, Wellington, West Auckland, Whakatane and Whangarei. All the active regions and local groups have been included in financial statements for the year ending June 2014.

GENERAL ACCOUNTING POLICIES

These financial statements are a General Purpose Financial Report as defined in the New Zealand Institute of Chartered Accountants Statement of Concepts and have been prepared in accordance with generally accepted accounting practice as defined in that Statement.

People First New Zealand Inc. qualifies for differential reporting because it is not publicly accountable and is not large. The entity has taken advantage of all differential reporting exemptions.

The measurement base adopted is that of historical cost. Accrual accounting is used to recognise expenses and revenue when they occur.

PARTICULAR ACCOUNTING POLICIES

Accounts Receivable - Accounts receivable are stated at expected realisable value. No provision has been made for doubtful debts as none is considered necessary.

Fixed Assets - Fixed assets are stated at cost less aggregate depreciation. Depreciation has been provided on a straight line basis so as to allocate the cost of assets over their estimated useful lives, as follows:

Computer Equipment	36%
Video Camera Equipment	28.80%
Office Equipment	18-63.5%

Income Tax - The Entity is exempt from income tax as it is registered with the Charities Commission.

Goods & Services Tax - These Financial Statements have been prepared on a Goods and Services Tax exclusive basis

Income Recognition - Funding received for the performance of agreed activities is recognised as income upon delivery, where there is partial delivery of contractual obligations, income is recognised to match costs incurred.

CHANGES IN ACCOUNTING POLICIES

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in the previous period.
