People First New Zealand is here to:







More importantly they are there to help new committee members to understand this new and challenging role.



Over the past year the National Committee has been focused on ensuring that People First's employment and health and safety policies are strong.


The Committee has also done incredible work in making sure its financial reports are able to be understood by everyone.

National Manager's Report

It has been a privilege serving People First members over the past year and working with a dedicated team of staff, members and volunteers.

Highlights have been:

- Seeing members developing confidence, skills, knowledge and having opportunities to speak up.
- Being able to deliver several Learn With Us courses which upskill people with learning disability about topics such as speaking up, money and keeping safe.
- Members speaking up on advisory committees and through submissions on a wide range of topics such as having more choice and control in services, banking, housing, being a tenant and education.
- The great work of the Make It Easy service which makes information into Easy Read – and the fact that more government departments and organisations are making their information accessible.
- Being part of the Disabled People's Organisations (DPO) coalition and its work with the New Zealand government and as a partner in the Independent Monitoring Mechanism (IMM). This is putting Articles 4.3 and 33 of the Disability Convention into real action.
- With the support of the organisation providing ongoing assistance to Robert Martin in his role as a committee member on the United Nations Committee on the Rights of Persons with Disabilities. Robert continues to speak up on a range of articles in the Disability Convention to assist countries around the world to make the rights in the convention real.

Having enough funding and resources to do everything we want to do is always a challenge and we continue to work hard to have enough to make good progress on the goals of People First New Zealand.

Goal 1: People know about People First New Zealand

Conferences and EXPOs

Every year, People First members speak at conferences on different topics that affect people with learning disability, like:

- being a Disabled Persons Organisation.
- self advocacy.
- supported decision making.
- school and work.
- health
- keeping safe.
- money.

We also have stalls at conferences and EXPOs where we give away free Easy Read information and tell people about their rights.





Disability information and advisory service

People First New Zealand has a disability information and advisory service.

This means that we answer questions that members and the community have about:

- · learning disability.
- the United Nations Convention on the Rights of Persons with Disabilities.
- how to speak up.
- where you can get more information about services for people with learning disability throughout New Zealand.





Goal 2: People First has strong leaders

Leadership Forum 2018

In 2018 we held a 2 day Leadership Forum in Wellington for over 30 People First members from all around New Zealand.

Members heard from guest speakers like Life member Robert Martin MNZM, and took part in activities on:

- Human Rights.
- The Treaty of Waitangi.
- The UN Convention on the Rights of Persons with Disabilities.
- The Health and Disability Code of Rights.

It was a great chance for people to meet, talk and learn together.





Leona Gitmans award 2018

Leona was a person who was passionate about people with learning disability knowing about self-advocacy. When Leona passed away her parents asked her family and friends to make donations to People First rather than bring flowers to her service.

We would like to say a big thank you to the Gitmans family, who support People First to this day, in her memory.

The Leona Gitmans Trust was set up by People First in 2004. In 2008 our Kaumātua, Arapeta Amai added the words Te Aranga to the name of the Trust, so it became the Leona Gitmans Te Aranga Trust.

With the support of the Trust, the People First National Committee gives an award every year to a person with learning disability who has been a strong leader in selfadvocacy in New Zealand.

People First New Zealand was thrilled to be able to present the award for 2018 to People First Whakatāne member Bernadette Moses.

Bernadette was given a beautifully carved pounamu (greenstone), a certificate and a cash prize.

Congratulations Bernadette and thank you for your hard mahi.





Goal 3: People First speaks up

Advisory group work

Members from around New Zealand represent People First at many national, regional and local advisory groups. Their role is to bring the voice of people with learning disability and make sure all ideas for change will assist people with learning disability to have good lives.

People First New Zealand provides trained Meeting Assistants for members who represent People First on advisory committees.

People First New Zealand would like to thank everyone who has worked as a Meeting Assistant over the last 12 months. Your work makes sure that people with learning disability have an equal voice when speaking up.





Making submissions

People First New Zealand makes submissions to the Government when they are thinking about making new laws. Knowing what people think helps the Government choose what to do. We think it is important that the Government hears from Disabled people.

This year, People First has made submissions on:

- Reform of the Residential Tenancies Act 1986 (RTA) renting a house.
- The Healthy Homes Standards having a good home to live in.
- The Arms amendment act having better gun laws.
- Education Legislation Consultation making education better for disabled students.
- The NZ Banking Association's review of voluntary guidelines making banking better for disabled and older people.

Assisting Robert Martin MNZM at the UN

As Robert Martin continues in his role as an independent expert on the UN Committee for the Rights of Persons with Disabilities, he continues to be assisted by People First New Zealand. His work takes him to Geneva 2 times a year – where the committee looks at the countries that have signed the Convention to see how they are putting in place the rights in the Convention. Roberts's term runs to the end of 2020.







Goal 4: People First respects and welcomes people from all cultures

Visit to Rāpaki marae

In October 2018 People First Midsouth members had an overnight visit to Rāpaki Marae. Members were welcomed with a pōwhiri and spent time learning about:

- · harakeke weaving.
- stone painting.
- · Te Reo Māori.

It was a great chance for people to make better connections with local iwi and share time together, learning about each other and Māori tikanga.







Goal 5: People First has an Easy Read translation service

Our Easy Read translation service is called Make It Easy and it is very busy. This year we translated 60 documents and doubled the number of translators in our team.

We would like to thank our translators, who work very hard to make sure our Easy Read is the best it can be.

We would like to thank all of the organisations who chose to make their information easier for people to read and understand through the Make It Easy service this year.

This means there is more accessible information in New Zealand, and more people with learning disability able to speak up on issues that affect them.

Easy Read for the United Nations

This year our Make It Easy service made 2 documents in Easy Read for the United Nations:

- The report on the work of the UN Committee on the Rights of Persons with Disabilities for the last 10 years.
- General Comment 7 a document about how Governments need to work together with Disabled Persons Organisations.



These were big, important documents to get right and we were very proud to be chosen to do this work.

The work of the Make It Easy service is now being used by people all over the world.

Make It Easy award 2018

Every year the National Committee give out an award to an organisation or person who has made a great commitment to making their information in Easy Read.

In 2018 this award was given to the New Zealand Electoral Commission for making 'Get Ready and Vote: The Easy Read guide to voting.'

This is a great resource that will assist many people with and without learning disability to take part in politics as citizens of New Zealand.







Goal 6: People First has courses

Learn With Us is the education arm of People First New Zealand. Members and staff write and teach the courses together.

People First New Zealand knows how to teach in a way that works for people with learning disability.

Here are the courses we have:

- Speaking Up.
- The UN Convention.
- · Work and your rights at work.
- · Keeping Safe Feeling Safe.
- Money Smarts Made Easy.

Thank you to everyone involved with Learn With Us this year.

Keeping Safe Feeling Safe

This year 3 Keeping Safe Feeling Safe courses were run around the country.

It is a course for adults with learning disability that teaches people about:

- healthy relationships what abuse is.
- keeping yourself safe what to do if something bad happens to you, or someone else.

- your rights.
- the law.
- · how to get help.
- talking to the police and support services.
- how to report abuse who to tell and how to tell them.

Thank you to Sue Hobbs and everyone involved in making our Keeping Safe Feeling Safe courses successful.







Goal 7: - People First is a strong DPO

DPO coalition


People First New Zealand is part of a group called the DPO coalition.





What these words and numbers mean

Current assets

These are the things that People First owns, that change - such as the amount of money we have in the bank.

The money amount of these things is 8 hundred and 75 thousand, 5 hundred and 64 dollars.

Fixed assets

These are the things that People First owns, which do not change.

The money amount of these things is 10 thousand, 9 hundred and 33 dollars.

Total assets

These are things that People First owns, such as money in the bank, computers and office furniture.

If we add our current assets and fixed assets together, this will give us our total assets.

The money amount of these things is 8 hundred and 86 thousand, 4 hundred and 97 dollars.

Current Liabilities

These are the things that People First owes to other people or organisations.

The money amount of these things is 1 hundred and 16 thousand, 6 hundred and 76 dollars.

Net assets

This is how much money People First can say it has, after taking away the money it owes.

The money amount People First has at the end of this year, is 7 hundred and 69 thousand, 8 hundred and 21 dollars.
