Study Guide: "The Wisdom of the Universe" (2014) by Christi Belcourt

About the artwork: The Wisdom of the Universe (2014) was commissioned by the Art Gallery of Ontario (AGO). This large work (roughly 6 x 9 ft) depicts species of plants and animals listed as threatened, endangered, or extinct in Ontario. The image has a striking



symmetry, which the centreline disrupts. There we see a bird that appears to be flying. The symmetry shows us something about the way the world exists — balanced, centered, and patterned as a whole design, not in separate bits and pieces. You can find surprising details upon close viewing. Belcourt's signature dots - of which there are an estimated 250,000 - bring the artwork to life. She uses the bead, an object insignificant in size and simple in design, as the foundation of her art. Through the bead Belcourt connects with her Métis heritage and its artistic traditions. She simulates the appearance of beads by dipping the end of a paintbrush or a knitting needle into paint to create the tiny dots. Belcourt encourages viewers to notice details, objects, and events whose worth and importance are often overlooked. For Belcourt, all living things connect by lines symbolizing heritage, and the viewer is included and implicated in this network.

About the artist: Christi Belcourt (b. 1966) is a Michif (Métis) artist, author and activist who has become best known for large-scale acrylic paintings featuring thousands of painted dots emulating Métis Beadwork. Her Métis ancestry originates from the historic Métis community of Manitou Sakhahigan (Lac Ste. Anne, Alberta.) Belcourt grew up in Ontario and is currently based in northeastern Ontario. She began painting at age 15 and became a full-time painter around 2000. Her journey as an artist has pushed her to uncover the tradition of beadwork and the gifts of plants further, helping her to understand what people meant when they said, 'We are all connected.' Much of her recent work speaks to revitalizing Indigenous culture, language and land-based knowledge, as well as drawing attention to the urgent situation facing the planet as a

result of resource extraction and climate change. She is a lead organizer for the Onaman Collective, which focuses on the resurgence of language and land-based practices. She is also the lead coordinator for Walking with Our Sisters, a community-driven project which collects and displays ornamented moccasin vamps (tops) to honour murdered or missing Indigenous women.

Please preview the short film and then share it with your students. Select one or two guiding questions that reflect your curriculum and can guide student research and inquiry connected to the artwork, artists, and the socio-cultural context in which it was created.

Guiding Questions:

- How has Belcourt centered Indigenous perspectives and challenged colonization and climate justice?
- How does Belcourt explore concepts of interconnectivity in her artwork?
- How can art making and artworks promote renewal and healing in First Nations, Métis, and Inuit communities as well as reconciliation and dialogue with non-Indigenous communities?
- Is it significant that Belcourt uses both Métis and Western artmaking techniques? Or that it is
 often exhibited in traditional galleries but has also appeared in government institutions and
 European runways?
- The work is symmetrical almost. Upon close viewing, how do disruptions of symmetry communicate meaning?
- In what ways is Canadian identity tied to our relationships with First Nations, Métis, and Inuit communities? To the land? To our non-human relations?
- How does Christi Belcourt uphold or push the role of artist?
- How might you represent your relationship to land through an artwork, dance composition, dramatic scene, or original song?
- How might you represent the relationship between several plants and/or animals (ecosystem) through an artwork, dance composition, dramatic scene, or original song?
- This painting reflects Belcourt's worldview. How does that contrast with your own worldview? Can
 you use an artwork, dance composition, dramatic scene, poem, or original song to represent your
 world view?
- Create an artwork, dance composition, dramatic scene, poem, or original song to represent the concept of *Interconnectivity*.

Note to Teachers:

Cultural appropriation is harmful. A definition of cultural appropriation is: "using or borrowing elements of a marginalized culture without the permission of that culture. Cultural appropriation is harmful, diminishes the elements of the culture that are appropriated, and continues the oppression of the marginalized group." (First Nations, Métis, and Inuit Studies, 2019, page 285). When engaging in arts making practices with your learners, refrain from asking them to reproduce the artist's style. Rather, allow them to respond to big themes, ideas, and concepts using their own artistic voice. Students should be encouraged to communicate their learning in multiple ways. In addition to artmaking, presentations, videos, podcasts, journals, portfolios, etc., are just some of the ways that students might show what they know and are able to do.
