

## Indian Country Snapshot: Muscogee Nation

Concerned the State of Oklahoma wasn't doing enough to prepare its people who were leaving prison for life outside of it, MCN established its Reintegration Program (RIP) in 2004. Committed to protecting the public by "re-invest[ing] positive citizens back into our communities," RIP provides its clients an array of restorative support services rooted in Muscogee culture.<sup>2</sup> These include pre-release needs assessments, GED acquisition, life skills and vocational training programs, resumé preparation, college tuition assistance, behavioral/mental health supports, legal services, work clothing and tools, financial assistance for housing and groceries, and job placement services - whatever each client needs to avoid reoffending, get a job, and build a career.3 RIP clients must work or be actively pursuing employment; when not working, they must "pay it forward" by volunteering to perform community services, from mowing tribal elders' lawns to picking up roadside trash.4 In 2021, RIP launched its Fiber Optic Technician (FOT) program, which teaches 15-participant cohorts trade-critical skills in the high-growth field.<sup>5</sup> After eight weeks, trainees complete four-week paid internships before seeking employment. FOT boasts a 100% job placement rate for its graduates, who can make upwards of \$100,000 a year working for RIP's network of employers. Trainees who need housing reside and train at RIP's campus, which features a 36bed transitional living facility for eligible RIP clients, "state-of-the-art educational and vocational training" classrooms, and RIP's administrative headquarters. RIP also recently opened a call center on site to employ RIP clients while they reside there. By eliminating all of the barriers – such as a lack of transportation – standing in the way of participants' success, RIP makes its exceedingly difficult for them to fail, which explains the 6.9% recidivism rate among RIP clients (dramatically lower than Oklahoma's 15.6% rate). Following the McGirt Supreme Court decision, RIP expanded its services to support justice-involved MCN members during their sentencing processes, which has enabled many to avoid prison by completing RIP-customized diversionary plans.9

RIP's activities are supported by an evolving mix of federal grants coupled with increasing MCN funding, which sits at \$2 million annually (MCN funding for RIP was \$400,000 in its first year of operation). RIP staff invite MCN's political leadership to RIP events so they can "see what the tribal dollars are funding," which has been key to the Nation's sustained political and financial support of RIP and the ultimate goals it seeks to achieve (Tony Fish, Manager, Muscogee Nation Reintegration Program, Conversation with NCAI, June 26, 2024).

<sup>&</sup>lt;sup>2</sup> For example, RIP "facilitates cleansing ceremonies to help inmates prepare spiritually for reentry into society. Reintegration Program staff work with prison chapels to provide rocks for sweats, offer blessings, and coordinate sponsors." As RIP Program Manager Tony Fish explains, "Traditionally in our culture, once you pay your debt to society, we brought you back in, we restored you back into the tribe.
