





Tribal Grant Support Costs (TGSC)



- ✤ TGSC increased +10% 2021-2024
- Outyear need estimates based on BIE Budget Requests
- More funds managed = more TGSC resources

Tribal Grant Support Costs

- Statutory Formula Public Law 100-297
- ✤ Federal funds managed by schools multiplied by 11%
- Funds allocation is driven by student counts, and student participation in programs such as Native Language, FACE, etc.

ADMINISTRATIVE COST GRANT DISTRIBUTION FORMULA

In accordance with the Hawkins-Stafford Elementary and Secondary School Improvement Amendments of 1988, Pub.L. 100-297, as amended by the No Child Left Behind Act, individual administrative cost grants are determined using an administrative cost percentage rate calculated by the following formula: (Tribe Administered Program Dollars X 11%) + (\$600,000 (std Direct Cost Base) X 50%)

(Tribe Administered Program Dollars) + (\$600,000)


The above formula generates a percentage that is then multiplied by the tribally administered program dollars (called the Tribal Direct Cost Base which is the total number of Federal appropriated dollars managed by the Tribe) to calculate the dollars for the Administrative Cost Grant. The Administrative Cost Grant equals the value generated from the formula above or a minimum amount of \$200,000 regardless of the number of students (as required by the NCLB), prorated based on the availability of funds.


Tribal Grant Support Costs

- Increases in ISEP funding is a major driver in TGSC
- Additional budget lines that play a roll in school-level TGSC include the following:
 - Student Transportation
 - o Facilities Maintenance and Facilities Operations
 - Education Construction Facilities, Improvement, and Repair funding (FI&R)
 - Department of Education Title Funding





Johnson O'Malley Program (JOM)




- Students enrolled in BIE-funded schools (both tribally controlled and BIE-operated) are not eligible for JOM funding.
- To comply with the JOM Modernization Act, beginning in SY24-25, JOM distributions will be based on actual student counts.

Tribal Colleges and Universities (TCUs)




- Funding is based on Indian Student Count

TCU Facilities Improvement and Repair




- ♦ No FI&R appropriation prior to FY2021

Student Transportation Funding

- Funds increased +20% from 2021 to 2024
- ♦ Funds based on annual reported mileage 25 CFR Subpart G
- Funding supports fuel, driver salaries, maintenance, etc.
- Historical BIE Reimbursable per mile funding has risen from \$3.79 in 2021 to an estimated \$4.91 in 2024

Impacts of Road Conditions on Native Student School Attendance

Requires School Reporting in student information system of absences related to poor road conditions

BIE defines Chronic Absenteeism as being absent (excused and unexcused) from school for 10% or more of school days per student within a school year. Absenteeism represents lost instructional time whether excused or not and has a strong relationship with achievement and graduation.

Overview of EPA's Clean School Bus Program



The Bipartisan Infrastructure Law (BIL) provides **\$5 billion** over five years (FY22-26) for the replacement of existing school buses with zero-emission and clean school buses.

These new clean school bus replacements will produce either zero or low tailpipe emissions compared to their older diesel predecessors.

Eligible activities include the replacement of existing internal-combustion engine (ICE) school buses with electric, propane, or compressed natural gas (CNG) school buses, as well as the purchase and installation of electric vehicle supply equipment (EVSE) infrastructure.





Why Clean School Buses?

Roughly 500,000 school buses in the U.S., serving about 24 million students¹.

2024 CSB Rebate Program Overview





The EPA is offering up to \$965 million for clean school buses and ZE school buses. The EPA may modify this amount based on the applicant pool and other pertinent factors. Funds are subject to availability and total awards may be higher or lower than the anticipated funds offered update if changed.

Eligible activities include the replacement of existing internal- combustion engine (ICE) school buses with electric, propane, or compressed natural gas (CNG) school buses, as well as the purchase and installation of electric vehicle supply equipment (EVSE) infrastructure.



The EPA is prioritizing applications that will replace buses serving highneed local education agencies, Tribal schools funded by the Bureau of Indian Education or those receiving basic support payments for students living on Tribal land, and rural areas. EPA is committed to ensuring the CSB Program delivers on the Justice40 Initiative.

Separation Build America, Buy America Requirements



What is Build America, Buy America (BABA)?

Certain infrastructure projects are subject to BABA provisions of the Bipartisan Infrastructure Law (BIL).

- These require that all the iron, steel, manufactured products and construction materials used in federal infrastructure projects are produced in the U.S.
- This includes, but not limited to: the EV charger, all wiring or fixtures to support the charging equipment, breaker panels or subpanel, conduit from the meter to the panel.

- School buses are <u>NOT</u> subject to BABA requirements.
- Electric Chargers (EVSE) and supporting equipment <u>ARE</u> subject to BABA requirements,
 - Applicants should plan to purchase BABA compliant charging infrastructure products.



Workforce Development and Job Quality

Workforce planning and preparation are critically important elements of successful clean school bus deployment.



- All workers associated with the project, including current drivers, mechanics, electricians,
- bus monitors, and other essential personnel.
- Safe operation and maintenance of new buses and infrastructure for students and workers.
- ✓ Job quality for workers and adequate support during the transition, including worker voice and representation throughout the process (e.g., current workers are not replaced or displaced from new buses, workers are compensated their wages for time spent in training, etc.).

*Note: It is a **requirement** that all electricians installing, maintaining, or operating infrastructure are certified by the **Electric Vehicle Infrastructure Training Program.**

Costs associated with <u>workforce development</u> are an <u>eligible</u> use of program funds.










Clean School Bus Grant Awards Map: Tribal Prioritization*

FY2023 Grant Selectee Spotlight: Eastern Band of Cherokee Indians (EBCI)

- In partnership with the Cherokee Boys Club, the Eastern Band of Cherokee Indians was selected for 15 electric school bus replacements through EPA's Clean School Bus Grant program to serve Cherokee Central Schools, a Tribally-operated school system with approximately 1,300 students in grades K-12
- EBCI applied, and was selected, to replace diesel buses from 1991, 1992, and 1998 with clean, electric school buses
- Prior to the Clean School Bus program, the EBCI had previously used other Federal, state, and local funding to replace six older diesel school buses with electric school buses
- By adding 15 buses, the district will increase their total number of electric school buses to 21 – a 100% electric school fleet.

Aside from the Cherokee Boys Club, EBCI acknowledged many other partners in this project, including North Carolina Clean Energy Technology Center (NCCETC), North Carolina Department of Environmental Quality, Land of Sky Clean Vehicles Coalition (part of the Department of Energy's Clean Cities Coalition Network), Duke Energy, Carolina Thomas, and Renewable Design Associates.





FY2023 Grant Selectee Spotlight: Eastern Band of Cherokee Indians (EBCI) – Battery Tests and Effectiveness

- Before putting their first electric school bus into rotation, the EBCI conducted a mountain test in the Smoky Mountains
- The battery was at 78% when the bus reached the top, and 84% after going down the mountain.
- The bus has performed well in mountainous terrain and benefits from the regenerative braking through which the bus battery can gain range when driving downhill.
- Their average daily bus route is 50 miles the bus charges every other day
- The average bus was using around \$800 a month in diesel fuel, compared to the electric buses - which use around \$400 a month in electric costs.

Other EPA Funding Opportunities: Diesel Emissions Reduction Act (DERA)

Set EPA

Ownership, Usage, and Remaining Life

The existing vehicle must be fully operational.

The participating fleet owner must have owned and operated the vehicle during the 2 years prior to upgrade.

The existing vehicle must have at least 2 years of remaining life at the time of upgrade. Remaining life is the fleet owner's estimate of the number of years until the unit would have been retired from service if the unit were not being upgraded or scrapped because of the grant funding.

Highway Usage: **Tribal applicants:** 5,000 miles/year during 2 years prior to upgrade. **Territory applicants:** 1,000 miles/year during the 2 years prior to upgrade.

- Mileage of two or more units may be combined to reach the thresholds where two or more units will be scrapped and replaced with a single unit.
- If an applicant can demonstrate that a certified highway engine/vehicle is being used in a predominately nonroad application (e.g., firetrucks or utility trucks that idle for long periods to power auxiliary apparatus), engine operating hours as defined in "nonroad usage" may be used for application eligibility purposes.

Nonroad, Locomotive and Marine Usage:

- Agricultural Pumps: 250 hours/year during 2 years prior to upgrade.
- All Other Nonroad Engines: 300 hours/year during 2 years prior to upgrade.
- Locomotive and Marine Usage: 500 hours/year during 2 years prior to upgrade.

FY 2024 Execution

> Expiring Funds

U.S. Department of the Interior Indian Affairs

Executed 99.74% of FY 2023 OIP, IGLP, and OIEP.

Carryover Funding

- ♦ \$672M or ~22% of \$3.04B carried over of FY 2024 OIP, IGLP, and OIEP.
 - Balances are lower than the previous year by \$94M and 2% of total funding compared to FY 2024.
 - In FY25 QI-Q2, Regions and OSG working with Awarding Officials to obligate FY 2024 funding to Tribes.
 - BIE carryover decreased \$83M in FY 2025 compared to FY 2024 due mainly to an increase in obligating forward funding in FY 2024 compared to FY 2023.

FY 2025 Distribution of Funds

- > Continuing Resolution (CR) through December 20, 2024.
 - Tribal Transfers
 - <u>IA implemented FY 2025 Tribally requested transfers of TPA base funding under CR1</u>. Allows funding to be posted to the lines on which Tribes anticipate using the funding in FY 2025 and avoid reprogramming issues when final funding is provided for FY 2025.
 - Exception Apportionment
 - OMB approved IA's request to provide 100% of TPA base and Law Enforcement funding to FY Tribes under CR1. Funds should be with Tribes or on its way. Please work with IA awarding officials to claim funds in ASAP before 12/20/24 so that Tribes have funding and can continue to operate in the event of a shutdown. During a shutdown, federal employees are not permitted to work, including moving funds to Tribes.
 - If the CR extends into January 2025, CY Tribes will also receive 100% of TPA base and LE funding.

- Biennial process priority rankings will be used for 2027 and 2028 budget requests but Tribes may submit an updated Tool each year.
- National and Regional Tribal Priority Ranking Results presented at TIBC Spring Meeting and used to develop Tribal Budget Request. Also used by IA during budget deliberations so senior leadership can make informed decisions.



Finalizing Tribal Ranking Submissions by Region

> To complete regional Tribal ranking submissions, each IA Regional Office will:

- Consolidate and weight all Tribal Preferred Program Ranking Tool information submitted by Tribes in their region. (See weighting instructions in the guidance document.)
- Meet with Tribes to discuss their overall regional Tribal ranking. Agree upon any changes or recommendations proposed to their final ranking.
- Provide Central Office, OBPM with a copy of their final regional Tribal ranking, including category rankings, using Attachment C Final Consolidated Tribal Preferred Program Ranking Tool by Region.
- During the Spring TIBC Meeting, regional representatives should be present to address any issues related to their regional rankings.

Tribal Budget Formulation Sessions - BIE

- > The BIE Budget Officer and their budget formulation staff will
 - Coordinate with IA Regional Budget Offices to confirm the dates of initial and follow up budget formulation meetings with Tribes.
 - Coordinate with BIE ADDs and EPAs to designate POCs for each region.
- The designated BIE budget formulation staff and POC's will attend each IA Regional Office's budget formulation meetings with the Tribes.
- Then the BIE budget formulation staff will meet (can be done virtually) with all schools in the regional area to provide a demonstration and distribution of the ranking Tool and guidance, outlining that the schools need to complete only the Education and Construction Category rankings.





Tribal Budget Formulation Sessions - BIE



- The BIE POC will monitor ranking Tool completion rates, reach out to those schools that have not completed the ranking Tool, and offer technical assistance or other assistance to obtain and complete their submission.
- The BIE budget formulation staff will consolidate overall weightings for each line item within the Education and Construction Categories for all of their schools using the weighting factors included in this guidance.
- Once consolidated, the BIE budget formulation staff will send that weighting to each IA Regional Office for inclusion in their overall weighting process. The BIE budget formulation staff and POC should attend the second budget formulation session with each region, review the consolidated ranking, and develop a unified regional ranking for the Education and Construction Categories.
- During rollout of the National Ranking, OBPM and BIE budget staff will present the Education and Education Construction rankings from schools as well as Tribes both separately and combined.





Tribal Interior Budget Council Resolution #TIBC-24-001

Title: Calling on the Administration to Preserve the Base BIA/BIE Budget and BTFA Funding in the President's Budget while also Including Water Settlement Monies Reclassified as Mandatory Funding and that Said Monies are Removed from the BIA Interior Budget

WHEREAS, the Tribal/Interior Budget Council (TIBC) was created to provide a forum and process, consistent with the Indian Self-Determination and Education Assistance Act, Section 450(a)1 and Executive Order 13175 and the Department of the Interior's (DOI) Government to Government policy, whereby Tribal nations and the DOI work together to develop policy and budgets that provide for 1) the DOI to fulfill its Treaty obligations and Trust responsibilities; and 2) the fulfillment of Tribal nations' inherent sovereign rights of self-determination, self- governance, and self-sufficiency, as well as securing levels of funding necessary to strengthen Tribal governmental capacity to serve their citizens and communities; and WHEREAS, Tribal nations are sovereign governments that have a government-to-government relationship with the federal government embodied by 375 treaties, the U.S. Constitution, Acts of Congress, Executive Orders, Supreme Court decisions, federal regulations, and customary practices of U.S. foreign relations; and

WHEREAS, Tribal nations ceded millions of acres of land and natural resources, often by force and/or coercion, that are the foundation of the wealth and power of the United States; and

WHEREAS, the United States government has assumed a trust responsibility to protect these rights and to fulfill its solemn commitments to Tribal nations and their citizens; and

WHEREAS, in these solemn agreements, the United States government made promises it is obligated to fulfill in perpetuity, which codify the unique political status of Tribal nations and establishes the bedrock principles of the federal government's "trust responsibility" to protect the remaining lands and inherent rights of self-determination, self-government, and

WHEREAS, the United States government has failed to uphold its treaty obligations and trust responsibilities to Tribal nations; and

WHEREAS, this centuries-long failure has created and perpetuated socioeconomic conditions that inhibit Tribal nations' inherent rights of self-determination, self-government, and self- sufficiency that were promised to be preserved by the United States government; and

WHEREAS, when Congress enacts Bureau of Indian Affairs (BIA) appropriations, BIA distributes Tribal Priority Allocation (TPA) funding based on each tribe's historic TPA funding baseline, which was established through the 1990s tribal shares process; and WHEREAS annual appropriations for some accounts—such as Indian Land and Water Claim Settlements—are widely variable and are based on specific amounts authorized in any given fiscal year"; and

WHEREAS in the past, these widely variable accounts—when funded—have negatively impacted funding in other areas, for example, Congress reduced the ILWC account by more than \$44 million from Fiscal Year (FY) 2021 to FY2022 due to supplemental funding for Indian water settlements provided by the Infrastructure Investment and Jobs Act (IIJA; P.L. 117-58); and

WHEREAS, 25 U.S.C. Section 5325(a)(1) states: "The amount of funds provided under the terms of selfdetermination contracts entered into pursuant to this chapter shall not be less than the appropriate Secretary would have otherwise provided for the operation of the programs or portions thereof for the period covered by the contract, without regard to any organizational level within the Department of the Interior or the Department of Health and Human Services, as appropriate, at which the program, function, service, or activity or portion thereof, including supportive administrative functions that are otherwise contractable, is operated."; and

NOW THEREFORE BE IT RESOLVED, that the Tribal / Interior Budget Council requests the Administration preserve the base BIA/Bureau of Indian Education (BIE) budget and Bureau of Trust Funds Administration (BTFA) funding in the President's Budget while also including in the President's Budget water settlement monies reclassified as mandatory funding and which are removed from the BIA Interior Budget.

Opening Remarks

Tribal Co-chairs Opening Remarks

Acknowledgements to Assistant Secretary of Indian Affairs Bryan Newland and Team

Tribal Co-chairs expressed their gratitude to AS-IA Newland and his staff for their commitment to Indian Country over the last four years and their continued commitment to the TIBC body and its processes. While it is complicated, we also know that this administration has made a commitment to Indian country, and it's revealed in all the different appointments throughout the administration, there's just countless examples where Indian Country is highly recognized in this administration, and we deeply appreciate that.

<u>EO 14112 - Reforming Federal Funding and Support for Tribal Nations To Better Embrace Our</u> <u>Trust Responsibilities and Promote the Next Era of Tribal Self-Determination</u>

Tribal Co-chairs identified the importance of the EO 14112, with regard to government-to-government relationship, and removing barriers and impediments to helping tribes advance its goals of governance, self-governance and self-reliance agendas as part of our nation building. The countless programs that the Bureau provides for Indian country, as well as the programs that are available to the other agencies within the purview of the Department of Interior, led by Secretary Haaland, and appreciate the fact that Tribes and the department are working together. Tribes are appreciative of the department's collaboration with other departments and agencies that that affect Indian Affairs, rights and interest.

Tribal leaders remain supportive of the Presidents FY24 budget request to Congress and its request for a budget proposal to shift Contract Support Costs and Payments for Tribal Leases from discretionary to current mandatory funding with emphasis to include and Indian Land and Water Claim Settlements into that proposal.

Maximizing Budget Strategy within the TIBC Body

Tribal Leaders expressed the importance of utilizing TIBC not only for the short-term goals of a single fiscal year's budget, but to look at strategies of capturing a much broader, long-term goal of establishing the uncaptured costs for the benefit of all Tribes. This can be done through calculating the historical shortfalls of Treaty and Trust obligations made with Tribes on behalf of the Federal government, specifically the costs of lost homelands and resources extracted from those lands.

Office of Assistant Secretary for Indian Affairs (AS-IA) Opening Remarks

<u>Welcome, Assistant Secretary of Indian Affairs (AS-IA)) Bryan Newland</u> – AS-IA provided opening remarks on behalf of the Department of the Interior. AS-IA Newland serves as one of the top policy experts for the US Secretary of the Interior, Deb Haaland.

TIBC serves the administration in its advocacy efforts

AS-IA Newland remarked that under his leadership at Indian Affairs, TIBC has been noticeably more productive and collaborative in his tenure. The amount of education that has taken place over the last four years has been reflective of how much the department's culture has changed over the last fifteen years. AS-IA Newland has attributed this relationship as a reflection of TIBC's leadership from Indian Country and Tribal leaders improving ability to navigate the budget processes through strategic efforts. It was also noted that Tribal leaders should continue to hold the department accountable for the it's actions as this is what their citizens have asked of them by attending these meetings.

Boarding School Initiative Report

AS-IA Newland announced that in after just eight weeks of Secretary Haaland appointment, the administration was able to announce the federal Indian boarding school initiative, and remarked how incredible it was to have done something so monumental in such a short timeframe. AS-IA Newland credits this work to an outstanding team within Indian Affairs, and special recognition to the Bureau of Trust Funds Administration for its lead in these efforts with its research of over one hundred million pages of historical documents. He also commended them for taking on such a emotionally challenging task of going through tragic historical events of Native peoples, many of which these staff are familiar with. AS-IA Newland expresses his gratitude to the staff that sat through some of the most heart wrenching testimonies for over a year and a half and stated how proud he is the work that went into revealing the truth of this dark period in our history.

AS-IA Newland is supporting the legislation which creates a national commission, and its efforts to conduct the next investigative steps that the Federal government couldn't investigate such as churches. He made it a point that while the department did create some broad recommendations, the actual work of implementing those recommendations falls upon the shoulders of every tribal

leader and the commission.

The full report can be found <u>here</u>. Below are some of the findings/recommendations that AS-IA Newland highlighted to Tribal leaders at the meeting:

- The Federal Government spent approximately \$23.3 billion in modern day funds to establish the system of forced assimilation through, boarding schools, day schools, and the systems that supported those efforts. This is not inclusive of the value of lands that were sold, stolen to support these efforts, nor does it include those value of trust assets that were rated to pay for boarding schools. It also does not account for the value of forced labor that was enacted upon the children at these schools or the number of investments that churches and states put toward these efforts.
- Detailed profiles for each school for the names and tribal affiliations of more than 18,000 students who attended these schools. This information is not a full accounting of all students and doesn't include the day schools.
- Our first recommendation was that the United States Government should issue a national acknowledgement and apology for operating these boarding schools and what was done, and that that should also include a formal repudiation of a policy of forced assimilation, because we can't just apologize for it. This apology must be accompanied by action.
- The second recommendation says that we should make investments to heal or remedy the present-day impacts or effects of these boarding schools, and that that investment should be commensurate with the amount. That we spent to operate or to set up and run these boarding schools. The recommendation is that the funding for that should be flexible, so it's not the federal government telling tribes here's how you need to spend your healing money, and that that funding should also be available to organizations working with all of your people in cities.
- Call for investments and Family Preservation and reunification with a defined goal of measurably reducing the number of Native kids in foster care. Investments in violence prevention, further investments in improving Indian education, as well as language revitalization. And one of the things that we're trying to be clear on is that this shouldn't just be money that's in the budget this, you know, because we've got an ongoing trust and treaty obligation, this money should be invested to undo the harm that was done, so over and above our annual and ongoing trust and treaty obligations.
- Development of a national memorial to acknowledge the people who went through these boarding schools.
- Call for investments in the creation of a process to identify and repatriate children who never returned from those boarding schools. These efforts need to be inclusive of those tribes that may have lost its land base to rebury human remains and funerary objects, and that Federal land should be made available to appropriately do so.
- Calls for the return of former boarding school sites to tribal ownership, particularly where the deeds of transfer have language saying that when they're not used for a boarding school, they'll be reverted to the federal government or to tribal ownership.
- Call for the development of an oral history project to educate the country and the world about these boarding schools.
- Calls for investments and continued research about the present day mental, physical and economic impacts of boarding schools, the intergenerational trauma, so that we can understand how that affects us today.

TRIBAL/INTERIOR BUDGET COUNCIL PROTOCOL

Approved by Tribal Representatives on: 11/05/21

<u>Mission</u>: To provide a forum and process, consistent with the Indian Self-Determination and Education Assistance Act, Section 450 a-1 and Executive Order #13175 and Department of the Interior's (DOI or Department) Government to Government policy, whereby Tribes and the Department work together to develop policy and budgets that promote:

- 1) DOI to fulfill its Trust responsibilities and Treaty obligations; and
- 2) the fulfillment of Tribes' inherent sovereign rights of self-determination, self-governance, and self-sufficiency, as well as securing levels of funding necessary to strengthen Tribal governmental capacity to serve their Tribal citizens and communities.

I. Introduction

The Tribal/Interior Budget Council (TIBC) is established to provide a forum for the Tribes and Tribal organizations to work with DOI officials in the formulation of the Indian Affairs annual budget requests and performance plans in the spirit of the President's Government-to-Government consultation and collaboration policy.

II. <u>Purpose</u>

Tribal representatives will advise and make recommendations to DOI and Indian Affairs on:

- a. development of Indian Programs within DOI and Indian Affairs (IA) budget requests relative to the priority needs of Indian Country and the Department, Tribal governments, and individual American Indian and Alaska Native (AI/AN) beneficiaries;
- b. strategic planning and data collection processes and systems to justify budget increases to meet Federal treaty and trust obligations and fully fund budget priorities;
- budget formulation, fund distribution, program management, and statutory and regulatory reporting requirements, including Government Performance and Results Act (GPRA) and Program Assessments as they apply to the federal and Tribal systems;
- d. policy and performance measure changes that improve the budgeting policy for the long-term, including development of standards and criteria for GPRA and Program Assessments and the DOI Strategic Plan measures;
- e. establishment of meaningful and effective relations and communication with all Federal officials that influence the Indian Affairs and their respective budgets, including the Office of Management and Budget (OMB) and the White House; and
- f. assist in facilitation with other federal agencies to ensure a coordinated budget strategy for Tribal programs.

This protocol document provides the formal framework for TIBC meetings, activities,

and actions and for any subgroup(s) authorized to perform activities as authorized by these TIBC protocols and policy.

III. <u>Membership</u>

Membership on the TIBC includes the following (or the equivalent thereof):

- a. Indian Affairs Representatives:
 - 1. Assistant Secretary Indian Affairs (AS/IA)
 - i. Principal Deputy Assistant Secretary
 - ii. Deputy Assistant Secretary-Management
 - a. Chief Financial Officer
 - b. Associate Chief Information Officer Indian Affairs
 - c. Director, Office of Budget and performance Management
 - d. Director, Office of Facilities, Property, and Safety Management
 - iii. Deputy Assistant Secretary-Policy and Economic Development
 - a. Director, Office of Indian Energy and Economic Development
 - b. Director, Office of Self Governance
 - iv. Director, Bureau of Indian Affairs
 - a. Deputy Bureau Director, Field Operations
 - b. Deputy Bureau Director, Indian Services
 - c. Deputy Bureau Director, Justice Services
 - d. Deputy Bureau Director, Trust Services
 - e. Regional Directors
 - v. Director, Bureau of Indian Education
 - a. Deputy Bureau Director, School Operations
 - b. Chief Academic Officer
 - c. Associate Deputy Director Division of Performance and Accountability
 - d. Associate Deputy Director Bureau Operated Schools
 - e. Associate Deputy Director Navajo Schools
 - f. Associate Deputy Director Tribally Controlled Schools
 - vi. Bureau of Trust Funds Administration Representatives
 - a. Director
 - b. Principal Deputy Bureau Director
 - c. Budget Officer
- b. White House Representatives
 - 1. Office of Intergovernmental Affairs
 - 2. Office of Management and Budget
 - 3. Executive Director of the White House Council on Native American Affairs, or equivalent
- c. Tribal representatives:
 - 1. Twenty-four elected or appointed Tribal officials will be nominated and selected to serve on the TIBC, two from each of the 12 BIA Regions. Tribal officials may formally designate a non-elected representative by written notification.
 - 2. Selection criteria: Each Region will establish a transparent process to nominate and select two Tribal officials to serve on the TIBC and a third Tribal official to serve as an alternate. These three names will be forwarded to the Regional Director. The Regional Director may help

facilitate the nomination process. Each region should ensure that all Tribes have an opportunity to provide input on the nomination and selection process.

- d. TIBC Leadership:
 - 1. There shall be three Tribal Co-Chairs who shall be elected by a vote of the Tribal representatives of the TIBC. The Chairs shall be elected in a manner that is representative of direct service, self-governance, and contracting Tribes.
 - 2. The Tribal Co-Chairs shall serve three-year terms. If a sitting Tribal Co-Chair is unable to continue to serve in that capacity for any reason, or is unable to meet the attendance requirements of the TIBC, appointment by the Tribal representatives of TIBC of a Tribal Co-Chair to complete the current term can be held at any other full TIBC meeting and may be decided by a majority vote of the Tribal representatives. The Tribal Co-Chairs may serve multiple consecutive terms.
 - So that Tribal Co-Chair terms are staggered by one year, the first election of the Tribal Co-Chairs will elect one Tribal Co-Chair for a term of one year, one Tribal Co-Chair for a term of two years, and one chair for a term of three years. After this initial election, Tribal Co-Chairs will serve three-year terms, subject to III(d)(2) above.
 - 4. The Assistant Secretary Indian Affairs serves as the federal Co-Chair and the Principal Deputy Assistant Secretary will serve in the Assistant Secretary's absence. The AS/IA may delegate his/her duties to another senior DOI/BIA official.

IV. Length of Service

a. Tribal representatives are appointed for three-year terms. Tribal representatives may be appointed for multiple terms. In the event that a TIBC representative can no longer serve on the TIBC, or cannot meet attendance requirements, the BIA Regional Director shall—in consultation with Tribes in their Region—appoint a new Tribal representative to complete the current term.

V. <u>Responsibilities</u>

- a. The Tribal representatives from each region will advocate on behalf of Tribes in their region.
- b. Tribal representatives serving on the TIBC and officials from the Indian Affairs regional offices are responsible for coordinating input from Tribal leaders within their respective Regions, as well as providing a report of recommendations and actions to their respective region's Tribes and ensuring thorough communication about the activities and actions of TIBC.
- c. Tribal representatives, NCAI and BIA Regional directors should work together to ensure that Tribal representatives have an opportunity to present updates to relevant intertribal gatherings in their region prior to and at the end of the budget formulation process.
- d. DOI Indian Affairs staff members serving on the TIBC are responsible for facilitating the active participation of Tribal representatives in the formulation of the Indian Affairs budget request and annual performance plan.
- e. DOI Indian Affairs is responsible for working with TIBC Tribal representatives

prior to the budget formulation season to secure a calendar hold on the appropriate DOI and OMB officials' calendars to attend the spring TIBC meeting.

- f. DOI Indian Affairs will develop a draft agenda in consultation with the Tribal Co-Chairs and send it to Tribal representatives no later than 30 calendar days before the meeting.
- g. The TIBC Co-Chairs will moderate TIBC meetings and ensure TIBC objectives are acted upon.
- h. TIBC Tribal representatives should make every effort to participate in all in-person and webinar/phone TIBC meetings. Each Representative can backfill their participation at in-person/remote TIBC meetings with their alternate Representative once per budget formulation cycle (except in extenuating circumstances conveyed to and approved by the TIBC co-chairs). If a Tribal Representative is unable to meet their attendance obligation, the TIBC Co-Chairs will ask the BIA Regional Director to consult with Tribes in their region to designate a different TIBC Tribal representative. Before action to replace a TIBC member is taken, TIBC Tribal Co-Chairs will attempt to make direct contact with the member. This attendance standard will ensure that Tribal representatives at each meeting are up-to-date and actively engaged in the work of the TIBC.
- i. TIBC shall identify its representative who shall testify before any Congressional Committee for TIBC-related invitations.

VI. <u>Meetings</u>

- a. TIBC will meet for official business at least three times per year: once in the Spring, once in the Summer, and once in the Fall.
- b. TIBC meeting dates, time, agenda topics, federal participants, and location will be decided at a previous meeting of the TIBC.
- c. TIBC meetings will be held over 2-3 consecutive days unless otherwise agreed and are open to the public. However, only TIBC members are eligible to bring motions and vote.
- d. Seating at TIBC meetings shall be designated by the TIBC Co-Chairs. All Tribal leaders are welcome to attend any Tribal Caucus and speak by request to and approval by the Co-Chairs.
- e. Any Co-Chair may recognize non-TIBC members in discussions at meetings. However, priority shall be given to TIBC members before a non-member is given the opportunity to discuss the issue.
- f. Regular meetings (see "Meetings" VI(a)) may be conducted via video or telephone conference.
- g. Special meetings may be called by the Co-Chairs with advance notice to all representatives. These meetings may be conducted via video or telephone conference.
- h. The TIBC members shall be supported with sufficient resources to enable them to fulfill the purposes of this council.
- i. TIBC members shall be prepared to take action on business brought before TIBC during each meeting.

- j. TIBC Tribal representatives will be reimbursed through their BIA regional office in a manner that is acceptable to the TIBC Tribal representative.
- k. The TIBC budget will be reviewed and approved by the TIBC annually.

VII. Quorum and Voting

- a. A quorum will be met by:
 - 1. Three-fourths (18) majority of the voting Tribal representatives (24); or
 - 2. Three-fourths (9) of Tribal regions representing BIA regions (12).
 - 3. In the absence of a quorum, a working meeting will be held with no formal actions.
- b. Voting is limited to Tribal representatives or their designee of the TIBC.
- c. A vote requires a simple majority of TIBC representatives present to pass.

VIII. <u>Sub-Committees</u>

- a. Purpose.
 - 1. Sub-Committees convene TIBC representatives, participants, and Federal reps to engage in more extensive detail on budgets and budget policy and provide recommendations and supporting data to the full TIBC membership.
- b. Establishment.
 - 1. The TIBC may establish Sub-Committees to review, investigate, and/or evaluate issue(s) of importance and provide recommendations to the TIBC.
 - 2. The TIBC must establish a clear mission, purpose and objectives and/or tasks for the Sub-Committee(s).
 - 3. The number of Sub-Committee voting members and chair(s) are determined by the full TIBC by vote.
 - 4. The Chair(s) of each Sub-Committee serve in a non-voting role within the Sub-Committee they chair, except in the event of a vote that requires a tiebreaker.
 - Sub-Committees are intended to operate for a duration specified by the TIBC at the Sub-Committee's inception. A Sub-Committee's term, however, may be extended by a majority vote of the TIBC. If no extension is granted the Sub-Committee will be dissolved.
 - 6. Standing Sub-Committees may be established to address long-term or continuing issues for the TIBC. A standing Sub-Committee's continuation must be agreed to annually at the first National Budget Meeting of the calendar year.
 - The TIBC may dissolve Sub-Committees by a simple majority of TIBC representatives present when a quorum has been met (See Section VII "Quorum and Voting").
- c. Responsibilities.
 - 1. Each Sub-Committee will present to the full TIBC only when there are specific decision items that require consideration by the full body.
 - 2. In the event that a Sub-Committee has decision items to present, each

recommendation shall be discussed individually by the TIBC and only adopted after a motion is made and seconded and approved by the TIBC.

- 3. All members of the TIBC shall receive written notice of Sub-Committee meetings in advance and be provided the opportunity to participate telephonically.
- 4. Indian Affairs officials will assist TIBC Co-Chairs and Sub-Committee chair(s) in inviting and securing participation of appropriate federal officials both within DOI as well as in other federal agencies.
- 5. Sub-Committee chair(s) will be responsible for working with the full TIBC to fill vacant positions on Sub-Committee. The TIBC will approve any proposed changes to Sub-Committee membership at the next meeting. However, proposed new members may participate in Sub-Committee meetings in a non-voting capacity until their official membership is approved.
- 6. TIBC Tribal Sub-Committee members should make every effort to participate in all in-person and webinar/phone Sub-Committee meetings. Each representative can backfill their participation at in-person/remote TIBC meetings with their alternate representative once per budget formulation cycle (except in extenuating circumstances conveyed to and approved by the Sub-Committee co-chair). If a Tribal Sub-Committee member is unable to meet their attendance obligation, the Sub-Committee chair(s) will work with the TIBC Co-Chairs to identify and designate a replacement member. Before action to replace a TIBC Sub-Committee make direct contact with the member. This attendance standard will ensure that representatives at each meeting are up-to-date and actively engaged in the work of the Sub-Committee.
- 7. Each Sub-Committee leader will designate a single individual, either a technical advisor or other staff assistant, to act as the logistical lead responsible for the following Sub-Committee operations:
 - i. working with the Sub-Committee chair(s) to schedule meetings;
 - ii. tracking meeting topics, discussion, outcomes, and follow up;
 - iii. working with the chair(s) to draft meeting agendas and circulate them to Sub-Committee membership at least one week in advance of meetings;
 - iv. tracking Sub-Committee membership, attendance, and managing a process to on-board new members;
 - v. working with the Sub-Committee chair(s) to draft talking points, meeting minutes, and other relevant documents; and
 - vi. ensuring the availability of relevant printed materials for each meeting (agenda, presentations, past meeting notes, etc.).
- d. Sub-Committee Quorum and Voting.
 - 1. A quorum shall be established when a simple majority of Sub-committee voting members are present.
 - 2. Sub-committee meetings will be open to attendance and participation by the full TIBC membership.
 - 3. A motion can be brought by a member of the Sub-committee and an affirmative vote will be a simple majority of the voting membership.
 - 4. Sub-Committees may include technical staff or other non-TIBC members as required to fulfill the intent of the subgroup.

5. Sub-Committee meetings are open to all TIBC members.

IX. <u>Conflicts of Interest</u>

- a. TIBC Tribal representatives will speak on issues for the general benefit of Indian Country. It is assumed that Tribal TIBC representatives will speak from the experience of their Tribes for the benefit of Indian Country in general and that no conflict of interest with any other Tribe occurs when a member speaks about any Tribal issues in their particular Region.
- b. TIBC members will not present proposals that will create an unfair advantage over any other TIBC member or Tribe for the individual person, his/her personal office, or his/her Tribe in the budget process.

X. Meeting Records. communications. and dissemination of TIBC documents

- a. It is the responsibility of Indian Affairs to ensure that accurate records of meeting actions are recorded and summarized as the minutes to be approved by the full TIBC. The written record shall at a minimum be a summary of issues and topics discussed and action(s) taken and not the discussion surrounding the action.
- b. Action items will be developed and provided to the TIBC representatives no later than 21 calendar days after the meeting. Indian Affairs will provide a progress report on action(s) taken at subsequent TIBC meetings.
- c. Indian Affairs is responsible for tracking the following information from Tribes every year:
 - 1. Each region's two TIBC representatives and alternates
 - 2. Each region's technical support staff (if any).
- d. Tribal representatives may be asked to follow up on specific action(s) on avoluntary basis.
- e. Information regarding TIBC meetings, activities, and actions shall be posted on the Indian Affairs website.

XI. <u>Protocol Duration</u>:

This Protocol will be reviewed every six years from the date of adoption.

XII. Adoption and Amendments:

This protocol document may be adopted, amended, or terminated per the voting procedure.

The date of adoption and all subsequent amendment dates shall be recorded following this section.
