SECOND QUARTER AND FIRST HALF YEAR 2023



Q2 2023 highlights: Improving efficiency and solid overall performance

Reducing loan growth to adjust to a more challenging macroeconomic environment near-term – H2 profitability expected below H1 2023.

Solid growth and stable net yield in Q2

- +3% loan balance growth vs. Q1 2023
- Stable net yield enabled by increased loan book interest rates
- Total income growth of 15% vs. Q1 2023 mainly driven by loan growth

Cost/income ratio target met ahead of plan

- Total operating expenses before depreciation stable vs. Q1 2023 despite a larger balance
- Cost/income ratio of 31% vs. 35% in the previous quarter (Q4 2023 target 30%)
- Number of full-time employees (FTEs) reduced by ~45% since peak in H1 2022
- · IT transformation progressing according to plan, further efficiency gains expected

Increased credit losses, stable profitability

- Loan loss ratio of 4.8%, up from 3.9% in Q1 2023 driven by change in customer payment behaviour towards the end of the quarter
- Profit after tax of NOK 41 million vs. NOK 40 million in the previous quarter

Reducing growth in H2 amid more challenging macroeconomic picture

- · Higher market interest rate trajectory expected to put pressure on margins
- Further tightening of credit policies and close dialogue with customers
- Some downside risk seen vs. normalised loan loss ratio of 4-5%; H2 2023 profits hence expected below H1 2023 levels
- Solid capital position with CET1 ratio of 20.6% vs. 19.4% at the end of Q2 2023, and a regulatory CET1 requirement of 17.9%
- Management evaluating further initiatives to support long-term growth and increase return on equity (ROE) from 8% in H1 2023 to above 12%

Comment from the CEO, Øyvind Oanes:

"During 2022 and the first half of 2023, we've managed to significantly increase throughput, protect our yield and bring down the cost/income ratio towards our target 30% mark – which is a very competitive level for our industry. As part of our mission to build a new and future-proof bank, we've also rebranded in Q2 and I'm delighted to see the alignment and engagement across our highly capable organisation. Combining that with a diversified Nordic consumer loans portfolio and a solid financial position, we are well-positioned for delivering long-term growth and value creation. Near-term, however, we see a more challenging macroeconomic picture where the balance between credit risk and growth needs to be carefully managed. As a result, we've tightened our credit policies and reduced sales which will slow loan balance growth in H2 2023. While the macro-outlook is more positive for the medium term, our focus in the near term continues to be on improving operational efficiency."



About Morrow Bank ASA

Morrow Bank ASA (the "Bank"), previously Komplett Bank, started operations in March 2014 when the Bank received its banking licence from the Norwegian authorities. Morrow Bank offers convenient consumer financing to creditworthy individuals. This provides individuals with financial flexibility which in turn contributes to economic activity and growth for the society at large.

The Bank's main products are consumer loans, comprising Morrow Bank's annuity loans launched in May 2019 as well as a flexible loan product with functionality that gives the customer more flexibility in use of the credit line. In July 2022, the Bank launched a new refinancing product in Norway. In addition, the Bank offers "Morrow Bank Mastercard", a credit card with product features tailored for online shopping. The Bank offers these products in Norway, Sweden and Finland. Moreover, Morrow Bank offers deposit products with highly attractive interest rates in Norway, Germany and Sweden. As a member of the Norwegian Banks' Guarantee Fund, customer deposits are guaranteed up to NOK 2 million (EUR 100,000 in Germany and Sweden) per customer.

The Bank follows a strategic roadmap based on geographical and product-wise diversification and expansion. The Bank is pursuing a strategy of building a digital, scalable and efficient operating model combined with strong risk control. In the near- to medium-term, lending operations will be focused on the Nordic region.

The Bank operates on a cross-border basis from Lysaker, outside of Oslo. The Norwegian banking license provides for passporting of the Bank's offering throughout the entire European Economic Area (EEA).

Financial figures for Q2 2023

All figures are prepared and presented in accordance with the International Financial Reporting Standards (IFRS).

Gross loans to customers amounted to NOK 11.1 billion at the end of Q2 2023, an increase of 3% compared to Q1 2023. Split on product segments, loans increased by NOK 376 million and credit cards increased by NOK 53 million. The point of sales (POS) financing product, where new sales have been discontinued in Q2, decreased by NOK 104 million. Adjusted for currency effects, gross loans increased by 2%. As previously announced, the Bank discontinued its POS financing product effective as of 1 May 2023.

Net interest income amounted to NOK 257.1 million in Q2 2023, up 12% compared to Q1 2023. Loan interest rates were increased across markets during Q2 2023 to mitigate the margin impact of increasing deposit rates, with a limited impact on the inflow of loan applications. However, increased interest rates were offset by higher deposit rates. Additionally, new customers are on lower interest rates than the average in the Bank's existing loan book, as loan interest rates in general have declined over the past years due to lower market interest rates and increased competition.

The yield increased to 13.6% for performing loans (13.3% in Q1 2023) while the performing credit card yield declined to 16.2% (16.4%). Deposits increased to 2.6% from 2.2% in the previous quarter. The net interest margin increased to 9.3% in the quarter from 8.8%, mainly due to decreased deposits volumes.

Net commissions and fees amounted to NOK 5.5 million in the quarter, up from NOK 0.7 million in the previous quarter.

Net gains on certificates, bonds and currency were NOK 6.2 million compared to NOK 4.3 million in Q1 2023 due to mark-to-market gains on liquidity placed in market-based instruments.



Total income was NOK 268.8 million, up 14.5% from the previous quarter driven by loan growth, loan interest rate increases and higher commission income and fees. The net impact from one-off items was positive by NOK 5 million in the quarter.

Total operating expenses were relatively stable at NOK 82.7 million compared to NOK 81.3 million in the previous quarter.

Personnel expenses were reduced to NOK 23.5 million in the quarter from NOK 24.4 million in the previous quarter. The number of FTEs was 77 at the end of Q2 2023, a reduction of ~45% since the peak in 2022.

General and administrative expenses including direct marketing expenses were NOK 34.7 million, up from NOK 33.9 million in Q1 2023.

The cost/income ratio was 30.8%, down from 34.7% in Q1 2023.

Further cost efficiencies are expected to materialise in the coming quarters including lower personnel cost, reductions in IT platform costs and office rent. The Bank will continue its investments in structural changes to reduce cost and automation/IT enhancements going forward.

Losses on loans amounted to NOK 131.2 million, up from NOK 100.2 million in Q1 2023. The increase was mainly driven by a change in customer payment behaviour towards the end of Q2. The loan loss ratio was 4.8% compared to 3.9% in the previous quarter.

Profit after tax increased to NOK 41.2 million compared to NOK 39.9 million in the previous quarter, mainly driven by loan growth and increased loan interest rates for performing loans.

Total assets as at 30 June 2023 amounted to NOK 12,026 million (compared to NOK 12,750 million as at 31 March 2023). Net loans to customers ended at NOK 10,523 (NOK 10,241 million). Deposits from customers amounted to NOK 9,516 million (NOK 10,466 million).

Total equity was NOK 2,218 million as at 30 June 2023 (NOK 2,085 million as at 31 March 2023). The Bank successfully completed a NOK 100 million capital (equity) increase during the quarter in order to strengthen the Bank's solidity. The Bank had a total capital ratio of 24.1% (22.3%) by the end of the quarter, and a CET1 ratio of 20.6% (19.4%). The Bank's CET1 ratio requirement was 17.9% (17.7%).

Loan and deposits with credit institutions and certificates and bonds amounted to NOK 1,358 million (NOK 2,351 million) corresponding to 11.3% (18.4%) of total assets.

Dividend policy

Morrow Bank's dividend policy is to distribute excess capital not allocated to growth to its shareholders.

Significant events after balance sheet date

There were no significant events after the balance sheet date.

Development and outlook

Morrow Bank maintains a positive outlook for growth and increased profitability in the medium to long term. The outlook is founded on the Bank having a well-diversified NOK 11.1 billion gross loan book, a continued strong inflow of loan applications, profitable operations, and exposure to a growing Nordic consumer financing market that has demonstrated strong resilience historically.



Most new NPL loans are sold on forward flow agreements which limits the balance sheet risk.

During Q2, the Bank had good sales volumes across all geographical markets driven by a generally benign market demand as well as enhanced conversion rates. The latter is chiefly a result of systematic work by the Bank to improve conversion and throughput.

To achieve increased throughput without accepting riskier client segments, the Bank has over the past six quarters deployed several strategic initiatives – focusing on product performance, process automation and tech simplification. The initiatives related to product performance and process automation have been successfully implemented with more to come from tech simplification which is expected to positively impact operational efficiency in 2023.

Overall, the medium to long-term macroeconomic outlook for the Nordic region remains robust, supporting an expected increase in consumption and demand for consumer financing. Nevertheless, there is uncertainty related to the geopolitical situation, inflationary pressure and the impact from the interest rate trajectory which has moved upwards since last quarter.

Cost inflation has affected personnel costs somewhat during the first half of 2023, but the impact from inflation on overall costs is still expected to be moderate in the near term.

Further, over the past quarters, the Bank has successfully passed on its higher funding costs to customers as increased loan interest rates. Gradual repricing of loan interest rates is expected to continue to during Q3 2023. However, the Bank sees a risk that further loan interest rate increases near term could result in increased churn and/or higher credit losses given the recent change in customer payment behaviour.

By the end of Q2 2023, consumers' loan servicing capacity started to show signs of deterioration with an increasing number of customers asking for forbearance.

Combined, this points to a more challenging near-term outlook and, as a result, Morrow Bank further tightened its credit models and engaged in closer customer dialogue to adjust to the situation. The Bank expects growth levels in H2 2023 to be lower than Q1 and Q2 2023 and sees a risk for its loan loss ratio to notch above the previously targeted normalised range of 4-5% for the coming quarters. Furthermore, as the general interest rates increase to levels above prior consensus, the Bank also foresees a near-term squeeze on its margins. Consequently, profit after tax in Q4 2023 is expected to come in below the previous target exceeding NOK 40 million.

Based on the current macroeconomic outlook, the Bank targets an annual loan balance growth of around 10%, a cost/income ratio of less than 30% and a return on target equity above12%.

While the medium to long-term outlook remains positive, the Bank is currently evaluating further initiatives to support growth and ROE levels of more than 12%.

Risks and uncertainties

Morrow Bank's operations and results are subject to a range of risks and uncertainties. The Bank's framework for managing financial risks is described in the Annual report 2022. Below is a description of selected major risk factors that may affect Morrow Bank in the remaining six months of 2023, including macroeconomic risks, reputation risk and regulatory risks.

While the war in Ukraine has had no direct impact on Morrow Bank's business so far, it contributes to increased macroeconomic uncertainty. Reduced economic growth, increasing unemployment and diminishing savings rates could reduce demand for consumer financing from creditworthy individuals, reduce existing customers' ability to service their loans and limit the Bank's access to capital. Implemented mitigating actions include Morrow Bank's geographical diversification, strengthening of refinancing offering, and continuous surveillance of risk development in the loan portfolio.



While rising unemployment rates historically have had the largest negative impact on the consumer finance market, the observed increased rate of inflation and higher interest rates This may lead to an increased part of Morrow Bank's outstanding loans going into default. While no such impact has been experienced so far, the Bank is monitoring this situation closely.

Damage to the Bank's reputation could reduce access to customers, capital and liquidity. Actions undertaken to minimise such risk include the implementation of a strong corporate governance framework, and regular training of all employees within anti-money laundering and terrorist financing.

Regulatory tightening could reduce the Bank's ability to grow its profitability and increase the cost of capital. In addition to the geographical and product-wise diversification, Morrow Bank has implemented processes to continuously strengthen the Bank's agile culture and adaptability.

Note 2 – Loans to customers

The Bank is applying forward looking elements for its credit loss model, see the Annual Report 2022 for more information regarding the credit loss model.

There are uncertainties related to the estimates as they are forward looking. As at 30 June 2023, the total loan loss provision related to macroeconomic factors amounted to NOK 27.4 million (30 June 2022: NOK 15.8 million).
