

Please read this document carefully. It contains information about terms and conditions for the use of WoT Scholar Round Fonts.

Licenses to WoT Scholar Round Fonts are provided as a reward for contributions to the crowdfunding campaign of the “Words of Type” project on Kickstarter in September 2023, created by Lisa Huang.

DEFINITIONS

This End User License Agreement (“EULA”) is a legal agreement between you (the “Licensee”, whose name is specified in the crowdfunding checkout process), and Lisa Huang (“Lisa Huang”) for the use of Scholar Round Fonts.

WoT Scholar Round (or “Fonts”) is the Font Software created by Lisa Huang.

In the interest of facilitating the crowdfunding rewards process, all Scholar Round Fonts licenses are granted to individual users (single users) only.

GENERAL TERMS

This EULA governs the access to, and grants the use of Scholar Round Fonts by the Licensee, as set forth in this EULA.

By receiving, installing, or using the Fonts, Lisa Huang grants you a personal, limited, non-transferable, revocable, and non-exclusive license to use Scholar Round in accordance with the terms of this EULA.

You agree that all rights not granted to you by this EULA are expressly reserved by Lisa Huang.

If you are the one receiving the License then you are a party to this EULA and must abide by its rules.

This EULA outlines the ways the Licensee can and cannot use the Fonts, and which uses require special licensing.

OWNERSHIP

Lisa Huang retains ownership of Scholar Round.

The Fonts are subject to trademark, service mark, trade dress, copyright, or other intellectual property rights exclusively held by Lisa Huang.

No right, title, or interest in any of the Fonts is transferred to you as a result of this EULA.

You acknowledge that the Fonts Software is protected under domestic copyright and other intellectual property laws of France, as well as international copyright and other intellectual property laws of other nations or treaties.

LICENSE SCOPE - DESKTOP & WEB

If you wish to purchase a custom license, you will receive a special EULA which will govern your use of Scholar Round instead of this EULA.

This is a special EULA made exceptionally for the crowdfunding campaign rewards, and shall not apply to future licenses of Scholar Round Fonts. If you have any questions, please reach out to hello@lisahuang.work.

This License permits you to use the Fonts for yourself, you can install and use the Fonts on any workstations belonging to you.

The Fonts are provided in OTF (OpenType CFF) for Desktop use, and WOFF and WOFF2 font formats as webfonts. Alternative formats might be provided on request, at the discretion of Lisa Huang.

Permitted desktop uses of the Fonts include, but are not limited to, the design of printed materials, PDFs, static images, motion graphics, logos, Ebooks, and print advertising.

You may outline a licensed font and modify those outlines for a book title artwork, poster, or other such artwork, but you cannot convert these designs back into a font or make a new or modified font based on the design of the licensed Fonts.

You may open the Fonts in font editor software or inspect the Fonts’s internal data for informational and educational purposes only.

You may upload the Fonts to web-based design and collaboration software, so long as you are the only one who is able to access and use the Fonts through such software and web applications.

You may embed the Fonts on websites with CSS `@font-face`.

The web fonts may only be installed on website domains that are under your direct control. The Fonts may not be embedded on websites or tools that allow the use of the Fonts in the generation of dynamic artwork or documents that can be viewed remotely by others through the website or exported for use outside the context of the website, which requires special licensing.

You may subset the web fonts.

USES THAT REQUIRE SPECIAL LICENSING

This Crowdfunding Special License does not cover the use of the Fonts in the following ways:

- App and Game Embedding. A special license is required to use the Fonts embedded in mobile or computer applications (“Apps”), including games.
- Broadcast. A custom Broadcast license is required for the use of the Fonts in video content broadcasts such as free TV, cable TV, cinema, streaming services, web video platforms, etc.

PROHIBITED USES

The following uses of Fonts are expressly prohibited:

Hate Speech. You cannot use the Fonts to promote violence or discrimination.

AI Training. You cannot use the design or internal data of the Fonts for the training of artificial intelligence (“AI”) models or tools.

Redistribution. Except as provided by this EULA, you cannot transfer, give access to, or distribute any part of any of the Fonts to any third party without Lisa Huang’s prior consent, and cannot redistribute Fonts with other software packages or other means that make the Fonts accessible to third-parties not covered by your License.

Other Restrictions. You cannot reverse engineer, alter, or modify any part of any Fonts. You cannot emulate, mimic, or otherwise create a substitute for any Fonts. You cannot use the Fonts in any way not expressly permitted in the “Permitted Uses” Section of this EULA.

PROHIBITED MODIFICATIONS

The following modifications of the Fonts are prohibited:

You cannot distribute, reproduce, sell, transfer, license, or give away your copies of the Fonts.

You cannot convert the Fonts to another format.

You cannot make, authorize or commission a third party to make customized versions of the Fonts without the written consent of Lisa Huang.

You cannot add glyphs to the Fonts or modify the design of the glyphs within the Fonts.

You cannot modify any naming data of the Fonts without the written consent of Lisa Huang.

COPIES

Copies of the Fonts may be made for backup or archival purposes only, so long as these copies are not accessible to non-licensed parties.

TERMINATION

You agree to pay Lisa Huang’s reasonable attorneys’ fees incurred in connection with an investigation or action or proceeding arising from your breach of this agreement.

You are responsible for taxes that accrue in your country, including any withholding taxes.
