

## Campus Visitor Travel and Exposure Questionnaire

All visitors to Miss Hall's School campus must complete this questionnaire prior to or upon arrival on campus. All visitors are required to wear a face covering. Beginning August 23, if you have received two doses of the Moderna or Pfizer COVID-19 vaccines or one dose of the Janssen (Johnson & Johnson) vaccine more than 14 days ago and do not have symptoms, we will ask that you continue to wear a mask while indoors on campus. If you're outdoors while on campus, you do not need to wear a mask if you are vaccinated.

If you are vaccinated and have symptoms of COVID-19, you must continue to follow the Governor's Travel Order and related testing and quarantine requirements.

Please note that per Massachusetts law, all individuals entering the state for anything more than transitory travel, including Massachusetts residents, are required to quarantine for 10 days or produce a negative COVID-19 test result that has been administered up to 72-hours prior to arrival in Massachusetts. *Travelers who are exempt from having to quarantine include:* Travelers coming from [lower-risk states](#); Individuals who are entering Massachusetts for fewer than 24 hours; Individuals who are returning to Massachusetts after being out of the state for fewer than 24 hours; Individuals who can provide a recent negative Covid-19 test within 72 hours of arrival; Individuals who are fully vaccinated 14 days ago or more.

Miss Hall's School reserves the right to limit visitors at any time, in order to protect the health and well-being of our students, employees and extended community. If you answer YES to the 2nd, 3rd or 4th question listed below, you will not be allowed to visit campus.
